➤ During 2003, the Gainesville Police Department's Narcotics Unit investigated the city's first known methadone lab. The investigation resulted in a 7-year prison term for the suspect.<sup>16</sup>

➤ In 2002, 43% of Alachua County high school students reported using marijuana at least once in their lifetime. Approximately 12.7% of Alachua County middle school students surveyed in 2002 reported lifetime marijuana use. <sup>18</sup>

➤ During 2002, the mean age when Alachua County middle school students first used marijuana was 11.9 years. Among Alachua County high school students surveyed in 2002, the average age of first marijuana use was 14.2 years. <sup>20</sup>

#### **Enforcement**

- ➤ Comprehensive Drug Plan<sup>22</sup>
  Established in September 2003, the Gainesville Police Department's Comprehensive Drug Plan uses forfeiture funds to reduce drug activity in the city.
- As of October 31, 2002, there were 339 full-time law enforcement employees in Gainesville (274 officers and 65 civilians). <sup>23</sup>

#### **Trafficking and Seizures**

➤ The Gainesville Police Department seized 13.06 pounds of cannabis during 2003. 24

#### Courts

➤ Drug Courts<sup>26</sup>

As of September 2004, there were 2 drug courts in Gainesville that had been in existence for more than 2 years. There was also 1 drug court that had recently been implemented. No additional drug courts were being planned in Gainesville at that time.

#### **Corrections**

➤ In 2003, the average daily population at the Alachua County Jail was 932. The average population for the Alachua County Work Release program was 56 during 2003.<sup>27</sup>

#### **Consequences of Use**

➤ There were 45 deaths in Gainesville during 2003 in which cocaine was found in the body of the deceased. This is up from 2002 when there were 15 deaths in which cocaine was present.
