#### **Programs/Initiatives**

➤ High Intensity Drug Trafficking Area (HIDTA)

Designated in 2001, the North Florida HIDTA is responsible for 8 Florida counties, including St. Johns County. The St. Augustine Police Department is one of the North Florida HIDTA participating agencies.

#### **Crime and Drug-Related Crime**

➤ During 2003, the St. Augustine Police Department reported 1 murder. There were no murders reported in St. Augustine in 2002. 9

➤ During 2002, the mean age when St. Johns County middle school students first used marijuana was 12.3 years. Among St. Johns County high school students surveyed in 2002, the average age of first marijuana use was 13.9 years. <sup>18</sup>

➤ Nearly 19% of St. Johns County high school students surveyed in 2002 reported being drunk or high at school.<sup>19</sup>

#### Enforcement

- ➤ Drug Abatement Response Team (DART)<sup>20</sup>
  The St. Augustine DART Program was formed in 1996 to combat illegal drugs in St. Augustine by focusing on the property where drug activity flourishes.
- As of October 31, 2002, there were 63 full-time law enforcement employees in St. Augustine (49 officers and 14 civilians).<sup>21</sup>

#### **Trafficking and Seizures**

As a result of Florida's Domestic Marijuana Eradication program, 7 outdoor marijuana grow sites and 261 marijuana plants were detected in St. Johns County during 2003. No indoor sites were detected in St. Johns County during 2003.<sup>22</sup>

#### **Consequences of Use**

➤ There were 24 deaths in St. Augustine during 2003 in which cocaine was found in the body of the deceased. <sup>23</sup> This is up from 2002 when there were 23 deaths in which cocaine was present. <sup>24</sup> During 2001, there were 7 deaths in which cocaine was present. <sup>25</sup>

➤ Drug Courts<sup>27</sup>

As of September 2004, there was 1 drug court in St. Augustine that had recently been implemented. No additional drug courts were in existence or being planned at that time.

#### **Corrections**

➤ In 2003, the average daily population at the St. Johns County Jail was 389.<sup>28</sup>
