That is quite an achievement since we started TechReg on March 1, 2003.

For instance, NRCS is working to improve the interactive features on TechReg to ensure greater communication between NRCS and TSPs. Please check the site regularly because there is much to be excited about with TSP this year. For example, we plan to revamp the not-to-exceed rates to bring them more in line with market rates.

### **NRCS Funds Technical Service Provider Process**

NRCS funded its new technical service provider initiative with more than \$23.9 million in Fiscal Year 2003, demonstrating a major commitment toward this process.

States took full advantage of the opportunities afforded to them through the TSP process in Fiscal Year 2003.

For example, NRCS in Minnesota awarded about \$600,000 to private businesses to provide technical assistance for conservation practices. Nebraska awarded \$400,000 to engineering firms for livestock waste system designs; \$300,000 for wetland restoration designs, and

another \$300,000 for watershed rehabilitation designs. Montana signed a \$400,000 agreement with several partners that will help local ranchers save money and conserve water while improving habitat for trout and other native fish species.
