

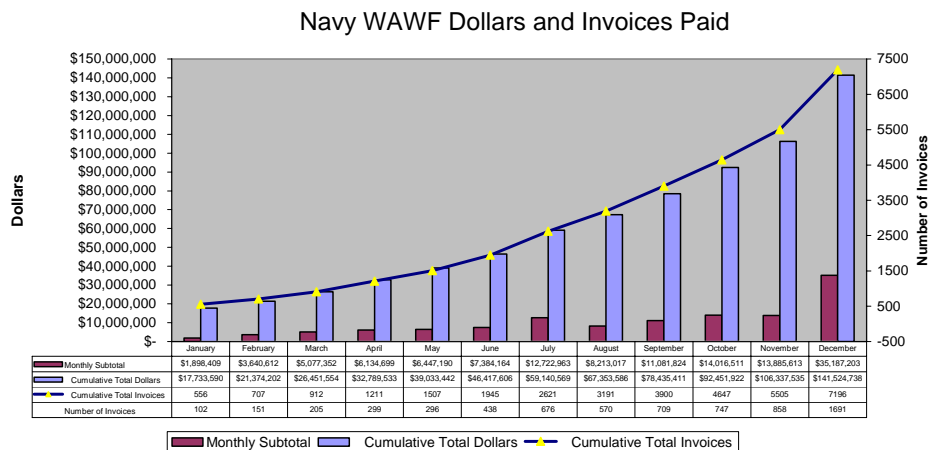


## US Department of the Navy WAWF PMO Update January 23, 2004

- **The Good News!**

The December 2003 metrics show a significant increase of WAWF usage between November and December. The number of invoices processed has doubled from 858 to 1691 while the dollars paid in WAWF have nearly tripled from \$12,682,281 to \$33,983,872.

- **OSD-ATL Policy News: Implementation of Changes in Acquisition Business Rules**

On December 22, 2003 Mr. Michael W. Wyne issued forth a memo concerning the role of WAWF in meeting acquisition business rules. For more details, please see attached memo.

- **New Functionality: Cost Vouchers**

Cost Voucher functionality was released in WAWF on December 19<sup>th</sup> as a pilot program for a select group of Government Vendors. Vertex Corp. submitted the first group of Cost Vouchers into WAWF for CNATRA's (Chief of Naval Air Training) certification. It was a successful endeavor as all 88 Cost Vouchers, totaling \$7,000,000.00, have reached DFAS for payment. With confidence in the new functionality, other pilot vendors will begin invoicing Cost Vouchers in the weeks ahead. A full implementation of Cost Vouchers will be available Navy wide beginning in February.

- **New WAWF Assistance**

- **WAWF Release**  
WAWF version 3.0.3 was just released 21 Jan 2004 and includes a fix for the PKI/CAC issue and updates to WAWF pages to minimize the proxy server issue which has been identified as the cause screens freezing in WAWF.
