As you may know, the Office of Management and Budget recently issued a revised Circular A-76 which governs how we carry out our competitive sourcing activities. We're sending this memo so that you know that we are now doing these activities according to the guidelines of the new circular, which was issued on May 29, 2003. Following is the text of the announcement appearing in the FedBizOpps as of today, June 27, which serves as the formal public announcement of these activities. The term "MEO Team Lead" under the old circular has been replaced by a new term, "Agency Tender Official." Both terms refer to the team leader for the group preparing the government's in-house proposal for how to do the work.
