MEMORANDUM FOR: All Participants in Ginnie Mae Programs

SUBJECT: Ginnie Mae I Electronic Transmission and Hard Copy Pool Delivery Dates for Calendar Year 2001.

This memorandum transmits the schedule for Calendar Year 2001, setting out the last date a submission will be accepted for a Ginnie Mae I pool to be issued in a particular month. For a pool security to have a particular issue date, the submission must be received by Ginnie Mae's Pool Processing Agent ("PPA"), in good order, by 4:00 PM ET on the delivery date indicated in the attached tables.

Processing time for Ginnie Mae I single family pools submitted electronically using GinnieNET is two business days. In addition, Ginnie Mae recently announced in All Participants Memorandum 00-19, dated December 29, 2000, that multifamily issuers will have the option to submit multifamily pools electronically using GinnieNET. Initially, processing time for multifamily pools will be three business days, and will be reduced to two business days effective with June 2001 issuances.

Securities will be delivered to The Depository Trust and Clearing Corporation (DTCC) on the morning of the third business day for two-day pool processing, and until 2:00 PM ET on the third business day for multifamily pools with three-day pool processing. The pool processing time clock begins the business day following the day when the PPA receives the electronic transmission of the pool data, certified by the issuer's document custodian. The PPA receives the GinnieNET electronic transmission the morning of the first business day after the pool is certified and transmitted by the issuer's document custodian.

Processing time for Ginnie Mae I hard copy pool submissions is 10 business days, with the exception of multifamily pool submissions which is three business days. The pool processing time clock begins the business day following the date of receipt by the PPA of pool submissions prepared in good order without In the event the issuer submits imperfect documentation, errors. the issuer will be given the opportunity to submit only one set of corrected documents or to utilize the New Pool Issuance Help Desk, if applicable. Such corrected documents must be received by the PPA no later than three business days prior to the issuer's anticipated delivery date, and in no event later than three business days prior to month end. If these documents still contain defects, the pool will be rejected and the documents will be returned to the issuer, if requested.

## PLEASE NOTE:

This memorandum serves to advise the issuer community of the latest dates the PPA will accept pool submissions. The dates indicated in this memorandum should not be relied upon as a schedule for securities delivery to investors or as a schedule of settlement dates established by The Bond Market Association.
