SYSTEM-TO-SYSTEM INTEGRATION MOVES FORWARD

Grants.gov is well on its way to mainstream use by the grant community, making it easier to Find and Apply for Federal government-wide grant opportunities. The latest step in the right direction is the gathering of grant applicant organization requirements for the ability to communicate with Grants.gov via a system-to-system (S2S) interface. Several grant-making agencies already connect with Grants.gov via an S2S interface. The S2S capability is now being expanded to include the grant community enabling them to:

- Continue to use internal business processes and systems while being compatible with Grants.gov
- Avoid costs related to building separate systems and processes for grant application and management

Currently, research and academia grant applicants are the earliest adopters, working hand-in-hand with Grants.gov on creating S2S interfaces. Jerry Stuck, Executive Director of the Federal Demonstration Partnership stated, "University researchers would rather spend more time conducting their research and less time pushing grant paperwork around or searching for the next funding opportunity." This sentiment rings true for the grant community as a whole. Acknowledging this sentiment, Grants.gov conducted a workshop focusing on grant community requirements for an S2S interface.

The Applicant System-to-System Workshop was well attended by a cross section of the grants community, including representatives from large universities (e.g., Duke, MIT and Cornell), the Federal Demonstration Partnership, state governments, research institution staff and third party grants software vendors. The goal of the workshop was realized by soliciting and capturing input from the grant community on requirements and alternatives for the development of an applicant S2S interface.

The future of Grants.gov's S2S effort is bright, equating to more access to application packages via Grants.gov and less paperwork and redundancy in the grant submission process. Contact Grants.gov via email at (Continued on Page 2)

Grant Community Recognition

The National Grants Management Association (NGMA) presented its first annual Electronic Solutions award to Grants.gov in April, noting that the site offers inspiration by championing excellence and innovation.

Showcase of Excellence Award

Grants.gov was named as one of two Showcase of Excellence E-Government winners by the Federal Leadership Council's Showcase of Excellence (FOSE). The site was highlighted at their annual conference in March as an example of the finest implementations of citizen-centric electronic government.

FEDERAL AGENCIES GET IN GEAR

Federal grant making agencies are working closely with Grants.gov to post more application packages for electronic transmission. Grants.gov recently conducted a Data Analysis and Forms Development Workshop detailing the steps necessary for agencies to make grant application packages available on Grants.gov and integrate electronic forms into their operations. To date over 12 agencies have standardized their program forms and posted applications. Additionally, four agencies/sub-agencies have taken the lead in completing their System-to-System interfaces (i.e., U.S. Departments of Agriculture, Education, and Health and Human Services (HHS) Administration of Children and Families and HHS Health Resources and Services Administration).
