

**NATIONAL CREDIT UNION ADMINISTRATION

Footnotes to Financial Statement: June 30, 2004

1. Represents the Fund's unsecured interest in the assets of charter number 18570 placed into liquidation on April 30, 2002 and charter number 12787 placed into liquidation on May 17, 2003.
2. Account reflects the total appropriations granted in 2004 and prior years specifically for technical assistance. The 2004 appropriation of \$1 million (received on March 4, 2004) was reduced by a \$5,900.00 rescission stated in Warrant No. 441-25-01-02.
3. Account reflects the amount of technical assistance grants paid and charged against the appropriation warrants for fiscal years 2001, 2002, 2003, and 2004. As of this statement date there are remaining appropriation funds of \$619,133.60 (including all outstanding appropriated commitments). Previous financial statements footnotes listed the remaining funds with a disclosure of the committed appropriated amount.
4. Funds specifically designated for CDRLF Loan Program. On March 4, 2004, the Fund received an additional appropriation totaling to \$200,000. This appropriation was reduced by \$1,180.00 which is a rescission stated in Warrant No. 441-25-01-02.
5. The Fund began investing residual cash in the overnight money markets February 2001. Income from these investments is recorded here and labeled Treasury Deposit Income. Approval to invest appropriation funds in Account 253/44472 and Account 25044472 has not been provided to the Fund; therefore these funds are not invested.
6. Represents the recognition of TA expended at the time of commitment from Congressional appropriations.
7. This account reflects the timing of payment of actual grant claims and recognition of committed appropriation funds. Previous financial statements footnotes disclosed this account with only the payment of actual and a contingent liability of grant claims.
