- Applicability:** Ginnie Mae I MBS Program and Ginnie Mae II MBS Program.
- Purpose:** To be used by an issuer to report SSCRA eligibility information and interest reimbursement requests when using alternative systems. Data files must be submitted through the Ginnie Mae Bulletin Board System (“BBS”) using HyperTerminal or the Web-based Issuer Information System (“Web IIS”) file upload function.

- Due Date:** Eligibility information is submitted on an ongoing basis. Interest reimbursement requests are to be submitted quarterly by August 10, November 10, February 10, and May 10, which are the months following the months of the quarterly loan level reporting cycle.
- Instructions:** Procedures are set forth in Chapter 34. Hard copy loan eligibility information shall be prepared in accordance with Appendix XI-6 and Quarterly Reimbursement Requests in accordance with Appendix XI-8.
