Our Purpose

We promote the safe and efficient transportation of hazardous materials by air, highway, rail, and water through uniform national and international safety programs.

What We Do For You

- We develop and issue the Hazardous Materials Regulations. We evaluate requests received from industry, government agencies, and you to determine the need for new or amended regulations and to identify and eliminate unnecessary or burdensome regulations. We encourage your participation and consider it essential in the rulemaking process.
- We issue exemptions to regulations when unusual shipping situations and technological advances cannot be addressed in existing regulations. Periodically, exemptions are converted to general regulations which extend the benefits of the exemptions by allowing you to use containers or shipping practices previously authorized only under an exemption.
- We manage the Hazardous Materials Registration Program which provides funding for the Emergency Preparedness Planning and Training Grants. We provide grants to states, U.S. territories, and Native American tribes to support local emergency planning committees and train emergency personnel. Emergency planning and training helps your community prepare for a spill, incident, or other hazardous materials emergency that may occur.
- We maintain the Hazardous Materials Information System (HMIS), a national database which includes incident reports. HMIS data on incident reports and other safety-related hazardous materials information are available to you upon request.
- We sponsor the Cooperative Hazardous Materials Enforcement Development (COHMED) program, an outreach effort which promotes national uniformity of Federal/State and local regulations and enforcement activities. We encourage your attendance at COHMED conferences to help you identify areas to minimize risks and facilitate trade.
- We inspect hazardous materials shipments, packaging manufacturers, and related certifying, retesting and reconditioning facilities. Our inspectors assigned to the Washington, DC headquarters and regional offices can also provide you with technical assistance.
- We provide you, upon request, with training materials, fact sheets, and other safety information to help you understand and comply with the Hazardous Materials Regulations.
