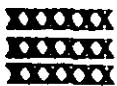

Carlo Gambino is an extremely powerful and notorious hoodlum of Brooklyn, New York. Highly confidential sources in both New York and Chicago have named him as likely being a member of the "commission" a group of men who exert influence in matters of criminal jurisdiction and control of the criminal activities of the nationwide hoodlum element comprised of persons of Italian extraction. Gambino along with several other individuals of similar background from New York, Chicago and other places is in Miami, Florida.

Miami Office has been successful in establishing a highly confidential source covering Gambino while in Florida, where he is expected to remain until March 17. The source has reported that Gambino speaks quite often in an Italian dialect which has been determined by consultation with the FBI Laboratory to be Sicilian. SAC, Miami, requests assignment of an Agent who will be able to make "on the spot" translations of Gambino's remarks.

The New York Office has an Agent, [REDACTED] who is able to translate Sicilian dialect and it has been ascertained that New York is in a position to release [REDACTED] temporarily for duty in Miami as desired. b7c

RECOMMENDATIONS

1. In view of the great importance of Gambino in his position in the criminal underworld, it is recommended that SA [REDACTED] be sent to Miami on special assignment until March 17, at which time it is expected Gambino will return to New York. REC-41 92-2811-71

2. That this memorandum be forwarded to the Administrative Division in order that instructions may be issued to have SA [REDACTED] go to Miami on special assignment in connection with the coverage of Gambino.

GAMBINO told [redacted] he had called someone 3 or 4 times, but could not locate him. He also stated he was in most of the day and only went out for a couple of hours. He told [redacted] they would get together one day maybe for breakfast, about 10:00 A.M.

The call was not completed.

At 5:45 P.M., Mrs. GAMBINO was overheard to make a telephone call to [REDACTED] Miami Beach, where she spoke [REDACTED] and told [REDACTED] she had talked to [REDACTED]. She told [REDACTED] would be there at 7:00. CARLO GAMBINO got on the telephone and stated he will come to see the person at [REDACTED] on 3/9/62. **b7c**

At 10:15 A.M., on 3/9/62, Mrs. CARLO GAMBINO was overheard to receive a telephone call in which she told the individual she tried to get them yesterday, wanted to come to see them, but highway was blocked. She then stated, "We'll be down in 15". She then spoke to an individual named [REDACTED] (phonetic). **b7c**

At 3:15 P.M. on 3/9/62, a Maintenance Man of the Golden Gate Motel was overheard doing some work in Room 218. CARLO GAMBINO entered the room at 3:34 P.M. and thanked the Maintenance Man for the work he had done. The Maintenance Man was overheard to say, "This is the spot, it's all right".

At 3:55 P.M., 3/9/62, CARLO GAMBINO was overheard to receive a telephone call in which he told an individual to come up to 218, "I got a little pain in my chest".

At 3:55 P.M., 3/9/62, CARLO GAMBINO was overheard in conversation with someone in Room 218, Golden Gate Motel. He told this individual he had never seen so many FBI and police as he did today. The caller mentioned he had left [REDACTED] in the lobby; [REDACTED] joined the general conversation. GAMBINO stated he was sorry the caller was leaving by train at 4:50 P.M. 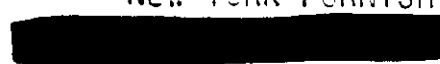

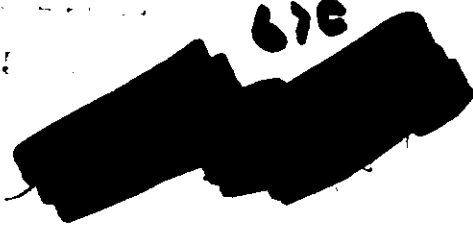

English and GAMBINO was heard to say "I saw him yesterday and I sent him up to you". "In the meantime, you have to take things as you find them. I don't have to speak with you tomorrow [redacted] will find us tomorrow".

At 4:25 P.M., March 14, 1962, Mrs. GAMBINO was overheard to inquire of GAMBINO in Sicilian if [redacted] be there tonight. He told her he did not know but did not think so. There was conversation in Sicilian as to where they would eat. He stated probably at [redacted] it was not clear to him. 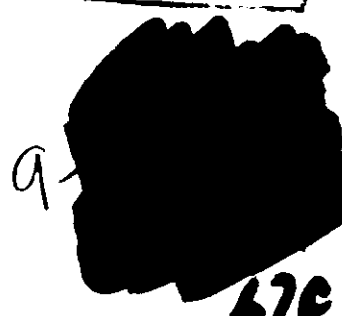

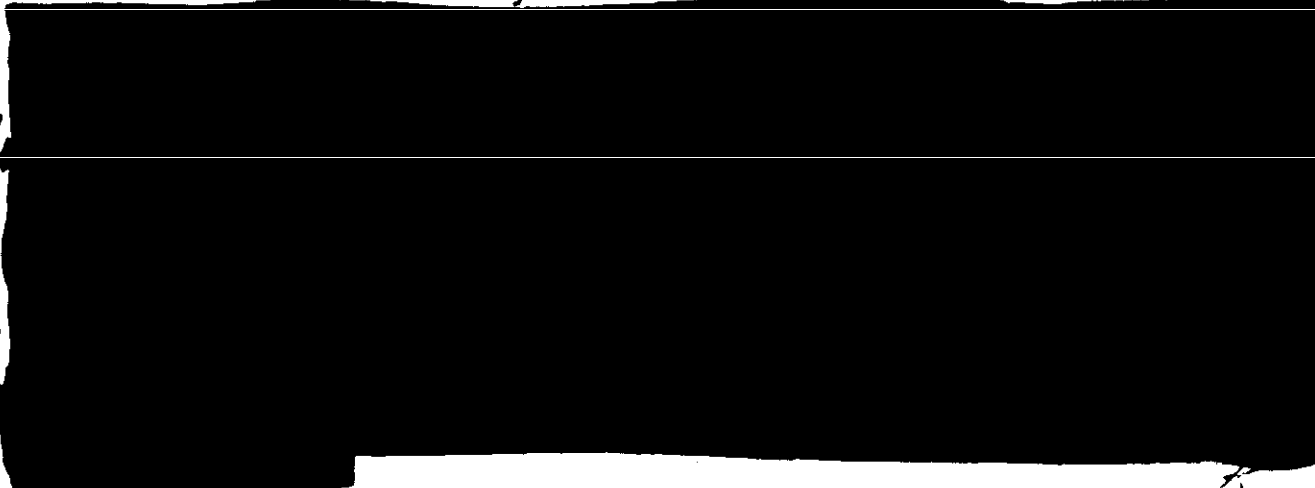

Enclosed herewith for the Bureau are the original and three copies of a letterhead memorandum pertaining to the subject.

It is requested that the enclosed letterhead memorandum be disseminated to the Department in an effort to convince the Department that GAMBINO is physically capable of appearing at an Immigration and Naturalization Service (INS) hearing.

It is further requested that the Bureau, if it agrees that a hearing can and should be pressed, discuss this matter on a Departmental level which would be in a position to resolve INS' seeming reluctance to proceed against GAMBINO.

It is pointed out to the Bureau that, in conferences with INS officials at New York City, it has been determined that their only objection to holding the hearing is a fear that GAMBINO may actually suffer a fatal heart attack during the course of a hearing. INS feels that, if such should occur, the resulting adverse publicity would overshadow any possible good that the hearing would accomplish.

It is felt that the information contained in the enclosed letterhead memorandum tends to indicate that the subject could withstand the rigors of an INS hearing.

On November 25, 1957, the INS obtained a warrant for the subject charging him with violation of Section 241A1 of INS Act of December 29, 1952, in order to show cause why he should not be deported, and charging Gambino, a national of Italy who entered the United States on December 23, 1921, at Norfolk, Virginia, with being a stowaway on the "SS Vincenzo Florio."

On November 3, 1958, Gambino appeared before an INS Deportation Hearing; however, he complained of chest pains and was removed to a hospital. The hearing was postponed, and, to date, no new hearing has been scheduled.

On November 4, 1958, [REDACTED] Investigative Unit, INS, New York City, advised that Gambino had indicated he would refuse to answer any questions put to him at the hearing. In view of this, it was [REDACTED] opinion that it would not be too difficult to deport Gambino.

On August 13, 1960, Gambino entered the United States Public Health Service Hospital, Staten Island, New York, for a cardiac evaluation. In part, the Public Health Service Medical Report reads as follows:

"Regarding your (INS) questions about whether Mr. Gambino can take part in deportation proceedings: it is our opinion that he may be served papers and interrogated without risk to the patient. It is possible that under the condition of emotional excitement, Mr. Gambino will have episodes of angina pectoris pain. These can be readily controlled by patient taking nitroglycerin tablets. We suggest that the

hearings be held as informally as possible and that the questioning period be no more than 20 to 30 minutes in length, with a short rest interval between each questioning period. If Mr. Gambino would take a nitroglycerin tablet prior to the questioning he might have less difficulty with his anginal pain. A very small risk does exist that if the patient would become severely agitated, he might have a myocardial infarction."
