THE BASE LINE IS LOCATED ABOUT 1.6 KM (1.0 MI) SOUTH OF LONDON, KY AT THE LONDON/CORBIN AIRPORT (MAGEE FIELD), 17.7 KM (11 MI) NORTH OF CORBIN, KY, 46.8 KM (29 MI) EAST OF SOMERSET, KY AND 27.4 KM (17 MI) WEST OF MANCHESTER, KY.

THE BASE LINE IS AN EAST-WEST BASE LINE WITH THE 0-METER POINT ON THE EAST END. IT CONSISTS OF THE 0, 150, 430, AND 1200 METER POINTS.
