## Twenty-one Volunteers Honored During National Health Care Fraud Conference in Washington, D.C.

On Wednesday, July 21, 2004, the Administration on Aging (AoA), an agency of the U.S. Department for Health and Human Services will honor the contributions of 21 senior volunteers who serve as community educators and resources in the Administration's effort to fight fraud, error and abuse in Medicare and Medicaid programs.

The Senior Medicare Patrol (SMP) Project grants, originally the "Health Care Anti-Fraud, Waste and Abuse Community Volunteers Demonstration Projects," were established in 1997 under the Older Americans Act through language in the Omnibus Appropriations Consolidation Act. Administered by the AoA, the projects recruit and train retired professionals such as doctors, nurses, teachers, lawyers, accountants and others to work with Medicare and Medicaid beneficiaries.

AoA's volunteers have worked in their own communities and in local senior centers, educating more than 1.5 million Medicare and Medicaid beneficiaries on how to recognize and report suspected cases of deceptive health care practices, such as over billing, overcharging, or providing unnecessary or inappropriate services. This training also empowers beneficiaries to be better health care consumers.
