Land and Water Conservation Fund (LWCF) State Grant Program Proposed LWCF National and Performance Goals/Measures and Implementation Strategy

In FY2003, the Office of Management and Budget (OMB) evaluated the performance of the Land and Water Conservation Fund (LWCF) State Grant Program through the Program Assessment Rating Tool (PART). In its assessment of the Program's purpose, national relevance and delivery, the review was generally positive. However, OMB found room for improvement in the areas of strategic planning and measuring performance. Accordingly, OMB recommended that program managers coordinate with state partners to establish meaningful performance measures and develop a comprehensive process to capture and report program accomplishments.

In March 2004 the Program managers assembled a LWCF Performance Implementation Team, consisting of National Park Service (NPS) staff, state partners, and members from constituent organizations to respond to these recommendations. After more than fifteen sessions, a sub-workgroup has made its recommendations for LWCF program performance goals and measures as well as an implementation strategy. The performance assessment framework includes three national strategic program goals and seven performance goals.

Implementation Strategy

Performance of the LWCF program will be assessed through thirteen proposed performance measures. Select performance measures will be used in the Federal budget process while all thirteen will be reported in an annual program performance report. Implementation of the LWCF performance assessment framework will commence October 1, 2004 with willing State partners. Full implementation with all States and Territories will begin on October 1, 2005.

Implementation of the performance framework involves three basic tasks. The first is defining the appropriate targets for the performance measures that will be incorporated into the Federal budget process. The second is systematically tracking our progress achieving these targets and reporting on the performance goals included in the annual program performance report. The final task would be submitting State and Territory program accomplishment summaries that will be published in the annual program performance report.

Project Status

These proposed goals and measures as well as the implementation strategy are under current review by NPS program leaders. Formal approval from the Office of Management and Budget and Department of Interior representatives is scheduled for September.
