

"Excuse me for taking the liberty to write you about my private matters but you are the person who can help me in this difficult situation.

"The trouble is that the State Department gives no exit permit for my spouse Mrs. Gittel Madel M.D., who is working and living in the Willard Parker Hospital, New York 9, N.Y. My spouse presented her application in March 1944 and until now has received no direct answer, in spite of intervention of the Ambassadors of Czechoslovakia and Costa Rica; only a lawyer who asked the State Department for a resolution in this matter has received the notice that a new application can be presented on the beginning of the present year.

"I will inform you about myself; I am 45 years old, a Polish citizen, a Jew, of Polish nationality; doctor in mathematics, actuary and economist; From 1918 to 1930 I studied and worked as actuary in Prague, Czechoslovakia; from 1930 to 1938 I lived and worked as actuary in Warsaw and moved in 1938 to Prague. After Munich I left Czechoslovakia for Bolivia. In Bolivia I worked $4\frac{1}{2}$ years as Director of the Social Security Department of the Ministry of Labor; simultaneously I was technical adviser of the Ministry of Finances. In April 1943 I received the immigration permit to the U.S.A. My wife moved in August to New York and I had decided to do it some months later, after finishing my work in Bolivia. In the meantime, during the parliamentary discussion about the well known Catavi massacre, I was accused and jailed as communist, but quickly released by order of the High Court, which sentenced in 'habeas corpus.' Immediately I was reinstated, by order of the president General Penaranga, in my job in the Ministry of Labor, where I worked until my move to Costa Rica in March 1944. In the meantime the State Department cancelled my immigration permit and the International Labor Office arranged my actual job in Costa Rica. Here I am working as technical adviser and actuary of the Social Security Board, as technical adviser of the Financial Commission of the Congress and as professor of the University. In October last I presented to the State Department an application for transit visa to Montreal in order to participate in the 2nd International Conference of Actuaries, organized by the International Labor Office. In spite of the intervention of the Costarican Ambassador, the

"Social Security Board and the International Labor Office and in spite of the fact that I have received the visa of Canada, the State Department has not yet answered my application, after four months.

"The result of this is that I have not seen my wife for more than one and a half year. I am sure that the State Department has no intention of destroying my home and my family life; but nevertheless this is what is happening. I greatly miss my beloved wife.

"I beg your help and your assistance in this desperate situation of mine. I thank you in advance and remain."



Foundation which would be free of all controls. ██████ told the membership that ██████ a charter member of the B-C Branch of the AAScW, was in dire financial straits and that he, ██████ was at a loss to understand why the Branch had not provided him with assistance. He did not pursue the topic when ██████ pointed out that so long as ██████ was under indictment, the Branch ought to avoid any action which might prove embarrassing.

██████ then took the floor to severely criticize the AAScW for not having taken some action to rid American universities of Nazi scientists brought to this country by the War Department for research work. She described these Nazi scientists as enemies of the United States who were depriving skilled American scientists of a means of livelihood. She did not feel that any scientific contribution they might make to this country justified their presence. The informant noted that two such Nazi scientists who are doing work at the Boston University Optical Laboratory, one ██████ and ██████ had been brought to the meeting by ██████. In view of their presence, and in order not to personally embarrass them, ██████ cut down the discussion on this point.

██████ has furnished the Boston Field Division the News Letter published by the B-C Branch for February, 1947. This News Letter urged AAScW members to send telegrams to their respective Congressmen and Senators urging confirmation of DAVID LILIENTHAL as Chairman of the Atomic Energy Commission. Favorable reference was made, and at length, to an article appearing in the February 3 issue of the NEW REPUBLIC magazine by Mr. HENRY WALLACE. WALLACE, according to the News Letter, condemned unnecessary amount of control being placed on scientific research by various Government agencies. Members were also urged to hear Mrs. ELEANOR ROOSEVELT in a Boston appearance on February 21, 1947. The bulletin further announced that as a result of its earlier filed protest, Mr. I. F. STONE, Washington editor of PM, had delved into the Aberdeen Proving Ground case and had exposed the War Department and its Fascist tendencies. The readers were referred to the article for further elucidation. (U)

Zlatko and Joyce Balokovic are, of course, husband and wife, the former being a naturalized citizen who came to this country as a concert violinist, but attained his most notable success by his marriage to the latter, the former Joyce Borden, a heiress of considerable means.

The Balokovics are extremely close to Louis Adamic who, as you know, is a well known Yugoslav - American author who has sponsored the cause of Tito in this country and other causes of Communist taint. With Adamic Zlatko Balokovic was instrumental in forming in 1943 the United Committee for South Slavic Americans and at the present time he is its President with Adamic being Honorary President. This group, as shown by the Bureau's investigation of it, works closely, and is in almost constant contact with individuals identified with the Yugoslavian Embassy or official Yugoslavian missions in the United States.

[REDACTED] in connection with the Bureau's inquiry into the activities of the United Committee of South Slavic Americans. It has been apparent for some time that the United Committee operates as a propaganda and publicity agent for the present Yugoslavian Government, and in this regard investigative reports and other material have been regularly made available to the Criminal Division.

The Criminal Division has vouchsafed the opinion that the United Committee's activities have been in violation of the Registration Act and on one occasion the activities of this group have been described by an individual in the Criminal Division as perhaps one of the most flagrant violations of the Registration Act to come to light.

During the Roosevelt regime the Balokovics and Louis Adamic, as well as others identified with the Tito cause, had considerable entre into influential circles in Washington and Zlatko Balokovic was personally introduced to former Attorney General Biddle by Eleanor Roosevelt. The Committee has, of

course, on a number of occasions in the past been requested by the Department to appropriately register, but has consistently refused to do so.

At the present time, the Bureau has been told the only thing holding back institution of steps looking toward prosecution of the United Committee is a doubt as to just what "off the record" arrangements might have been made by the Balokovics and former Attorney General Biddle.

At the present time the Department is attempting to ascertain exactly what understanding, if any, might have existed between the former Attorney General and the Committee in order that it might proceed with prosecutive action without fear of having the Committee use as a defense an agreement entered into with Biddle whereby the Department sanctioned or rationalized the Committee's activities.

My dear Mrs. Roosevelt:

I have recently learned through Solicitor General
Francis Biddle that some concern has been expressed re-
garding the fact that the Bureau has been conducting an
investigation of Mrs. Edith B. Helm. I wanted to advise
you that the Bureau initiated an investigation of Mrs.
Helm as a result of a specific written request dated
October 29, 1940 by Mr. Sidney Sherwood, Assistant
Secretary of the Advisory Commission to the Council of
National Defense. Mrs. Helm's name was included in a
list of persons who were described as "per annum employees
of the Advisory Commission to the Council of National
Defense." Mr. Sherwood, in line with established
procedure, has over a period of time requested investi-
gations of several hundred employees of the Advisory
Commission to the Council of National Defense and no
indication was given us as to the identity of Edith B.
Helm or the fact that she was acting in a secretarial
capacity for you.

In view of the fact that some question apparently
has been raised as to why the Bureau was conducting this
investigation, I wanted to inform you fully of the facts
in the matter. Of course had we known at the time the
investigation was requested that Mrs. Helm was assigned
to White House duties the inquiry would not have been
initiated. I want to assure you that I regret the
incident may have caused you any annoyance or concern.

MEMORANDUM FOR MR. ROSEN

Re: Investigations being conducted of the Personnel of The Advisory Commission to the Council of National Defense.

With reference to my memorandum of this same date reflecting an interview had with Mr. Matthew F. McGuire, Assistant to the Attorney General, upon the authority of Mr. L. R. Fennington, I wish to record the additional information as hereinafter set forth.

Mr. McGuire advised he deemed it preferable to have all requests in the future emanating from The Advisory Commission to the Council of National Defense clear through the office of the Attorney General in order that that office might be advised at all times concerning the names of the individuals upon whom investigations are being requested of the Bureau. He explained that this situation was brought to a head through a recent request made by Mr. Sidney Sherwood at The Advisory Commission to the Bureau for an investigation of Miss Edith Helm who is a personal secretary to Mrs. Roosevelt, the wife of the President. He explained as a result of the Bureau's investigation Miss Helm had apparently learned that inquiries were being made concerning her and Mr. McGuire indicated although he did not state as much, that this had been brought to the Department's attention by the President. He explained that he was going to contact Mr. Sidney Sherwood immediately and arrange for all these requests to clear through his office in the future in order that no kickback might be made upon the Bureau as a result of investigations being conducted of individuals whom the Department might feel should not be investigated in view of their positions and surrounding circumstances. My dear Mrs. Roosevelt:

Edith B.

I have just received your note of January 26th relative to the investigation of Mrs. Helm. I note your statement that the explanation contained in my letter of January 24th that the investigation of Mrs. Helm was a mistake, indicated inefficiency upon the part of the person who ordered it. I thoroughly share your view about this. I did want to make certain, however, that you understood that the investigation was not ordered by the Federal Bureau of Investigation, but was ordered by the Assistant Secretary of the Advisory Commission to the Council of National Defense.

In regard to the statement that inquiries have been made about Miss Thompson at her apartment house as to when she comes and goes and other information, I made immediate inquiry and find that no investigation of any character has been or is being conducted by this Bureau of Miss Thompson.

I want to assure you that there has been no one more appreciative of the necessity for avoiding any attitude or indulging in any activities which might be construed as improper or un-American as those in the conduct of investigations than I. I think it is so important that those of us who are charged with the conduct of Governmental investigations see that they are carried forth in a proper manner - fairly, impartially, and without any aspect that may favor of those procedures typical of certain foreign Governments and so repugnant to our American ways. To accomplish this, we have endeavored to select not only personnel of very high standing and ethics, but to also train and instruct that personnel in the proper performance of their duties and in the necessity for carrying

them out in a truly American way. Obviously, no Governmental agency can expect to merit the support and confidence of the public unless it conducts itself in a manner that is both legal and ethical.

In connection with the necessary expansion of Governmental agencies incident to the National Emergency, the policy had been established of sending to the Federal Bureau of Investigation the names of persons working for these Governmental agencies, in order that inquiry might be made as to their background, integrity and loyalty. I want to point out that this work was not sought by the Federal Bureau of Investigation, but was assigned to it. I want further to point out that the names which are sent to the Federal Bureau of Investigation upon which investigations are ordered by the interested Governmental agencies, are selected by these agencies and that this Bureau has no part in the selecting of these names upon which investigations are ordered. In the case of Mrs. Helm, I understand now that her name was on the pay roll of the Advisory Commission to the Council of National Defense, along with many others, and the list, which was prepared in the Advisory Commission to the Council of National Defense, was taken from the pay roll of that Commission. This Bureau had nothing whatsoever to do with the preparation of the list or the placing thereon of Mrs. Helm's name. The investigation of all of these names, including Mrs. Helm, was predicated upon the letter from the Advisory Commission to the Council of National Defense.

I want again to assure you that I deeply regret the resentment which this incident has caused you, and particularly the impression which I fear you have gained as to the position of this Bureau in this matter. I have tried in this letter to clarify exactly what the position of this Bureau has been and what its function was, and I am hopeful that this may correct the impression which you may have.

However, anyone who cared to avoid such a mistake would only have had to look at the questionnaire which Mrs. Helm filled out last summer to realize that she has been attached to the White House ever since we have been here, and incidentally that her father and husband had been Admirals in the Navy.

Reds Squatters Among Liberals, F. D. R. Jr. Says

NEWARK, N. J. —(INS)—
Franklin D. Roosevelt Jr., de-
clared yesterday that all
American Communists should
be forced to stand up and be
counted as such.

The son of the late pres-
ident, addressing a group or-
ganizing a New Jersey chap-
ter of Americans for Demo-
cratic Action, said he does
not favor outlawing of the
Communist party, or its sup-
pression.

All Communists, however,
he said, should be stripped of
their "liberal" disguises.

He described Commu-
nist party members as "mere
squatters of the American lib-
eral traditions" and said "we
must remove them."

Roosevelt also said that
Americans must not be con-
fused and misled by those who
say that attacks on American
Communists are attacks on
Soviet Russia, but must con-
fine themselves to these facts:

"The government of the Rus-
sian people is their business:

"The preservation of Amer-
ican freedom and Democracy
by exposing and eliminating
all proletarianism movements
here is our business."

Roosevelt said:

"The Communists for the
moment have adopted the pro-
tective coloration of liberalism,
but at heart believe in a dic-
tatorship which they call the
'dictatorship of the proletar-
iat.'"

He also made a strong plea
for "a foreign policy that will
offer a democratic alternative
to proletarianism to the awak-
ened people of the world."

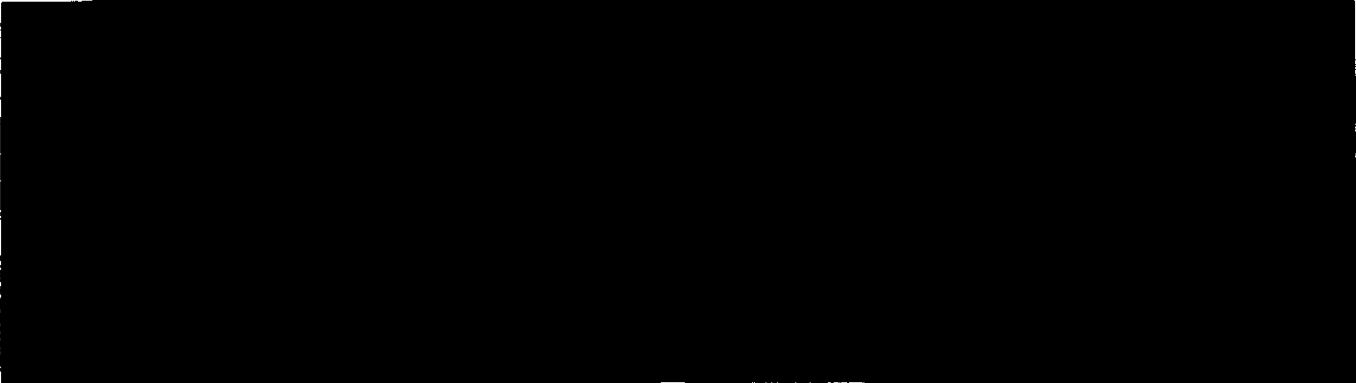
In accordance with your request a discreet inquiry was made of certain employees of the White House to determine whether these employees are divulging confidential information to unauthorized persons. This group included ushers, doormen, butlers, housekeepers, gardeners, telephone operators, chauffeurs, employees of the Social Correspondence Section, Social Entertainment Section, Telegraph, Code, and Travel Section, the President's valet, his masseur, and the secretary to Mrs. Truman. A total of eighty-one employees were checked and spot surveillances were conducted on one or more of the employees of each of the above categories. With the exceptions noted hereinafter, the information developed was not unfavorable, and no instances of such employees divulging official information to unauthorized persons were discovered.

You will observe in some instances arrest records are recorded with the qualification that sufficient information is not available to positively identify the person arrested with the White House employee or member of his family. Due to the discreet nature of this inquiry it was not possible to directly interrogate the employee involved, or others who might definitely identify the person arrested with the White House employee under investigation.

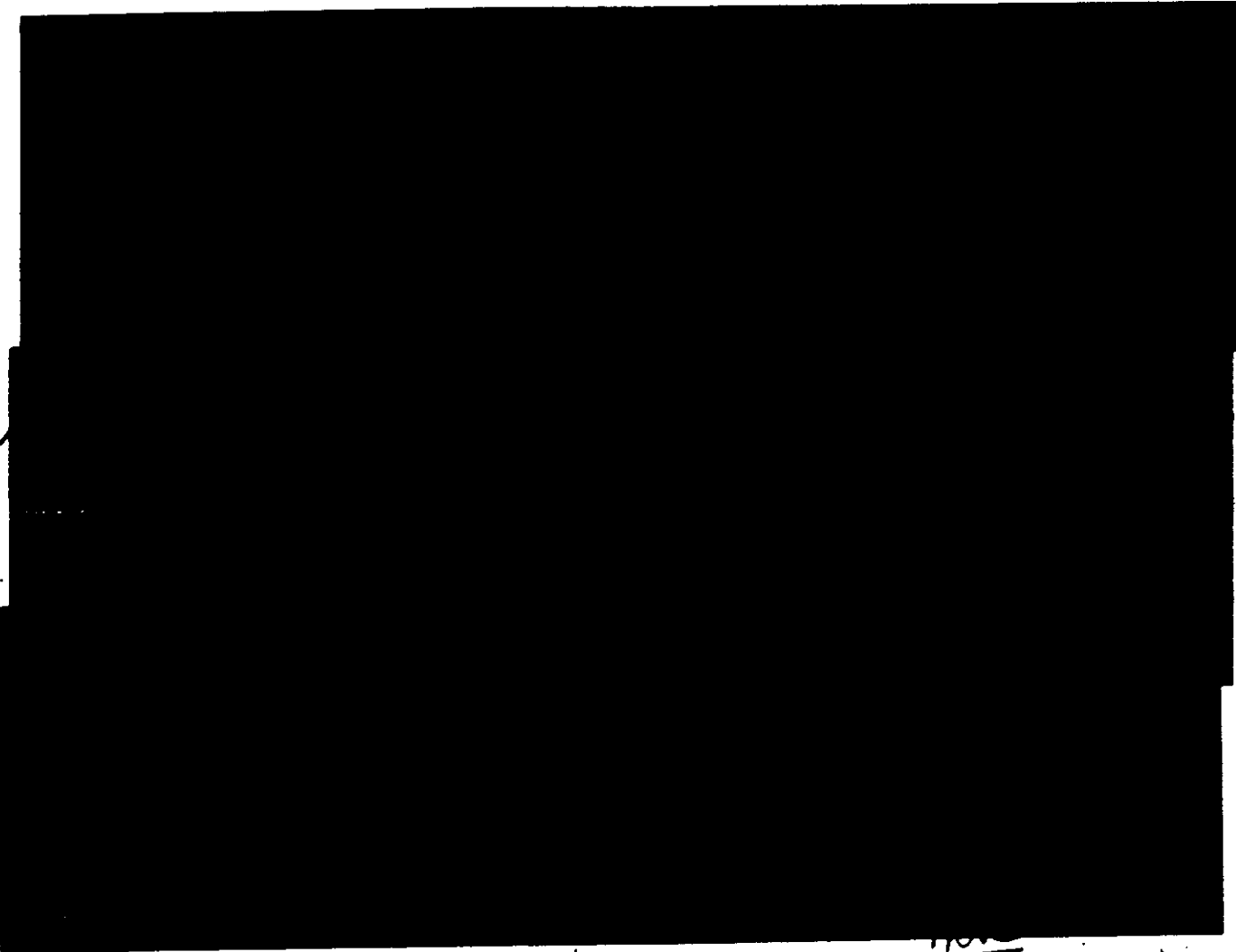

In the case of [redacted], Forgery of Bureau of Standard Reports, Fraud Against the Government, an investigation was conducted relative to the forgery of Bureau of Standards reports in which [redacted] were involved. [redacted] submitted to the Bureau of Standards for tests certain specimens for building materials which [redacted] perfected. The Bureau of Standards submitted an unfavorable report on these tests, dated May 18, 1935, and the object of the investigation was to determine if a favorable report dated May 24, 1935, had been fabricated by [redacted]. The investigation disclosed that [redacted] claimed to have influence in the White House through [redacted], who at that time was on the clerical staff of Mrs. Eleanor Roosevelt.

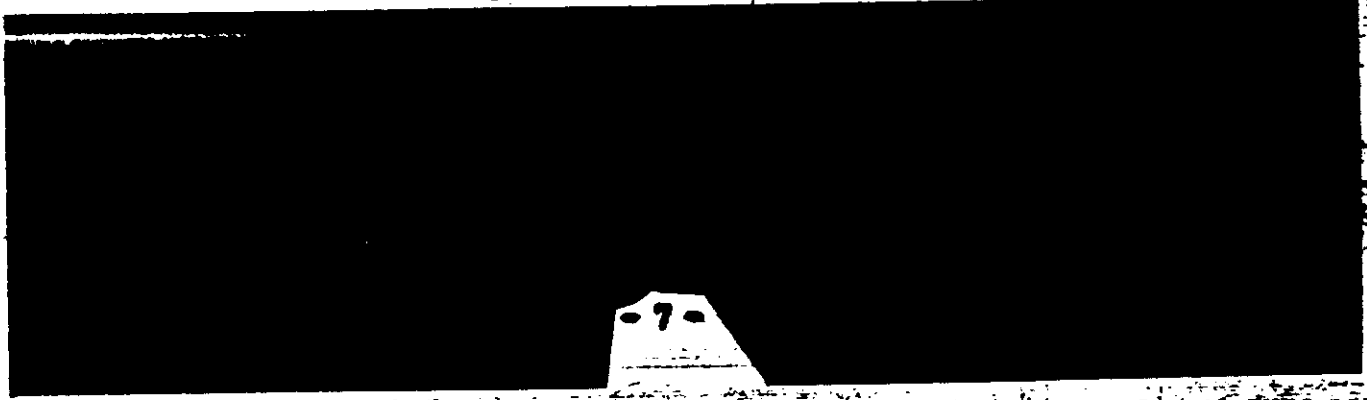
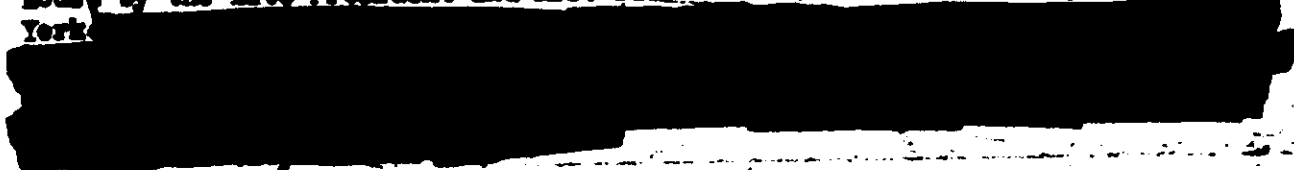
The facts in this case were discussed with the United States Attorney for the District of Columbia who was of the opinion that the evidence was insufficient to definitely connect [redacted] with the compilation of fraudulent reports for the Bureau of Standards, and, accordingly, the case was closed.








The above investigation developed information from a confidential but reliable source that [redacted] said that he had no difficulty in obtaining a loan from the Government, because he had a [redacted] who was employed as a housekeeper in the White House. [redacted] was quoted as saying that when he made an application for a loan he would write to [redacted] who in turn would inform Mrs. Roosevelt of the request, and that in most instances the loan would be granted immediately.

Attended luncheon in honor of Mrs. Franklin D. Roosevelt and
Mrs. Maxim Litvinoff at the Waldorf Astoria Hotel, 49th St. and
Park Avenue. There were three thousand people present. Admission
was three dollars per person. At this luncheon there was inaugurated
a nation-wide campaign for six million dollars for Russian War Relief.

The luncheon started with the playing of the Internationale and
the Star Spangled Banner. The audience joined in singing both. The
Chairwoman was Mrs. ~~GilGersleave~~, dean of Barnard College. The first
speaker to be introduced was Archibald ~~W. Leish~~, director of the ~~Office~~
of Facts and Figures. He said that there are Fascists in this country
who would rather see this country lose the war than give aid to the
Soviet Union. There are those he said who would hold back shipping the
arms to the Soviet Union because they think these arms would be used for
the Bolshevization of the world. This is not so he said as you cannot
force upon the people a form of government that they do not want as the
people will choose the form of government they desire.

The next speaker was Mrs. Litvinoff who after being introduced said
to the pleasure of everyone listening, "I was a British subject, I am a
Soviet citizen". Her speech was about the gallant red army and the good
work being done by the Russian War Relief.

She was followed by Miss Margaret ~~Webster~~, who gave a speech official-
ly launching the campaign for six million dollars. She announced several
donations of one hundred dollars, five hundred dollars, ~~one thousand~~ dollars

Your letter of March 6, 1947, relating to American Youth for Democracy, was deeply appreciated. I have deferred an acknowledgment of the letter until today in the belief that you might be interested in the report of our Committee. A copy of such report, which was delivered to President Stearns last Saturday afternoon, is enclosed. The report contained no recommendation as to the attitude which the University should adopt with respect to the organization. President Stearns decided, however, to bar AYD from the campus not, I think, because it is communistic, but because it is not in its underlying purpose the democratic and liberal institution which it purports to be.

Your Committee also examined files of the Daily Worker and the New York Times from the date of the organization of AYD to the present time, and read numerous reports of congressional committees and of others engaged in investigating so-called un-American activities. In addition, your Committee sent letters of inquiry to the following persons and organizations:

National Headquarters, AYD, National Association of Manufacturers, National Chamber of Commerce, Naval Intelligence Service, Army Intelligence Service, Federal Bureau of Investigation, The New Republic, The Nation, Christian Science Monitor, PM, Columbia University, Brooklyn College, Queens College, University of Utah, Michigan State College, University of Michigan, University of Chicago, University of Wisconsin, New York University, University of Washington at Seattle, Life, Eleanor Roosevelt, and University of California.

In each of these letters the addressee was informed of the appointment of the Committee and its purposes, and the desire of the Committee to make a complete and impartial investigation. The addressee in each case was invited to send to the Committee information concerning the origin, motivations, and purposes of AYD. As of the date of this report, the Committee has received replies from all of the letters except those sent to the National Association of Manufacturers, Naval Intelligence, Army Intelligence, The New Republic, Christian Science Monitor, University of California, and Eleanor Roosevelt. The letter to Mrs. Roosevelt was sent only a few days ago. She has hardly had time to respond. In view, however, of your request for a prompt report, we have decided not to wait for this and other possible replies.

From the hearings, our own investigations, and the replies to our letters we have accumulated a considerable amount of material regarding AYD. Some of the information is confidential, and some has been returned to its source, but much of the material will be kept in our files where it will be available if evidence confirmatory of our findings is needed. Certain other evidence has also been micro-filmed and is available in the files of the University Library.

Turning now to your specific questions, our answer to your first question is that the Colorado Tom Paine Chapter of AYD is a student organization controlled by regularly enrolled students in the University. In giving this answer, we feel that a distinction must be made between the word "controlled" and the word "influenced". By the terms of Article IV of the Constitution of the national organization, each club selects its own name, elects its own officers, and is authorized to draw its by-laws in conformity with the National Constitution of AYD. There is nothing in the National Constitution of AYD militating against democratic operation of the local clubs, which are authorized to conduct such activities as may be decided by the majority.

Reference is made to New York letter to the Bureau dated January 27, 1944, in the above entitled matter; more particularly reference to JOSEPHINE TRUSLOW ADAMS.

A discreet inquiry at the Dioptric Instrument Corporation, 47 West 56th Street, New York City, revealed that JOSEPHINE TRUSLOW ADAMS was employed there and that she resided at 55 West 10th Street, New York City. Her former residence was 431 Riverside Drive, New York City.

It was also learned that JOSEPHINE ADAMS had taken one week leave of absence from her employment either the last week in January of 1944 or the first week in February, 1944, for the purpose of making a trip to Washington, D.C. The inquiry further revealed that her fellow employees were under the impression that the purpose of the trip was to visit Mrs. ELEANOR ROOSEVELT at the White House. Her fellow employees further revealed that she had made numerous references concerning her association with Mrs. ROOSEVELT, and had made the statement that she was going to induce Mrs. ROOSEVELT to make an inspection trip through the Dioptric company's plant.

SYNOPSIS OF FACTS:

The Negro Youth Council for Victory and Democracy was founded by HARPER [REDACTED], alleged Communist, and EDWARD TOLAN, Communist sympathizer, after the Detroit Youth Council was disbanded in May, 1942. TOLAN invited Detroit Youth Council leaders to meet on June 16, 1942, at the Y.W.C.A. in Detroit to form a committee to deal with race discrimination, which committee resolved itself into Subject organization. As a sponsor, the NYCVD controlled the "Win the War rally" originated by the Young Negro Democrats in Detroit August 9, 1942. The NYCVD does not have a constitution, nor is it incorporated; financed through contributions. Headquarters now located at Twelve Horsemen's Civic Center. Official publication now discontinued. Aims and purposes of NYCVD follow announced Communist Party platform. All officers are Communists or closely affiliated with Communist front groups. Many members have been identified as Communist sympathizers. On October 25, 1942, the NYCVD planned "Institute on Training And Employment of Negro Women in War Work" the success of which was underwritten by the Civil Rights Federation, a Communist front organization. Many of the sponsors of the Institute are known Communists or sympathizers. Members of the Communist Party and the Young Communist League spoke at meetings. The NYCVD has advocated the abolition of the poll tax, non-discriminatory housing, ending of segregation in the armed forces, the freedom of India, and the ending of Jim Crow practices in Detroit. Two hundred and fifty persons representing the Young Communist League, the International Workers Order, the National Negro Congress, the Metropolitan Detroit Youth Council, the UAW-CIO, the National Association for the Advancement of Colored People, the State, County,

Bureau Confidential Informant [redacted] stated that the Win the War Rally sponsored by the Young Negro Democrats had a strong Communistic influence and had received endorsements from Senator CHARLES C. DIGGS, MRS. ROSA GRAGG, WILLIAM L. SHERMILL, Negro, and HORACE WHITE, Negro. Endorsements had been received for this meeting from UOPWA-CIO Local 663 and from the NAACP branches. Bureau Informant [redacted] further stated that it was the scheme of the sponsors of this affair to cover up the communistic background of the meeting by the use of several non-Communist sponsors.

"The Michigan Chronicle" carried an item on August 8, 1942, which described the tremendous interest shown in the Win the War Rally. According to the newspaper, vice - President HENRY WALLACE sent his personal endorsement to the rally. An endorsement had also been received from Mrs. ELEANOR ROOSEVELT which stated as follows:

"I am very much interested to hear of your Win the War Rally on August 9, 1942. Our first major objective is to work, fight, and sacrifice for a United Nations victory...After the victory is won we must all work for a lasting peace based on the respect for the dignity of man the world over and justice for all.

very sincerely yours,

/s/ ELEANOR ROOSEVELT"

According to Bureau Confidential Informant [redacted] the Win the War Rally at Belle Isle was held on August 9, 1942 at 4:30 p.m. but only sixty persons were present, 95% of whom were colored. The poor attendance was attributed to threatening weather. The following were identified by the informant as being in attendance:

MR. MATHEWS, CHRISTOPHER ALSTON, GLOSTER CURRENT, EDDIE TOLAN, MR. COOPER (Negro) CHARLES C. DIGGS, PAUL WYKOFF, ROSA GRAGG, LOUISE JOHNSON (Negress) LIEUTENANT GEORGE MURPHY, Director of the Youth Activities Division of the Wayne County Council of Defense, Congressman O'BRIEN, 13th District, HARPER and BRIDGET POULSON, GENEVA BEST (Negress - Young Negro Democrats) and GLORIA MORGAN (Sojourner Truth Citizens Committee).

The meeting was adjourned to meet two weeks later. Lieutenant MURPHY, according to the informant, endorsed the rally and Congressman O'BRIEN said that he also favored the freedom of India. Although PAUL WYKOFF was the chairman, EDDIE TOLAN assumed the platform in the last moment and summarized the results of the meeting.

Bureau Confidential Informant [redacted] reported that a strong Communist influence was expected in this rally. According to the informant, the real reason for calling the meeting was to give voice to their demands to open the second front which would relieve pressure on the Red Army. Nationally known figures, such as Michigan's Governor MURRAY D. VAN HOGGONER, Senator PRENTISS M. BROWN, war manpower Commissioner PAUL McNUIT, and others had been invited as speakers.

The August 15, 1942, issue of the "Michigan Chronicle" carried an item advertising the postponement of the rally due to inclement weather. It was announced in the August 29 issue of this paper that the program which was originally scheduled for Belle Isle would be held at the Ebenezer Church at 4:00 p.m. on Sunday, August 30. The rally had received a great deal of publicity by reason of the endorsement by ELEANOR ROOSEVELT and Vice-President WALLACE and a write-up which appeared in "Life" magazine.

According to Confidential Informant [redacted] whose identity is known to the Bureau, approximately thirty-five persons attended the rally on August 30, 1942. One of the speakers, Professor S. R. WILLIAMS, spoke on Negro history and challenged the Negro youth to rise up. LEONARD TROUTMAN, of the National Youth Administration, said that militant persons here at home have been called "Reds, Communists, radicals, etc." but still the struggle must go on. During his speech TROUTMAN said that he hoped there were some FBI men in the crowd to hear him make this statement. He urged all persons in attendance to buy bonds and support the organizations and movements which were fighting for Negro rights.

According to Confidential Informant [redacted] whose identity is known to the Bureau, TOLAN has been formulating another organization. He was forming this organization for the purpose of integrating Negro women into war industries in the Detroit area. TOLAN plans to have a large meeting in October to emphasize this movement.

II ORGANIZATION AND FINANCE

According to Confidential Informant [redacted], the NICVD does not have a constitution nor is it chartered as a chapter of any known organization. No membership fees or dues have been assessed against any member. The organization is financed solely by contributions from interested individuals [redacted]




