 This program, designed to help 6th 8th graders stay involved in school and away from gangs, drugs, and violence, provides after-school activities in a safe and well-supervised campus setting.

➤ During 2001, there were 7,090 drug arrests for heroin in Los Angeles. This number increased to 8,729 during 2002. 18

➤ During 2002, 36.4% of male arrestees and 35.7% of female arrestees tested positive for marijuana at the time of arrest in Los Angeles. ¹⁹

Drugs

➤ Cocaine²⁰

Crack cocaine is widely available and is considered to contribute to the most serious consequences in Los Angles. Crack cocaine is 80-85% pure and an ounce sells for \$600-\$700. A rock, which is 0.2 grams, sells for \$10. Adolescents, along with young adults, are the primary crack cocaine abusing population in Los Angeles. Powder cocaine is considered not very available in Los Angeles. A gram of powder cocaine sells for \$100 and is an average of 80% pure.

> Heroin

Heroin is associated with the most serious consequences in Los Angeles. Mexican black tar and Mexican brown heroin are increasing in availability in the area. A "Mexican ounce," which is 25 grams, costs \$600-\$700 and a "balloon," which is 0.1 grams, costs \$20. Methamphetamine is often used in combination with heroin. Heroin prices from 2001 to 2002 range from \$80-\$100 per gram; \$18,000-\$22,000 per kilogram for wholesale quantities and \$32,000-\$60,000 per kilogram for retail quantities. Average heroin purity levels in Los Angeles range from 16-18%.

➤ Marijuana²³

Marijuana is widely available in Los Angeles. BC bud is increasing in availability. Mexican commercial grade marijuana sells for \$10 per gram and Mexican mid-grade marijuana sells for \$25 per gram. An ounce of Mexican commercial grade marijuana sells for \$60-\$80 and a dime bag sells for \$10. The number of younger marijuana users is increasing in Los Angeles.

> Methamphetamine

Methamphetamine availability is increasing in Los Angeles. An ounce of methamphetamine costs \$500-\$700 and an eightball, which is 1/8 ounce, costs \$100-\$120. A "teener," which is 1/16 an ounce, sells for \$60-\$125. Adolescents are the predominate users. Newer users tend to smoke methamphetamine, although injecting still predominates. ²⁴ Ice is frequently encountered in the LA area. ²⁵

➤ Club Drugs²⁶

Ecstasy was considered an emerging drug in Los Angeles during 2002. An ecstasy pill costs between \$25-\$40. More adolescents are selling ecstasy than in the past in Los Angeles. Ecstasy is used in combination with GHB, ketamine, and prescription drugs. Ecstasy use is becoming more prevalent in private settings such as residences and parties and is no longer just available in the club scene. GHB is widely available in Los Angeles. A capful of GHB costs \$20.

➤ Diverted Pharmaceuticals²⁷

OxyContin is not considered to be a significant problem in the Los Angeles area.

Juveniles

➤ During 2000, there were 1,819 juvenile arrests for drug law violations in Los Angeles. ²⁸ The number of juvenile arrests for drug law violations in Los Angeles decreased to 1,531 in 2001. ²⁹

➤ In Los Angeles during 2001, 41.2% of high school students surveyed reported using marijuana within their lifetime. ³⁰

➤ During 2000, 8.5% of juvenile male detainees and 2.1% of juvenile female detainees tested positive for methamphetamine at the time of arrest. 1% of juvenile male detainees and 2.1% of juvenile female detainees tested positive for PCP at the time of arrest.³¹

Enforcement

- As of October 31, 2002, there were 12,178 full-time law enforcement employees in Los Angeles (9,056 officers and 3,122 civilians).³²
- Narcotics Division, Los Angeles Police Department³³
 The Los Angeles Police Department's Narcotics Division is the largest drug enforcement entity in Southern California. It is responsible for enforcing local, State, and Federal narcotic laws throughout the City of Los Angeles. This division often works in cooperation with other law enforcement agencies to investigate narcotic related violations in neighboring communities, cities, and counties.

Trafficking and Seizures

- ➤ The trafficking of cocaine is a significant problem in the Los Angeles area.³⁴
- ➤ Los Angeles is a major transportation and distribution hub for Mexican black tar and brown powered heroin.³⁵
- Russian and Israeli drug trafficking organizations smuggle the majority of MDMA into California and transport it to Los Angeles using couriers on commercial air flights.³⁶
- Los Angeles based African American street gangs produce and distribute PCP.³⁷
- Mexican marijuana distributors in Los Angeles purchase B.C. bud and mix it with Mexican produced marijuana. They later market this combination as B.C. bud.³⁸
- Customs officials at the Los Angeles International airport often intercept Khat smuggled in quantities of up to 100 pounds.³⁹
- ➤ The U.S. Customs Service reported a seizure of 2,100,000 tablets/pills of ecstasy in Los Angeles during July 2000. The tablets originated from Europe. ⁴⁰
- ➤ During 2001, the Los Angeles Police Department seized more than 12,000 pounds of marijuana. From January to December 2002, there were 11,101 pounds of marijuana seized in Los Angeles.⁴¹

➤ The street value of marijuana seized during 2001 was more than \$115 million. From January to December 2002, the street value of marijuana seized in Los Angeles was over \$50 million. 42

Courts

- ➤ Drug Courts⁴³
 - As of November 2003, there were 2 drug courts in Los Angeles that had been in existence for over two years. No other drug courts were recently implemented or being planned.
- ➤ During FY 2001, approximately 42.2% of the Federally sentenced defendants in Southern California committed drug offenses. Approximately 76.8% of the Federal drug cases involved marijuana.⁴⁴

According to the Los Angeles County Sheriff, there were 23,741 total felonies filed and 39,901 total misdemeanors filed in the county during 2001. Narcotics offenses represented 36% of felonies filed and 14% of misdemeanors filed.⁴⁵

Corrections

➤ During FY 2000-2001, there were 4,185 inmates in the California State prison in Los Angeles County. 46

Consequences of Use

- ➤ Injection-related AIDS cases in Los Angeles were 39% black, 31% white, and 28% Hispanic. Hepatitis B cases declined in Los Angeles by 29% during the first half of 2001 compared to the first half of 2000.⁴⁷
- ➤ There were 176 emergency department (ED) MDMA mentions in Los Angeles during 2002.⁴⁸

➤ During 2002 in Los Angeles, 23.3% of all treatment admissions were for cocaine.⁵⁰
