

Programs/Initiatives

➤ Williamsburg Demand Treatment⁷

The Historic Triangle Substance Abuse Coalition works to provide persons who have inadequate health insurance coverage with screening, referrals, and treatment for substance abuse.

Federal Funding

- ➤ Drug-Free Communities Support Program grantees in Williamsburg: ⁸ Since funding was first available through the Drug-Free Communities Support Program in 1998, only one coalition in Williamsburg has received funding. In FY 2000, \$100,000 was awarded to the Williamsburg Community Health Foundation Historic Triangle Substance Abuse Coalition.
- ➤ There were no FY 2001 Substance Abuse and Mental Health Services Administration Discretionary Funds awarded to grantees in Williamsburg. 9
- Executive Office for Weed and Seed: 10
 Williamsburg has not been officially recognized as a Weed and Seed site.
- ➤ Williamsburg did not receive any funding for the FY 2002 Community Oriented Policing Services Methamphetamine Grant. 11
- ➤ There were no grants awarded to Williamsburg for the FY 2001 U.S. Department of Housing and Urban Development's Federally Assisted Low-Income Housing Drug Elimination Grants. ¹²
- ➤ Williamsburg did not receive any funding for the FY 2002 Office of Justice Programs Drug Court Grant. ¹³

Crime and Drug-Related Crime

➤ During 2002, there were a total of 480 index offenses known to the Williamsburg Police Department. ¹⁴

Enforcement

As of October 2001, there were 49 law enforcement employees in the city of Williamsburg (34 officers and 15 civilians). 17

Courts

➤ Drug Court¹⁸ As of January 2003, there were no drug courts in Williamsburg.

Treatment 19

- During 2002 in Williamsburg, there were 730 calls to substance abuse referral services. During this same time period, there were 1,865 people in treatment.
- There was an average of 30 persons waiting to receive treatment during 2002 in Williamsburg.
