### **Programs/Initiatives**

➤ Boise Area Narcotics and Drug Interdiction Task force (BANDIT)<sup>6</sup>
BANDIT is a multi-jurisdictional task force that investigates gambling, prostitution and illegal drug use.

- ➤ Drug-Free Communities Support Program<sup>7</sup>
  Since 1999, there have been no funds for the Drug-Free Communities Support Program awarded to Boise.
- Executive Office for Weed and Seed<sup>8</sup>
   Boise has not been designated as a Weed and Seed site.
- ➤ FY 2002 Substance Abuse and Mental Health Services Administration (SAMHSA) Discretionary Funds received in Boise: 9
  - Center for Mental Health Services: \$1,124,372
  - Center for Substance Abuse Prevention: \$0
  - Center for Substance Abuse Treatment: \$897,272
- ➤ FY 2002-2003 Office of Justice Programs Drug Court Discretionary Grant recipients in Boise:
  - FY 2002: \$495,225 to the Ada County Juvenile Court Services for drug court implementation. 10
  - FY 2003: no grantees. 11
- ➤ There were no Boise recipients of the FY 2003 funding available from the Department of Justice's Office of Community Oriented Policing Services (COPS) to fight methamphetamine. 12

- ➤ There were no funding awards in Boise for the FY 2001 Housing and Urban Development Drug Elimination Grants. <sup>13</sup>

## **Crime and Drug-Related Crime**

During 2000, there were 62 robbery offenses reported to law enforcement in Boise. This number increased during 2001 to 78. During 2002, robbery offenses increased to 84 in Boise. According to preliminary 2003 data, there were 30 robbery offenses in Boise from January to June 2003.

## **Drugs**

➤ Synthetic drugs including 2C-B, DET (a drug that imitates a psychotic state for psychological/medical experiments), SMeo DIPT, a.k.a. "Foxy" and "Foxy Methoxy" have appeared in the Boise rave scene.<sup>23</sup>

## **Juveniles**

During 2001, there were 744 larceny theft juvenile arrests in Boise compared to 1,177 during 1996.<sup>24</sup>

#### **Enforcement**

➤ As of October 2002, there were 326 law enforcement employees in Boise (262 officers and 64 civilians). <sup>25</sup>

### **Trafficking and Seizures**

➤ During 2001, there were 22 methamphetamine laboratories seized in Ada County. <sup>26</sup>

#### Courts

➤ Drug Courts<sup>27</sup>

As of November 2003, there were 2 drug courts that had been in existence for over 2 years in Boise. There were no other drugs courts recently implemented or being planned in Boise.

#### **Treatment**

➤ Boise Demand Treatment<sup>28</sup>

The Boise Demand Treatment works to develop a universal intake process for the city's social service system. This would include screening and referral for alcohol and drugs and participation with the State's regional substance abuse authority.

➤ Boise City Outpatient Methamphetamine Clinic<sup>29</sup>
The Boise outpatient methamphetamine clinic is a 16-week intensive outpatient program for adults and their families, followed by a 36-week aftercare program based on the Matrix Model.
