Programs/Initiatives

➤ High Intensity Drug Trafficking Area (HIDTA)⁶
Designated in 1997, the Northwest HIDTA is responsible for 14 counties in Washington, including Thurston.

- ➤ Drug-Free Communities Support Program⁷
 Since FY 1998 when funding was first made available through Drug-Free Communities, no coalitions in Olympia have ever received funding.
- Executive Office for Weed and Seed⁸
 There are no Weed and Seed sites in Olympia.
- ➤ Olympia did not receive any funding through the FY 2002 Office of Justice Programs Drug Court Grant Program. 9
- ➤ Olympia did not receive any methamphetamine funding in 2002 from the Department of Justice's Office of Community Oriented Policing Services. ¹⁰

Crime and Drug-Related Crime

- ➤ In April 2001, Olympia law enforcement authorities arrested a hospital administrator who forged more than 80 prescriptions for OxyContin from 1998 through March 2001 for his own use.¹⁴
- ➤ During 2000, there were 3 homicides known to police in Olympia. 15

- ➤ The Olympia Police Department reported 212 driving under the influence offenses in 2000. During 1999, there were 269 such offenses.¹⁶
- ➤ There were 643 adult drug arrests in Thurston County during 2001.¹⁷

Olympia is one of the main Washington cities in which MDMA is readily available and abused by teens and young adults. ¹⁸

Juveniles

➤ During 2001, there were 146 drug arrests in Thurston County involving individuals ages 10-17. ¹⁹

Enforcement

➤ As of October 31, 2001, there were 96 full-time law enforcement employees in Olympia (70 officers and 26 civilians). ²⁰

Trafficking and Seizures

➤ During 2001, approximately 151 methamphetamine labs and dumpsites were reported in Thurston County. ²¹

Courts

➤ Drug Courts²²

As of May 2003, there was one drug court in Olympia that had been operating for more than two years and one drug court that was being planned.

Corrections

- ➤ In 2001, the average daily population at the Thurston County Correctional Facility was 462.²³
- ➤ Substance abuse programs available at the Thurston County Correctional Facility include: ²⁴
 - Alcohol Anonymous (AA)/Narcotics Anonymous (NA): The AA/NA group meets for one hour each week and is available to inmates who request participation in a 12-step support group.
 - Chemical Dependency Program: This program provides a structured, monitored and supportive therapeutic environment using Moral Recognition Therapy as the primary treatment modality.

Consequences of Use

- ➤ During 2001, there were 3 methamphetamine-related events in Thurston County that were collected in the Hazardous Substances Emergency Events Surveillance database. There was 1 injury associated with the methamphetamine-related events.²⁵
- ➤ During 2001, there were 84 alcohol- or drug-related deaths in Thurston County. ²⁶

Treatment

- ➤ In the fall of 2002, a private, non-profit clinic opened in Thurston County offering methadone maintenance. ²⁷
- ➤ During FY 2001, there were 265 adult admissions to treatment in Thurston County with methamphetamine as the primary drug of abuse. ²⁸
