The Community Health Awareness Group established the Life Points Outreach Program on World AIDS Day in 1996. As the first licensed needle exchange program in Detroit, Life Points aims to reduce the spread of HIV among injection drug users by providing sterile needles and syringes as well as HIV risk education and counseling in five locations. Life Points also refers injection drug users to drug treatment and works to reduce the number of needles and syringes discarded in public places.

➤ During 2000, the Detroit Police Department reported 9,301 drug arrests.¹⁷ This number decreased to 7,540 drug arrests during 2001¹⁸ and 6,368 drug arrests during 2002.¹⁹

➤ During 2001, approximately 64% of adult male arrestees in Detroit tested positive for drugs at arrest. ²¹

Approximately 15% of Detroit adult male arrestees reported using crack cocaine within the past month. Among the arrestees reporting past month crack cocaine use, they used the substance an average of 9.5 days within the month.²²

Drugs

➤ In exchange for drugs, some people ("hitters") inject other users who have hard to find veins.²³

Cocaine

Detroit officials report that crack cocaine is the most widely used illicit drug in the city. Crack and powder cocaine users tend to be over the age of 30, black or white, and of low socioeconomic status. Powder cocaine dealers are often involved in nonviolent crimes such as robbery, larceny, and breaking and entering. Crack cocaine dealers tend to be involved in prostitution, gang-related activity, and violent and nonviolent crimes. One gram of powder cocaine usually sells for \$75-\$125. A rock of crack cocaine sells for \$10, although prices can range from \$50-\$200.

> Heroin

Nearly all of the heroin available in Detroit/Wayne County is white in color and originates in Colombia. However, the availability of Southeast and Southwest Asian heroin is increasing. Heroin users in Detroit are typically male, over the age of 30, black, and of low socioeconomic status. Packets of heroin are most often sold in \$10 units and bundles of ten hits cost between \$100-\$200. One gram of Colombian heroin typically costs \$100-\$150. Most of the Detroit heroin users are over the age of 30 and reside in the central city, although use in the suburbs is increasing. Quinine is a new heroin adulterant that is used to increase the heroin "rush."

> Marijuana

Mexican marijuana is the most common form found in Detroit/Wayne County, although the availability of marijuana from Canada is increasing. Marijuana users in Detroit are typically adolescents or young adults and are predominately male. A bag of marijuana sells for \$10 in Detroit and a pound sells for \$750-\$3,000. Marijuana dealers tend to be either young adults (18-30 years old) or older adults (over 30 years).

> Methamphetamine

Methamphetamine is reported as an emerging/intensifying problem in Detroit although use is not as prevalent as it is in western Michigan. Users tend to be young, white adults living in suburban and rural areas.³¹ A gram of meth costs \$100.³² An ounce of methamphetamine sells for \$500-\$2,000 with a purity range of 20-25%.³³

Club Drugs

GHB demand has declined in Detroit. MDMA users are typically white, young adults from middle to upper socioeconomic classes. The price for an MDMA pill in Detroit ranges from \$20 to \$40. 34 Rohypnol is "somewhat available" in Detroit. Liquid GHB is frequently packaged in plastic bottles. The liquid form of ketamine is injected and is sometimes mixed with marijuana. 35

Other Drugs

Juveniles

Approximately 22% of Detroit high school students surveyed in 2003 reported being current users of marijuana.³⁹

- ➤ During 2003, 6.3% of Detroit high school seniors reported using marijuana on school property within the past month, compared to 9.4% of 9th graders, 8.4% of 10th graders, and 7.2% of 11th graders. 40
- ➤ During 2003, 34.5% of high school seniors in Detroit reported being offered, sold, or given an illegal drug on school property within the past year compared to 32.9% of 9th graders, 37.1% of 10th graders, and 31% of 11th graders.⁴¹
- ➤ During 2003, over 49% of Detroit 12th graders reported using marijuana at least once during their lifetimes. 42

Enforcement

As of October 31, 2002, there were 4,656 full time law enforcement employees working in Detroit (4,006 officers and 650 civilians).⁴³

Trafficking and Seizures

- ➤ Detroit serves as the transshipment point for heroin to be distributed to other communities in Michigan. 44
- Detroit gangs control a number of distribution points and are major cocaine suppliers to many markets. 45
- Some Detroit cocaine traffickers are now dealing with smaller quantities due to the implementation of harsher sentences for trafficking larger amounts of the drug.⁴⁶
- ➤ In Detroit, ½ kilograms of methamphetamine was recently seized, indicating that the drug is being shipped from western states into the Detroit area and increasing methamphetamine availability.⁴⁷
- The majority of marijuana seized in Detroit originates in Mexico.⁴⁸
- ➤ The number of small, local methamphetamine labs seized in the Detroit increased during 2001.⁴⁹

Courts

➤ Drug Courts⁵⁰

As of May 2004, there was 1 drug court in Detroit that has been operating for over 2 years and 3 drug courts that had recently been implemented. There are no additional drug courts being planned in Detroit.

Consequences of Use

➤ During 2002, there were 20,979 drug-related episodes reported by emergency departments (ED) in Detroit. Cocaine was mentioned in more than 7,000 of the Detroit ED episodes during 2002.⁵¹

[➤] During 2002, there were 528 drug-related deaths reported by Medical Examiners (ME) in Wayne County. Cocaine was mentioned in 218 of the deaths.⁵²

- ➤ During 2003, the Detroit Poison Control Center identified 4 case involving "foxy," a hallucinogenic tryptamine, all involving young white males.⁵⁴
- ➤ As of July 2001, 55% of Michigan's total AIDS cases originated in Detroit/Wayne County. Injection drug use accounted for approximately 30% of the AIDS cases. ⁵⁵

Treatment

- ➤ Cocaine, including crack, was the primary drug in 28% of all treatment admission in Detroit/ Wayne County during FY 2003.⁵⁶
- ➤ During FY 2003, heroin was the primary drug admission for 29% of all treatment admission in Detroit/Wayne County.⁵⁷
- ➤ During FY 2003, there were 405 primary other opiate treatment admissions in Detroit/Wayne County. All other opiate admission (primary, secondary, or tertiary) represented 6% of treatment admissions. ⁵⁸
- ➤ During FY 2003, there were 1,401 primary treatment admissions for marijuana in Detroit/Wayne County. Marijuana admissions (primary, secondary, or tertiary) represented 29% of treatment admissions during FY 2003.⁵⁹
- ➤ In Detroit/Wayne County during FY 2003, there were 505 primary treatment admissions for methamphetamine. ⁶⁰
- ➤ During FY 2003, there were 364 treatment admissions involving depressants in Detroit/Wayne County. ⁶¹
- ➤ There were 45 primary treatment admissions in Detroit/Wayne County for hallucinogens, four of which involved PCP. ⁶²
- ➤ During FY 2003, there were 69 treatment admissions involving ecstasy in Detroit/Wayne County, compared to 31 during FY 2002.⁶³
- Approximately 8% (8.2%) of adult male arrestees in Detroit in 2001 reported that they have received treatment in the year before being arrested.⁶⁴
