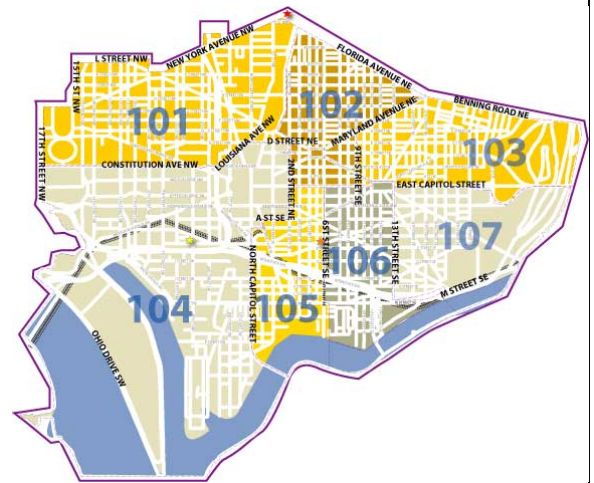

SUMMARY OF RECENT COURT CASES

- **Paul DuBois** sentenced to six years incarceration and three years supervised release, following convictions by Superior Court jury on charges of Arson, Felony Destruction of Property, Obstruction of Justice, and Second Degree Burglary, in connection with fire at Marina View Towers, 1000 6th Street, S.W.
- **Chaz Franklin**, age 16, under Title 16, which allows juvenile defendants charged with armed crimes of violence to be prosecuted as adults; is sentenced to a total of 10 years incarceration, and five years of supervised release, on three counts of Armed Robbery.
- **Zachary Henderson** is sentenced to six years incarceration for Armed Robbery of a convenience store in S.E. Washington, D.C.
- Off-duty MPD officer sentenced to 15 days incarceration following conviction by the Honorable Zinora Mitchell-Rankin of Simple Assault of patron at the MCI Center.
- **Richard Jones** sentenced to one year of incarceration and 3 years supervised release for Assault with a Dangerous Weapon.

THE COURT REPORT

Paul DuBois sentenced to six years incarceration and three years supervised release, following convictions by Superior Court jury on charges of Arson, Felony Destruction of Property, Obstruction of Justice, and Second Degree Burglary, in connection with fire at Marina View Towers, 1000 6th Street, S.W. (Case No. F4505-03; PSA 104)

FACTS: Paul DuBois, age 59, was sentenced by the Honorable Wendell Gardner to a combined sentence of six years incarceration, with three years of supervised release, following his conviction by a Superior Court jury on charges of Arson, Felony Destruction of Property, Obstruction of Justice, and Second Degree Burglary, in connection with a fire on July 23, 2003, at the Marina View Towers Apartment Complex, 1000 6th Street, S.W., where Mr. DuBois resided.

According to the government's evidence at trial, Mr. DuBois was a resident of an apartment on the 4th floor of the Marina View Towers Apartments, Building 1000. On July 23, 2003, building 1000 of the Marina View Towers was set on fire. Investigation revealed that the fire had been started with an accelerant (gas), and that the hallway in front of defendant's apartment, apartment 404, had the most damage. There were also four plastic juice containers on the scene – three in the hallway, and one in the stairwell. These containers were partially filled with gasoline – and still had their labels of Safeway brand Blossom Time juice, and the flavors were three grape, and one iced tea. Investigators observed that there was a distinctive pour pattern on the threshold carpet in front of Apartment 404, and determined that this area was the origin of the fire. After the fire, several witnesses reported that the defendant smelled strongly of gasoline, and he was found lying on the concrete area outside the apartment building wearing only his underwear (T-shirt and shorts), no shoes. He was the only building occupant to have been injured in the fire. A pair of men's pants and shoes with gasoline were found in the hallway near the area where the fire originated, and in the defendant's apartment there was also a pair of Levi's Jeans which had been custom made for him, also containing gasoline. The defendant was \$8000 in arrears on his rent, and eviction proceedings were pending. While in jail awaiting trial, the defendant tried to enlist the assistance of another inmate to set another fire at the Marina View Apartment Complex, in order to deflect suspicion from himself. Further, an analysis of the defendant's Safeway purchases revealed that five days before the fire, the defendant had purchased Safeway brand Blossom Time juice – three grapes, and one iced tea – just like the ones found at the scene of the fire.

This outcome was the result of thorough and detailed work by personnel of the District of Columbia Fire Department and the Joint Arson Task Force, including Fire Department Investigators Gregory Bowyer, Alan Lancaster, Wesley Hamilton, Aaron Hazel, John Curry, Gerald Pennington, Eugene Marshall and Sergeant Phillip Proctor; ATF Special Agents Lisa Green and Scott Fulkerson; and MPD detectives Sandy Urps, Frank Molino, Oscar Mouton and Drew Smith. Also to be commended are U.S. Attorney's Office Investigator Michael Evans, Legal Assistant Mary Doster, Paralegal Sandra Lane, and Assistant United States Attorneys Roger Kemp, who assisted, and Wanda J. Dixon, who investigated and tried the case.

Chaz Franklin sentenced to a total of 10 years incarceration, and five years of supervised release, on three counts of Armed Robbery. Franklin, age 16, had been charged as an adult under Title 16, which allows juvenile defendants charged with armed crimes of violence to be prosecuted as adults. (Case No. F-452-04; PSA 106)

FACTS: Chaz Franklin, age 16, was sentenced by the Honorable Susan Winfield, on three counts of Armed Robbery, to a total of 10 years of incarceration, to be followed by five years of supervised release. Franklin, and his three co-defendants aged 16 and 17, were part of a crew of over 20 youths (aged 12 to 17) from Potomac Gardens, believed to have been responsible for approximately 70 robberies and assaults in Southeast beginning in 2003.

Franklin was responsible for a June 19, 2003 robbery of a couple in the 1100 block of South Carolina Avenue, S.E. On this occasion, Franklin approached them, said “excuse me” and pulled out a gun and demanded their wallets. After obtaining their wallets, Franklin, and two of his codefendants fled the scene.

On another occasion, Franklin and other youths committed a robbery inside a Chinese food restaurant on Pennsylvania Avenue, S.E. A woman entered the store and was surrounded by a group of youths, led by Franklin. One of the youths asked her for a dollar. When she did not give him one, Franklin pulled out a handgun and demanded her wallet. She gave him her wallet and they all fled the scene.

The case was broken when two of Franklin’s codefendants were apprehended after a high-speed chase into Prince George’s County, following a robbery on October 28, 2003. A BB or pellet gun was recovered at that time. Later the third codefendant was arrested, and eventually Franklin was arrested as well.

First District Detective William Riddle, along with Officers Tate and Bowman, also of the First District, investigated these Title 16 cases, as well as numerous companion juvenile cases being prosecuted by the Office of the Attorney General for the District of Columbia. Assistant United States Attorney Brittain McInnis prosecuted the case.

Zachary Henderson sentenced to six years incarceration for Armed Robbery of a convenience store in S.E. Washington, D.C. (F-7261-03; PSA 207)

FACTS: Zachary Henderson, age 26, of the 1200 blk of 1st Street, S.W., Washington, D.C. was sentenced to six years incarceration for Armed Robbery by the Honorable Susan Winfield. The armed robbery occurred at a convenience store on November 20, 2003 at 3rd & K Streets, SE. The incident was captured on videotape by a security camera, resulting in clear photographs and a videotape of the defendant committing the crime.

Defendant Henderson escaped with an undetermined amount of cash, but was later arrested wearing the same clothes, visible on the videotape, that he wore during the robbery. The police had received a tip, as to where the defendant could be found.

This case was investigated by 1D detectives Robbie Saunders and Stanley Greene, and investigated and prosecuted, and the plea and sentence obtained, by Assistant U.S. Attorney Roger Kemp.

Richard Jones sentenced to one year of incarceration and 3 years supervised release for Assault with a Dangerous Weapon. (Case No. F-7683-03; PSA 105)

FACTS: On August 3, 2004, the Honorable Susan Winfield sentenced Richard Jones to three years incarceration, execution of all but one year suspended, and three years supervised release, following Jones' June 8, 2004 guilty plea to Assault with a Dangerous Weapon. Judge Winfield also ordered the defendant to obtain alcohol treatment. The victim in the case, Ray Wilson, was stabbed and beaten on September 25, 2003, in the 1000 block of 5th Street, S.E. The police investigation revealed that Keith Daniels and the victim were fighting when Richard Jones - Daniels' cousin - stabbed the victim.

The case was investigated by First District detective Robert Saunders, and prosecuted by Assistant United States Attorney John Irving.

Sean Lee sentenced to supervised release following conviction by Superior Court jury of Threats, but acquittal of Aggravated Assault while Armed and related charges. (Case No. F 3206-03; PSA 101)

FACTS: The Honorable Harold Cushenberry sentenced defendant Sean Lee to 20 months incarceration, with the execution of the sentence suspended, and three years supervised release, following his conviction by a Superior Court jury of Threats, but his acquittal of Aggravated Assault while Armed and related charges.

The evidence at trial concerned an incident on June 2, 2003, in the 400 block of K Street N.W., involving two male transgender prostitutes dressed as women. The complaining witness reported that the defendant accosted her, argued with her, and ultimately stabbed her in the thigh and slashed her across the face. The complaining witness and one eyewitness friend of hers testified, along with the arresting officer, and there were photographs of the injuries. However, the complaining witness had consistently described the perpetrator as wearing a black dress, while all of the photographs showed the defendant wearing a beige dress, with no blood on it. The defendant testified, and gave a different account. The jury had a doubt, concerning the majority of the charges.

The case was prosecuted by Assistant United States Attorney Catharine Hartzenbusch.

Off-duty MPD officer sentenced to 15 days incarceration following conviction by the Honorable Zinora Mitchell-Rankin of Simple Assault of patron at the MCI Center. (PSA 101)

FACTS: Marjorie Temple, 28, a Metropolitan Police Department Officer assigned to the Third District, was convicted in a bench trial, by Superior Court Judge Zinora Mitchell-Rankin, of Simple Assault of a civilian during a performance at the MCI Center. Temple was sentenced to 180 days of imprisonment, with the execution of all but 15 days suspended, and was placed on probation for two years. As part of her probation, Temple was ordered to attend an anger management class.

The evidence at trial established that on February 15, 2004, Temple and several other individuals arrived late to a performance of Disney on Ice at the MCI Center. As Temple and her party were walking to their seats, Temple encountered the 37-year-old victim, who was already seated and watching the performance with her four-year-old daughter. When the victim stood up to allow Temple and her party to pass to their seats, Temple and the victim had a short conversation, after which Temple shoved the victim back in her chair and began punching her in her head and face. The victim attempted to shield herself and her child from the blows by holding one arm over her face and her other arm over her child. Several other members of the audience who came to the victim's aid eventually pulled Temple off of the victim. The victim suffered swelling on her face as well as scratches and a welt on her back.

The case was prosecuted by Assistant United States Attorneys Nihar Mohanty, Robert Leidenheimer, and Alessio D. Evangelista.

Community Prosecutor for the First District

The Community Prosecutor for the First District is Kathy Worthington. Over the past several months, Kathy has worked closely with the D.C. Housing Authority to ensure that DCHA receives timely notification of the arrests of all individuals who reside in public housing and is informed of all Court orders requiring non-public housing residents to stay away from such premises. It is hoped that these efforts will make the premises safer for both public housing residents and the adjacent neighborhoods.

Community Outreach Specialist for the First District

Theresa A. Jackson is the newly assigned Community Outreach Specialist for the United States Attorney's Office assigned to the First District. Ms. Jackson will be working with Community Prosecutors, the Metropolitan Police Department, District of Columbia government agencies and the community to identify and address public safety and quality of life problems and concerns.
