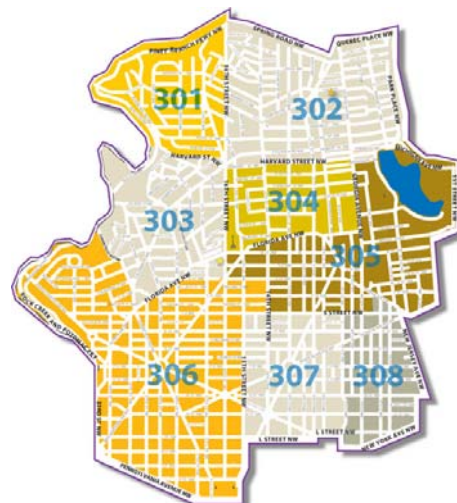

SUMMARY OF RECENT COURT CASES

- District of Columbia Metropolitan Police Department Officer, **Barron Brown**, 45, of the 200 block of Missouri Avenue, N.W., Washington, D.C., was found guilty of simple assault, in connection with the May 27, 2000, assault with a dangerous weapon of a civilian at 13th & N Streets, N.W., Washington, D.C. Brown is scheduled for sentencing on September 27, 2004, before the Honorable Maurice A. Ross.
- **Dwayne Gaffney**, was sentenced to incarceration after having been convicted of perjury involving a D. C. Superior Court grand jury investigation of an April 1, 2003 homicide. Dwayne L. Gaffney, also known as Dwayne L. Gaffney, 23, of the 2400 block of Elvans Road, S.E., sentenced to eighteen months in prison followed by three years of supervised release by Superior Court Judge Thomas J. Motley on July 22, 2004.
- 4 Other defendants were convicted or pled guilty in a number of firearms-related cases under the Project Safe Neighborhoods initiative.

A detailed descriptions of these and other cases from the 3rd District are provided inside of this report.

3RD DISTRICT COMMUNITY PROSECUTION UPDATE



A big part of Community Prosecution is the partnerships we develop with not only the community but also other government entities. These partnerships help all the agencies involved better serve the public. The U.S. Attorney's Office Community Prosecution team has forged a strong partnership with the Alcoholic Beverage Regulatory Administration (ABRA) to fight criminal activity occurring in establishments that have a license to sell alcohol. As part of this newly forged partnership, ABRA officials meet monthly with the Community Prosecution team and attorneys from the Attorney General's Office to discuss problem establishments. Joint strategies are formulated to bring these problem establishments into compliance. In addition, your Community Prosecution team monitors hearings before the ABC Board and provides the ABRA investigators and AG Office attorneys with any additional information they may need to successfully prosecute rogue establishments. This is just one of many examples of how Community prosecution works for you, the citizens of the District of Columbia. THE COURT REPORT

District of Columbia Metropolitan Police Department Officer convicted of simple assault. On July 15, 2004, Barron Brown, 45, of the 200 block of Missouri Avenue, N.W., Washington, D.C., a police officer with the District of Columbia Metropolitan Police Department, was found guilty today by a Superior Court jury of simple assault, in connection with the May 27, 2000, assault with a dangerous weapon of a civilian at 13th & N Streets, N.W., Washington, D.C. (PSA 310). Brown is scheduled for sentencing on September 27, 2004, before the Honorable Maurice A. Ross and faces a possible maximum prison sentence of 180 days (Case No. F-7464-03; PSA 310).

FACTS: The government's evidence at trial showed that on May 27, 2000, at approximately 2:55 a.m., defendant Brown was driving his personal Suburban truck and waiting at a traffic light at the corner of 13th & N Streets, N.W. As the complainant turned that corner heading into an Amoco gas station, the defendant stared really hard and mean at the complainant and the complainant stared hard back at the defendant. The complainant decided to drive a little distance past the gas pumps and stopped his car when he noticed that the defendant had backed up his truck into the gas station and had parked. The defendant, who was off-duty and dressed in plain clothes, got out of his truck and approached the complainant's driver's side door. The defendant cursed at the complainant while he was sitting in his car wanting to know why he was staring at him. The defendant then pulled out from his waistband a black handgun, at close range pointed it at the complainant's face, and forcefully shoved the barrel of that gun into the complainant's left cheek. The defendant continued to curse at the complainant and said "all I have to do is pull the trigger." The complainant, in an effort to distract the defendant, said "there's a cop coming." To the complainant's surprise the defendant said "I'm a cop mfer." The complainant begged a couple of times for permission to leave and the defendant replied that he would tell the complainant when he could leave. Shortly thereafter the defendant said that the complainant could go. The defendant returned to his personal truck and drove away.

The complainant, suffering from a bleeding cut to his left cheek, followed the defendant's truck and obtained his license tag number. Within a few minutes thereafter the complainant flagged down an on-duty Metropolitan Police Department officer, reported this crime, the license tag number of the suspect's Suburban truck and a description of the suspect. Further investigation that morning by the police officer and a few days later by a detective revealed that the license tag number and Suburban truck were registered to and owned by Barron Brown. Less than one week after this incident, the defendant admitted to a detective that he was involved in an altercation with the complainant at the gas station at 13th & N Streets on May 27, 2000, that he had his gun and had hit the complainant. The defendant then informed the detective that he was a police officer. Approximately two weeks after this incident the defendant also admitted to another member of the Metropolitan Police Department that he had a verbal altercation with the victim, that the defendant had backed up his truck into the gas station, cursed at the complainant, pulled his gun, bent over, and it was "on" for 3 minutes. The defendant further bragged that the Internal Affairs Division could not locate the complainant.

Assistant United States Attorney Karla-Dee Clark investigated, indicted and prosecuted the case.

Dewayne Gaffney was sentenced to incarceration after having been convicted of perjury involving a D.C. Superior Court grand jury investigation of an April 1, 2003 homicide. Dewayne L. Gaffney, also known as Dwayne L. Gaffney, 23, of the 2400 block of Elvans Road Street, S.E., sentenced to eighteen months in prison followed by three years of supervised release by Superior Court Judge Thomas J. Motley on July 22, 2004. During the sentencing hearing, Judge Motley stressed the importance of witness truthfulness in the criminal justice system. Gaffney was convicted on May 19, 2004 by A D.C. Superior Court jury of making false statements that were material to a D.C. Superior Court grand jury's investigation into an April 1, 2003 homicide (Case No. F-470-04; PSA 312).

FACTS: The government's evidence at trial showed that on April 1, 2003, Michael Taylor was shot and killed in the area of 1st and R Streets, N.W., Washington, D.C. A police investigation revealed that the motive for the murder was a home invasion and robbery of a target's girlfriend the day before the killing. The target learned that Michael Taylor was possibly one of the two armed robbers that had taken his money. A D.C. Superior Court grand jury began investigating the circumstances of the murder.

During the course of the investigation, two witnesses disclosed that they had each had a conversation with the defendant. The defendant told them that the named target in the homicide had offered money to kill one of the witnesses because the target believed that the witness might have been involved with the robbery, along with Michael Taylor. The grand jury issued a subpoena directing the defendant to appear and give testimony regarding the homicide.

On December 19, 2003, the defendant testified under oath in front of the grand jury. The defendant denied knowing the target and ever having any conversation about the murder or the robbery. The defendant also denied having any conversation with the witnesses about the above subjects.

AUSA Denise Cheung prosecuted the case, and the work of Detective Anthony Brigidini was crucial to the successful investigation and prosecution of the case.



DEFENDANTS WHO WERE CONVICTED IN FIREARMS CASES

Under the Project Safe Neighborhoods (PSN) initiative, 9 persons were convicted of firearms offenses in July 2004. PSN is a partnership between local and federal agencies to reduce gun violence in the District of Columbia. The following is a list of offenses that occurred in this district:

John Rice was sentenced to 20 months incarceration (entirely suspended) and 2 years of supervised probation by Judge Cushenberry, on July 6, 2004, following a conviction on the charge of Carrying a Pistol Without a License (CPWL) and Unregistered Firearms. Rice was initially arrested on December 7, 2003, at 61 Seaton Place, N.W. (PSA 303)

Darian R. McGriggs was sentenced to 2 years incarceration (entirely suspended), and 2 years of supervised probation under the Youth Rehabilitation Act Probation by Judge Diaz, on June 28, 2004, following his guilty plea to the charge of Carrying a Pistol Without a License (CPWL). McGriggs was initially arrested on February 20, 2004, in the rear of the 1700 block of 8th Street, N.W. (PSA 308)

Joe E. Johnson was sentenced to 3 years incarceration (entirely suspended), and 2 years of supervised probation by Judge Canan, on July 15, 2004, following his guilty plea to the charge of Carrying a Pistol Without a License (CPWL), Unregistered Firearms, and Unlawful Possession of Ammunition. Johnson was initially arrested on January 8, 2004, on route 295 north, Blue Plains. (PSA 101)

Keith C. Crockett was sentenced to 1year incarceration (entirely suspended), and 1 year of supervised probation by Judge Leibovitz, on July 16, 2004, following his guilty plea to the charge of Carrying a Pistol Without a License (CPWL) and Unregistered Firearms. Crockett was initially arrested on October 31, 2001, at 24th & O Streets, S.E. (PSA 105)
