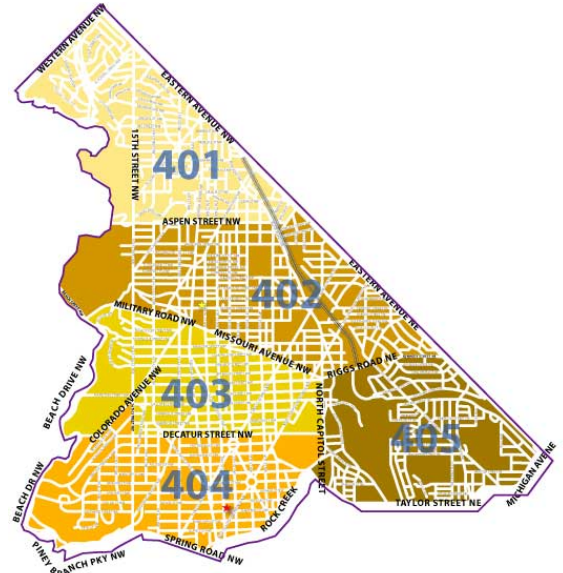

SUMMARY OF RECENT COURT CASES

- **Timothy Smith** was sentenced to Assault with Intent to Kill while Armed and other related offenses and co-defendant, **Dewayne Richardson**, was sentenced to Assault with a Dangerous Weapon and other related offenses before the Honorable Erik Christian.
- **Jon Robinson and Dyandra Demoraïs** were sentenced to Second Degree Murder while Armed before the Honorable Patricia A. Broderick.
- **Joseph Hilliard** was sentenced to Second Degree Murder while Armed (Knife) before the Honorable John H. Bayly.
- 18 other defendants were convicted or pled guilty and were sentenced in a number of separate drug cases.

A detailed descriptions of these and other cases from the 4th District are provided inside of this report.

4TH DISTRICT COMMUNITY PROSECUTION UPDATE

THE COURT REPORT

Timothy Smith was sentenced to Assault with Intent to Kill while Armed and other related offenses and co-defendant, Dewayne Richardson, was sentenced to Assault with a Dangerous Weapon and other related offenses before the Honorable Erik Christian. (PSA 407; Case Nos. F-3134-03 and F-5186-03)

On July 28, 2004, Timothy Smith, age 36, of Washington, DC, was sentenced to a total of 36 years incarceration for Assault with Intent to Kill while Armed, Armed Robbery, Mayhem while Armed and Aggravated Assault while Armed, as well as Carrying a Dangerous Weapon and Dewayne Richardson, age 42, of Washington, DC, was sentenced to a total of 30 years incarceration for Assault with a Dangerous Weapon, Robbery, Mayhem while Armed, and Aggravated Assault while Armed by the Honorable Erik Christian.

FACTS: On May 10, 2004, Timothy Smith, age 36, of 4209 Illinois Avenue, NW, Washington, DC was found guilty by a jury of the Superior Court of the District of Columbia of Assault with Intent to Kill while Armed, Mayhem while Armed, Armed Robbery, Aggravated Assault while Armed, and Carrying a Dangerous Weapon for his role in the May 14, 2003, robbery and stabbing of a District of Columbia man. On May 11, 2003, his co-defendant, Dewayne Richardson, age 42, of 4108 5th Street, NW, Washington, DC, was also found guilty by the same jury of Robbery, Mayhem while Armed, Aggravated Assault while Armed, and Assault with a Dangerous Weapon.

According to the government's evidence at trial, defendant Smith lured the complainant to his home under the guise of wanting to sell him jewelry. Upon the complainant driving up into the 4200 block of Illinois Avenue, NW, both defendants got inside the complainant's car. Defendant Smith sat in the front passenger seat and defendant Dewayne Richardson in the back passenger seat. When the complainant turned to defendant Smith to see the jewelry he had for sell, defendant Smith pulled out a knife and robbed the complainant of his jewelry and money. The armed robbery quickly turned into a brutal assault when defendant Richardson told defendant Smith to stab and kill the complainant. Initially, defendant Smith stabbed the complainant in the neck. As the complainant struggled to getaway, defendant Richardson held the back of the complainant's shirt attempting to prevent him from leaving. While defendant Richardson held the complainant, defendant Smith stabbed the complainant six times in the chest. Miraculously, the complainant was able to escape from the car and into an intersection where he was helped by several good Samaritans. The complainant survived his injuries and provided police information that led to the arrest of both defendants.

Assistant United States Attorney Michelle Jackson investigated the case and represented the case at trial and sentencing.

Jon Robinson and Dyandra Demorais were sentenced to Second Degree Murder while Armed before the Honorable Patricia A. Broderick. (PSA 401, Case Nos. F-00289-04 and F-00290-04).

On July 16, 2004, Jon Robinson, age 27, of the 1400 block of Floral Street, N.W., Washington, D.C., was sentenced to 20 years incarceration in connection with his guilty plea to

Second Degree Murder While Armed and Dyandra Demorais, age 17, of the 900 block of Farragut Street, N.W. was sentenced to 13 years incarceration in connection with her guilty plea to Second Degree Murder While Armed. The murder was committed during the commission of a robbery on January 11, 2004, at the Motel Six located in the 6700 block of Georgia Avenue, N.W.

FACTS: According to the government's evidence, on January 11, 2004, at approximately 5:00 p.m., the decedent met the defendant's girlfriend, Dyandra Demorais, who agreed to accompany him to a local motel in the area. When Demorais and the decedent arrived at the motel, they obtained a room using his credit card. Co-Defendant Demorais secretly called her boyfriend, defendant Jon Robinson, and told him that she was at the motel with the defendant. She then told defendant Robinson that she wanted to rob the decedent and asked for his assistance.

Shortly thereafter, the decedent went to the desk clerk inquiring about the availability of prophylactics. The clerk told him that none were available at the motel, but could be purchased at the store near by. Co-defendant Demorais and the decedent then left the motel. As they exited the motel, defendant Robinson, entered and had a brief conversation with co-defendant Demorais. During this conversation, co-defendant Demorais gave the room key to defendant Robinson, who went to the second floor of the motel to wait for co-defendant Demorais to return with the decedent.

When the decedent and co-defendant Demorais returned to the motel, the clerk, who had observed co-defendant Demorais give the room key to defendant Robinson, tried to warn the decedent that he thought the two intended to rob him. However, the decedent continued to the second floor where he was met by defendant Robinson who was armed with a handgun. Defendant Robinson demanded that decedent give him all his property and eventually shot him. Co-defendant Demorais then removed all his property, including his credit card as he lay dying from a gunshot wound to the stomach.

After taking the property from the decedent, co-defendant Demorais used his credit card to buy gifts for her friends and attempted to obtain a pin number from the credit card company. Co-defendant Demorais bragged to others about her involvement in the robbery and shooting. The decedent's property was recovered from the room occupied by co-defendant Demorais as well as the purchases made by co-defendant Demorais using the decedent's credit card.

Assistant United States Attorney Teresa Howie investigated the case and represented the government at sentencing.

Joseph Hilliard was sentenced to Second Degree Murder while Armed (Knife) before the Honorable John H. Bayly. (PSA 403, F-224-03)

FACT: On July 9, 2004, Joseph Hilliard, age 62, of Washington, D.C. was sentenced to 15 years incarceration for Second Degree Murder while Armed (knife). According to the government's evidence at the plea hearing, on or about December 12, 2002, while inside 619 Kennedy Street, NW., during the morning hours, the defendant was evicted from the basement

apartment by the son of the owner of 619 Kennedy Street, with the assistance of the decedent. At approximately 11:30 p.m. that night, the defendant told a witness if he could not live in that basement, nobody would, and that he would kill whomever he found in the basement. At approximately 6:00 a.m., a witness saw the defendant inside 619 Kennedy Street, NW, coming from the basement toward the kitchen. That witness noted that the defendant had what appeared to be blood on his face and clothes. The witness saw the defendant leave the house through the rear door.

On December 13, 2002, at approximately 8:15 a.m., employees of the owner of the house located at 619 Kennedy Street, NW, discovered the decedent's body, wrapped in a tarp, placed beneath the rear of a company truck, which was parked behind 619 Kennedy Street. They alerted the owner, who contacted the Metropolitan Police Department. Officers arrived to find the decedent, with his throat cut, numerous stab wounds and incisions to his left arm, among other things. Officers noted a blood trail between the driveway in the rear of 619 Kennedy and the rear porch of that house.

During the execution of a warrant authorizing the search of 619 Kennedy Street, evidence technicians lifted bloody fingerprints from the basement staircase banister. A fingerprint examiner identified those prints as belonging to the defendant. On December 16, 2002, police questioned the defendant, who told them that he was still wearing the clothes he was wearing when evicted. Those clothes were sent to the FBI Laboratory, where a DNA analyst determined that blood on the defendant's pants was that of the decedent.

Former AUSA Diana Harris Epps indicted the case and AUSA Gary Wheeler negotiated the plea and represented the government at sentencing.



DEFENDANTS WHO WERE CONVICTED OR PLED GUILTY AND WERE SENTENCED IN A NUMBER OF DRUG CASES

Christopher M. Reid, of the 1800 block of Redwood Terrace, N.W., was sentenced to 15 months confinement and three years probation by Judge Harold H. Cushenberry on July 8, 2004, following a guilty plea on September 23, 2002, to Attempted Distribution of Cocaine. **Reid** was arrested on June 15, 2002, in the 7700 block of Georgia Avenue, N.W. (PSA 401).

Alex Anderson, of the 2500 block of 17th Street, N.W., was sentenced to 14 months confinement (six months suspended) and three years probation by Judge Gerald I. Fisher on July 16, 2004, following a guilty plea on April 15, 2004, to Attempted Distribution of Cocaine. **Anderson** was arrested on January 12, 2004, in the unit block of Fourth Street, N.W. (PSA 402).

Sonja L. Malloy, of the 800 block of Kennedy Street, N.W., was sentenced to 18 months confinement by Judge Judith Retchin on July 9, 2004, following a guilty plea on April 27, 2004, to Attempted Distribution of Cocaine. **Malloy** was arrested on March 14, 2004, in the 600 block of Morton Street, N.W. (PSA 402).

Heredia Roger, of the 5800 block of 14th Street, N.W., was sentenced to three years confinement by Judge Erik P. Christian on July 16, 2004, following a guilty plea on May 5, 2004, to Attempted Distribution of Cocaine. **Roger** was arrested on March 14, 2004, in the 1400 block of Park Road, N.W. (PSA 402).

Omar T. Lyons, of no fixed address, was sentenced to 60 months confinement (54 months suspended) and 18 months probation by Judge Thomas J. Motley on July 8, 2004, following a guilty plea on April 23, 2004, to Attempted Distribution of Cocaine. **Lyons** was arrested on March 17, 2004, in the unit block of Gallatin Street, N.W. (PSA 403).

Darryl W. Freeman, of the 4600 block of 8th Street, N.W., was sentenced to 36 months confinement (entirely suspended) and five years probation by Judge Gerald I. Fisher on July 21, 2004, following a guilty plea on December 23, 2002, to Attempted Distribution of Cocaine. **Freeman** was arrested on August 15, 2002, in the 5400 block of 5th Street, N.W. (PSA 403).

Christopher B. Paul, of the 4600 block of 8th Street, N.W., was sentenced to 180 days confinement and five years probation by Judge Zinora A. Rankin-Mitchell on July 21, 2004, following a guilty plea on December 23, 2002, to Distribution of Cocaine. **Paul** was arrested on August 15, 2002, in the 900 block of Decatur Street, N.W. (PSA 406).

Michael A. Payne, of the 6800 block of Eastern Avenue, N.E., was sentenced to two years confinement (18 months suspended) and 18 months probation by Judge Lynn Leibovitz on July 22, 2004, following a guilty plea on March 25, 2004, to Attempted Distribution of Marijuana. **Payne** was arrested on February 5, 2004, in the 300 block of Emerson Street, N.W. (PSA 407).

Gerrod D. Woody, of the 1200 block of 5th Street, N.W., was sentenced to 180 days confinement (entirely suspended) and two years probation by Judge Russell F. Canan on July 8, 2004, following a guilty plea on January 21, 2004, to Possession of Cocaine. **Woody** was arrested on June 23, 2003, in the unit block of Ingram Street, N.W. (PSA 408).

Demetrius Pate, of the 3800 block of 8th Street, N.W., was sentenced to 18 months confinement (entirely suspended) and two years probation by Judge Lynn Leibovitz on July 9, 2004, following a guilty plea on May 20, 2004, to Attempted Distribution of Cocaine. **Pate** was arrested on February 10, 2004, in the 3800 block of New Hampshire Avenue, N.W. (PSA 409).

Darryl J. Wilson, of the 2900 block of Harvard Street, N.W., was sentenced to 36 months confinement and two years probation by Judge John H. Bayly on July 20, 2004, following a guilty plea on October 2, 2002, to Attempted Distribution of Cocaine. **Wilson** was arrested on August 1, 2002, in the 3100 block of 16th Street, N.W. (PSA 412).

Daniel Pleitez, of the 1400 block of Columbia Road, N.W., was sentenced to 90 days confinement and two years probation by Judge Gerald I. Fisher on July 14, 2004, following a guilty plea on November 6, 2002, to Possession of Cocaine. **Pleitez** was arrested on August 27, 2002, in the 3000 block of 15th Street, N.W. (PSA 412).

Darryl J. Wilson, of no fixed address, was sentenced to 36 months confinement, 24 months probation and a \$100 00 fine by Judge John H. Bayly, Jr. on July 20, 2004, following a guilty plea on January 29, 2003, to Attempted Possession of Cocaine. **Wilson** was arrested on October 12, 2002, in the 1500 block of Park Road, N.W. (PSA 412).

John V. Proctor, of the 3000 block of Ontario Road, N.W., was sentenced to 18 months confinement by Judge Judith Retchin on July 8, 2004, following a guilty plea on May 3, 2004, to Attempted Distribution of Cocaine. **Proctor** was arrested on January 7, 2004, in the unit block of Georgia Avenue, N.W. (PSA 414).

Gregory D. Swann, of the 600 block of Morton Street, N.W., was sentenced to time served by Judge Judith Retchin on July 15, 2004, following a guilty plea on February 6, 2004, to Possession of Heroin. **Swann** was arrested on January 30, 2004, in the 3200 block of Sherman Avenue, N.W. (PSA 414).

Robert L. Hunter, of the 1300 block of 7th Street, N.W., was sentenced to 180 days confinement (entirely suspended) and one year probation by Judge Thomas J. Motley on July 23, 2004, following a guilty plea on May 11, 2004, to Attempted Possession of Heroin. **Hunter** was arrested on March 20, 2004, in the 300 block of Emerson Street, N.W. (PSA 414).

Joseph H. Johnson, of the 1400 block of W Street, N.W., was sentenced to 180 days confinement (entirely suspended) and one year probation by Judge Wendell P. Gardner, Jr. on July 26, 2004, following a guilty plea on November 22, 2002, to Attempted Possession with Intent to Distribute Cocaine. **Johnson** was arrested on July 18, 2001, in the 700 block of Columbia Road, N.W. (PSA 414).

Mark P. Lucas, of the 900 block of French Street, N.W., was sentenced to 18 months confinement and 24 months probation by Judge John H. Bayly on June 29, 2004, following a guilty plea on March 26, 2003, to Distribution of Heroin. **Lucas** was arrested on January 25, 2003, in the 700 block of Morton Street, N.W.

In a second matter, **Lucas** was sentenced to two years confinement and 24 months probation by Judge Bayly, also on June 29, 2004, following a guilty plea on June 2, 2003, to Distribution of Heroin. In that case, **Lucas** was arrested on April 2, 2003, in the 700 block of Morton Street, N.W. (PSA 414).
