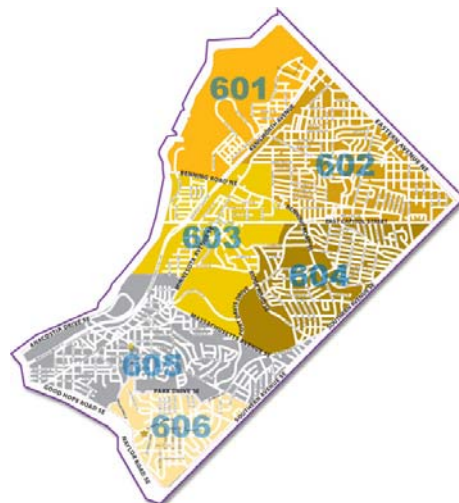

SUMMARY OF RECENT COURT CASES

- **Albert M. Price** Pleads Guilty to Assault with a Dangerous Weapon, Possession of a Prohibited Weapon, Threats and Contempt. Price will be sentenced on September 23, 2004 before the Honorable Erik Christian.
- **Velvet L. Barnes** Pleads Guilty to Attempted Uttering and is sentenced before the Honorable Harold L. Cushenberry.
- Sixteen year old involved in Head-on Collision while driving stolen minivan pleads guilty to Involuntary Manslaughter and Unauthorized Use of a Vehicle. Sentence scheduled for October 15 before the Honorable Robert I. Richter.
- Andrew Williams pleads guilty to Robbery and Assault with a Dangerous Weapon before the Honorable Susan Winfield.
- Leon T. Saunders was sentenced to 15 months incarceration by the Honorable Gerald I. Fisher
- 30 other defendants pled guilty and were sentenced in a number of separate drug cases under the Project Safe Neighborhoods initiative.

The COURT REPORT

Albert M. Price Pleads Guilty to Assault with a Dangerous Weapon, Possession of a Prohibited Weapon, Threats and Contempt (PSA 605; Case Numbers F-3256-04, F-3273-04, and F-3408-04)

On July 7, 2004, Albert M. Price, of Washington, DC, pled guilty, in D.C. Superior Court, to assault with a dangerous weapon, possession of a prohibited weapon, misdemeanor threats, and misdemeanor contempt in four different cases. Price will be sentenced on September 23, 2004, by Superior Court Judge Erik Christian.

According to the government's proffer, on or about May 14, 2004, the defendant entered the home of Jacqueline Foster at 1620 19th Street, S.E., #1, in Washington, DC. Once inside, the defendant grabbed a glass picture frame and slammed it down on a coffee table, causing it to break into a number of pieces. The defendant then picked up a piece of the broken glass and threw it at Ms. Foster, striking her in the hand. Ms. Foster suffered two lacerations to her thumb and index finger as a result of this assault.

On or about May 15, 2004, at approximately 7:45 pm, a Central Cellblock (CCB) employee was ordering food inside the Capitol Seafood Restaurant on Pennsylvania Avenue, S.E., in Washington, DC. The defendant entered the establishment and approached the CCB employee. She recognized the defendant as an individual she had recently processed through Central Cellblock. The defendant stated he was going to shoot the CCB employee and reached into his right side as if he were reaching for a weapon. The CCB employee asked the defendant who had let him out of jail. The defendant again threatened to shoot the CCB employee, and he followed her out of the restaurant. The CCB employee entered her car and left the scene.

On or about May 16, 2004, at approximately 4:50 pm, the defendant was observed at the Dollar Plus Store, located at 2529 Pennsylvania Avenue, S.E., removing several items from the rack, including two t-shirts, four bandannas, and one pair of sunglasses. A store employee approached the defendant, attempted to stop him, and told him not to leave the store before paying for the items that he had taken. The defendant then brandished a pocketknife with a four-inch blade, pointed it at the employee, and stated, "I'll shoot you." The defendant then slashed the rubber mats on the clerk's counter with his knife three times and fled the store with the property.

On or about May 20, 2004, the defendant was found by police in the area of 2104 Minnesota Avenue, S.E., which was within a zone from which the defendant had been ordered by the court to stay away. On or about May 15, 2004, the defendant had been released in case number F-3100-04 and ordered by a DC Superior Court Judge to stay away from the 1600 block of 19th Street, SE, and the 1900 block of Minnesota Avenue, SE, and three blocks in all directions.

AUSAs Ellen Chubin and Kate Connelly prosecuted these cases.

Velvet L. Barnes Pleads Guilty to Attempted Uttering (PSA 603; Case Number F-3049-04)

On June 28, 2004, Velvet L. Barnes, of Temple Hills, Maryland, pled guilty in D.C. Superior Court, to one count of attempted uttering. Barnes was sentenced to 150 days confinement (entirely suspended) and one year of supervised probation, by Superior Court Judge Harold L. Cushenberry, on June 28, 2004.

According to the government's proffer, on or about May 12, 2004, the defendant entered Citibank, located at 3917 Minnesota Ave., NE, in Washington, DC, and attempted to cash a check in the amount of \$1100 from the account of the victims. The branch manager called and spoke with one of the account holders, who informed the branch manager that he did not give the defendant the check in question and that the check was stolen. The defendant then stated, in the presence of MPD officers, that her boyfriend gave her the check to purchase a car. Both account holders advised MPD officers that they did not know the defendant and did not write a check for the amount presented to Citibank.

AUSA Ellen Chubin prosecuted this case.

Sixteen-year-old Involved in Head-On Collision While Driving Stolen Minivan Pleads Guilty to Involuntary Manslaughter and Unauthorized Use of a Vehicle (PSA 605; Case Number F-4000-04)

On Tuesday, August 3, 2004, Andrew Lofty, 16, of Washington, D.C., pleaded guilty in D.C. Superior Court to involuntary manslaughter and unauthorized use of a vehicle. The defendant faces a maximum of 30 years imprisonment when he is sentenced on October 15, 2004, by the Honorable Robert I. Richter.

According to the government's proffer, Lofty admitted driving a stolen minivan in the area of G Street and Alabama Avenue, S.E., when he spotted a police vehicle and began to accelerate, passing several stop signs without stopping. Lofty continued to speed on G Street, between Alabama Avenue and 46th Street, when he recklessly drove onto the left side of the two-way street colliding head on with Terry Andrew Weaver who was operating a motor scooter. The force of the collision threw Mr. Weaver in excess of 100 feet from the impact location. Mr. Weaver died as a result of the collision.

After colliding with the decedent, Lofty left the scene of the accident and continued driving on G Street, eventually turning onto Hilltop Terrace. The minivan caught fire as a result of dragging the scooter from the scene of the collision to Hilltop Terrace.

AUSA Jay Balacek investigated and prosecuted the case.

Andrew Williams Pleads Guilty to Robbery and Assault with a Dangerous Weapon (PSA 604; Case Number F-1618-04)

On August 2, 2004, Judge Susan Winfield sentenced seventeen-year-old Andrew Williams, of no fixed address, to three years incarceration, followed by three years supervised release, on each count of robbery and assault with a dangerous weapon. The sentences will run concurrently.

According to the government's proffer, on February 27, 2004, at approximately 5:45 p.m., the complainant, a Domino's Pizza delivery man, was delivering pizza in the 3700 block of Hayes Street, N.E., when the defendant approached him, displayed a sawed-off shotgun, and demanded the scooter he was riding. The complainant complied, and the defendant drove away on the scooter. The complainant immediately called 911, reported what had happened, and provided a description of the defendant.

Three hours later, Metropolitan Police Department officers receive a call for the sound of gunshots in the area of the 3700 block of Hayes St., N.E. When the officers responded to the scene, they observed the defendant and another juvenile on the roof of the building at 3778 Hayes St., N.E. The officers ordered the defendant to come down off of the roof. The defendant initially refused, but finally came down after the officers surrounded the building. When the defendant came down from the roof, the officers noticed that he matched the description of the suspect in the earlier pizza delivery robbery. The complainant was brought to the scene, and positively identified the defendant as the person who had robbed him of his scooter three hours earlier. When the officers searched the roof of the building, they discovered a Pardner Model SB1 410. gauge sawed-off shotgun that the defendant had used to commit the robbery.

AUSA Tonya Sulia prosecuted the case.



DEFENDANTS WHO WERE CONVICTED IN FIREARMS CASES

Under the Project Safe Neighborhoods (PSN) initiative, 9 persons were convicted of firearms offenses in July 2004. PSN is a partnership between local and federal agencies to reduce gun violence in the District of Columbia. The following is a list of offenses that occurred in this district:

Leon T. Saunders was sentenced to 15 months incarceration by Judge Gerald I. Fisher, on July 12, 2004, following his guilty plea to the charge of carrying a pistol without a license (CPWL). Saunders was initially arrested on December 31, 2003, in the 3700 block of Jay Street, N.E. (PSA 601)

**DEFENDANTS WHO WERE CONVICTED OR PLED GUILTY
AND WERE SENTENCED IN A NUMBER OF DRUG CASES**

Dehavilland J. Fox, of the 3700 block of Hayes Street, N.E., was sentenced to 13 months confinement by Judge Gerald I. Fisher on June 28, 2004, following a guilty plea on April 29, 2002, to Distribution of Marijuana and Possession with Intent to Distribute Marijuana. **Fox** was arrested on March 22, 2002, in the front of the 4000 block of Quarles Street, N.E. (PSA 601).

Aaron Toney, of the 1600 block of Bell Haven Drive, Landover, Maryland was sentenced to five years confinement (three years suspended) and five years probation by Judge Gerald I. Fisher on June 29, 2004, following a guilty plea on May 3, 2004, to Distribution of Heroin and Possession with Intent to Distribute Heroin. **Toney** was arrested on January 10, 2004, in the front of the 600 block of Division Avenue, N.E.

In another matter, **Toney** was sentenced to five years confinement (entirely suspended) and five years probation by Judge Fisher on June 29, 2004, following a subsequent guilty plea on May 3, 2004, to Distribution of Heroin. In this case, **Toney** was arrested on January 31, 2004, in the 600 block of Division Avenue, N.E. (PSA 602).

Arline E. Mobley, of the 200 block of 55th Street, N.E., was sentenced to 30 days confinement by Judge Truman A. Morrison, III on June 29, 2004, following a guilty plea on June 28, 2004, to Attempted Possession of Cocaine. **Mobley** was arrested on January 22, 2004, in the 200 block of 55th Street, N.E. (PSA 602).

Karl T. Carrington, of the 2800 block of Langston Place, S.E., was sentenced to 27 years confinement (entirely suspended) and two years probation by Judge Erik P. Christian on July 7, 2004, following a guilty plea on April 26, 2004, to Attempted Distribution of Cocaine. **Carrington** was arrested on February 4, 2004, in the 600 block of Division Avenue, N.E. (PSA 602).

Seamus J. Hing, of the 1600 block of Eastern Avenue, Capitol Heights, Maryland, was sentenced to two years confinement (entirely suspended) and 18 months probation by Judge Lynn Leibovitz on July 7, 2004, following a guilty plea on April 23, 2004, to Attempted Distribution of Cocaine. **Hing** was arrested on February 11, 2004, on the side of the 1500 block of Olive Street, N.E. (PSA 602).

Alan S. Brown, of the 3700 block of Kanawha Street, N.W., was sentenced to 180 days confinement (entirely suspended) and three days probation by Judge Harold L. Cushenberry on July 9, 2004, following a guilty plea on April 2, 2004, to Attempted Possession with Intent to Distribute Marijuana. **Brown** was arrested on January 2, 2004, in the 1500 block of Kenilworth Avenue, N.E. (PSA 602).

Tecardo J. Ward, of the 2400 block of Naylor Road, S.E., was sentenced to 10 years confinement (entirely suspended) and two years probation under the Youth Rehabilitation Act by Judge Erik P. Christian on July 8, 2004, following a guilty plea on July 8, 2004, to Attempted

Distribution of Cocaine. **Ward** was arrested on February 4, 2004, in the vicinity of 60th Street, N.E. and Eads Street, N.E. (PSA 602).

Larry F. Newman, of the 2300 block of Reynolds Place, S.E., was sentenced to 40 months confinement (entirely suspended) and three years probation by Judge Harold L. Cushenberry on July 16, 2004, following a guilty plea on May 3, 2004, to Attempted Possession with Intent to Distribute Cocaine. **Newman** was arrested on March 4, 2004, in the rear of the 800 block of 46th Street, N.E. (PSA 602).

David Davidson, of the 500 block of 49th Place, N.E., was sentenced to six months to 18 months confinement by Judge Russell F. Canan on July 16, 2004, following a guilty plea on March 31, 2004, to Possession with Intent to Distribute Cocaine. **Davidson** was arrested on March 20, 1999, in the 4500 block of Central Avenue, N.E. (PSA 602).

Antonio D. Alexander, of the 7000 block of 58th Street, N.E., was sentenced to 60 months confinement (40 months suspended) and three years probation under the Youth Rehabilitation Act by Judge Thomas J. Motley on July 20, 2004, following a guilty plea on May 17, 2004, to Attempted Distribution of Cocaine. **Alexander** was arrested on April 20, 2004, in the 700 block of 58th Street, N.E. (PSA 602).

Alonzo Beasley, of the 600 block of T Street, N.W., was sentenced to 36 months confinement, 24 months probation and \$250 fine by Judge John H. Bayly, Jr. on July 20, 2004, following a guilty plea on November 6, 2002, to Attempted Distribution of Cocaine. **Beasley** was arrested on June 5, 2002, in the 300 block of 50th Street, S.E. (PSA 602).

In another matter, **Beasley** was also sentenced to 36 months confinement, 24 months probation and \$250 fine by Judge Bayly on July 20, 2004, following a subsequent guilty plea on November 6, 2002, to Attempted Possession with Intent to Distribute Heroin. In this case, **Beasley** was arrested on June 13, 2002, in the 300 block of 50th Street, N.E. (PSA 603).

Emmanuelle Huggins, of the 3600 block of Lyndale Place, S.E., was sentenced to five years confinement (entirely suspended) and three years probation by Judge Russell F. Canan on July 16, 2004, following a guilty plea on July 16, 2004, to Attempted Distribution of Cocaine. **Huggins** was arrested on July 11, 2002, in the 5000 block of Field Place, N.E. (PSA 602).

Tremaine L. Moore, of the 4700 block of Alabama Avenue, S.E., was sentenced to 18 months confinement and 24 months probation by Judge John H. Bayly, Jr. on July 21, 2004, following a conviction at trial on January 30, 2002, for Violating a Drug Fee Zone. **Moore** was arrested on September 18, 2001, in the 600 block of Division Avenue, N.E. (PSA 602).

Keith A. Leaman, of the 6200 block of Hope Drive, Temple Hills, Maryland, was sentenced to 150 days confinement (entirely suspended) and 18 months probation by Judge Harold L. Cushenberry on July 22, 2004, following a June 22, 2004, to Attempted Possession of Heroin. **Leaman** was arrested on May 26, 2004, in the 200 block of 50th Street, N.E. (PSA 602).

Leonard Jones, of the 1800 block of Q Street, S.E., was sentenced to 20 months confinement (entirely suspended) and two years probation by Judge Harold L. Cushenberry on June 28, 2004, following a guilty plea on April 7, 2004, to Attempted Distribution of Cocaine. **Jones** was arrested on February 11, 2004, in the front of 3300 block of Ely Place, S.E. (PSA 603).

Lanard A. Cloyd, of the 4000 block of D Street, S.E., was sentenced to 27 years confinement (23 years suspended) and two years probation by Judge Erik P. Christian on July 12, 2004, following a guilty plea on October 16, 2003, to Distribution of Heroin. **Cloyd** was arrested on January 14, 2003, in the 300 block of 50th Street, N.E. (PSA 603).

Nellie Repovich, of the 4600 block of Quarles Street, N.E., was sentenced to 60 days confinement by Judge Maurice Ross on July 13, 2004, following a guilty plea on April 27, 2004, to Attempted Possession of Cocaine. **Repovich** was arrested on February 26, 2004, in the unit block of 42nd Street, N.E. (PSA 603).

Lawrence D. Bailey, of the unit block of 53rd Street, S.E., was sentenced to 18 months confinement by Judge Frederick H. Weisberg on July 16, 2004, following a guilty plea on December 1, 2003, to Attempted Distribution of Heroin. **Bailey** was arrested on September 8, 2003, in the 5000 block of Central Avenue, S.E. (PSA 603).

Leonard Johnson, of no fixed address, was sentenced to 12 months by Judge Gerald I. Fisher on July 22, 2004, following a guilty plea on February 17, 2004, to Possession with Intent to Distribute Cocaine. **Johnson** was arrested on January 13, 2003, in the 300 block of 50th Street, N.E. (PSA 603).
