Rural Housing Service

Fiscal Year 2003 was a remarkable year for USDA Rural Development's housing programs in Kansas, both in the single and Multi-Family areas. Funding usage in Kansas surpassed any previous year in USDA Rural Development's loan making history. Both programs combined have provided 1,295 homes for Kansas families in the past year.

502 Guaranteed (GRH) Loans

USDA Rural Development's GRH Program experienced tremendous growth in FY03. 705 loans were approved, representing a 24% increase over the previous year. Guaranteed loans are offered through approved lenders to provide rural residents with affordable housing options for new or existing homes.

Special Outreach Areas for the GRH Program have been designated to ensure that truly rural locations benefit. A minimum of 25% of all GRH loans must be in Special Outreach Areas. In Kansas, over 86% of Guaranteed Loans were made to borrowers in Special Outreach areas.

The Mike Shinkle family purchased the home they were renting in Jackson County, Kansas with 502 loan funds. Even after needed repairs were made to the home prior to the sale, their mortgage payments are \$375 less than what they paid in rent.



502 Direct Loan Program

The 502 Direct Loan Program for low and very low income borrowers provides a real opportunity for many who could otherwise not afford a home of their own.

Direct loans may be leveraged with funds from outside lenders and other groups to provide down payment assistance. Loan payments may be further reduced for qualifying families through payment assistance. All applicants must meet income guidelines for the county where the home is located.

The Tim Zorn family moved from Minnesota to Kansas in a school bus and lived in it for several months, until they learned of USDA Rural Development's 502 Housing Program. They were able to purchase this home near Wichita. The family now has a safe environment to raise their children. They commented that it is "truly a miracle that we now have a home of our own."

Mutual Self-Help Housing Program

Mutual Self-Help grants are awarded to eligible organizations to administer home building programs for families who otherwise could not afford home ownership. The grantee recruits families who qualify under USDA Rural Development loan guidelines and who are also interested in constructing their own homes. Currently, three active Self-Help grantees in Kansas work with families to construct Self-Help Housing. These grantees are: Housing Opportunities, Inc., Great Bend; Mennonite Housing and Rehabilitation Services, Inc., Wichita; and The City of Junction City, in Junction City

Housing Preservation Grants (HPG)

HPGs provide federal funds to public agencies, non-profit organizations and other eligible entities for qualified low and very low income applicants to repair their homes. Eligible grant purposes include water and waste systems, wiring, roofing, structural repairs, handicapped accessibility and energy saving measures. Once an entity is selected for funding, homeowners may apply directly to that entity for repair grants. In FY03, four Kansas entities received HPG grants:

515 Multi-Family Housing Loans

Multi-Family programs totaled \$3,074,300 in funding for FY03 in Kansas. Rural rental housing loans are direct, competitive mortgage loans made to provide affordable Multi-Family rental housing for very low, low, and moderate income families, the elderly, and persons with disabilities.

Business & Community Programs

In Fiscal Year 2003, USDA Rural Development funded 60 business and community projects totaling approximately \$27.5 million. Those projects included the areas of business development, water and sewer improvements, community facilities, value added businesses, energy efficiency, technical assistance, and related economic development projects.

FY03 found the Agency implementing several new and exciting programs resulting in new opportunities, such as renewable energy and an Ag Innovation Center. It has been a rewarding year through these experiences.

Business & Industry Loan Program

The Business & Industry Guaranteed Loan program is available to financial institutions for commercial loans in areas of less than 50,000 in population for projects that create or save rural jobs. In FY 2003 projects such as a metal fabrication business and a book distribution warehouse were funded.

USDA Rural Development was able to provide the needed funds for constructing a new building and purchasing equipment for the new cotton gin facility near Moscow, KS. This gin allowed the Cooperative members and some other growers in southwest Kansas to save money by not having to ship their cotton to other out of state gins. The project created jobs in the area as well as many additional economic benefits for the community. Rural Economic Development Loans & Grants

To facilitate job creation and community development, loans and grants are available to eligible rural electric and telephone cooperatives. During FY03, Kansas ranked #1 in the nation for this program in projects and funding.

- 11 Projects funded
- Approximately 200 jobs created and saved
- Over \$3.5 million in loans approved



Chisholm Trail Country Store of Newton, Kansas received a Rural Economic Development Loan from the Agency and administered through the Sedgwick Co. Electric Cooperative Assn. to provide a marketing outlet for locally grown agricultural commodities.

Value-Added Development Grant Program

Grants are available to agriculture groups for technical assistance and/or working capital for the development of value-added projects. Projects ranged from funding to complete feasibility studies for ethanol plants to providing working capital for a soybean crushing facility.

Agriculture Innovation Center Grants

Kansas was one of 10 states to receive an Agriculture Innovation Center Grant. The \$1 million grant was approved for the State of Kansas. The state's Department of Commerce will use the funds to establish an agriculture innovation center that provides assistance to agriculture producers in the development of value added businesses





Community Facilities

The Community Facility (CF) Program is available for American Indian Tribes, municipalities and non-profits in towns of less than 20,000 in population to construct, enlarge or improve community facilities for health care, public safety and public service. In FY03, CF funds were utilized to improve the quality of rural life through projects that included construction of a community civic center, city hall building, upgraded a multi-purpose community theatre, and installed a new heating/cooling system for a health care facility.

- Over 80,000 families benefited
- \$989,400 funding obligated



Chautauqua RFD#4 received funding from USDA Rural Development to expand to their existing firehouse. The addition will be used to house fire trucks and equipment. Over 1,100 rural Kansans are served by this project.

Renewable/Efficiency Energy Grants

In FY 2003, USDA announced the availability of \$23 million to assist farms, ranchers, and rural businesses to purchase renewable energy systems and make energy efficiency improvements. In FY 2003 the program consisted of grant funds only. Kansas successfully funded one energy efficiency project to a rural business. The business will benefit by 25 jobs saved. Renewable systems include wind, solar, biomass, geothermal, or hydrogen from renewables.

Water and Waste Disposal

Water and Waste Disposal programs are available to public bodies and non-profit organizations in communities of fewer than 10,000 in population to construct or improve water and waste disposal projects.

During FY03, Kansas experienced continual strong interest in the Guaranteed Water and Waste loan program.

- 19 Projects funded
- Over 8,000 households and businesses benefited
- \$14.8 million in funding



Doniphan County RWD #5 received loan and grant funds from USDA Rural Development to construct a new elevated storage water tank, rehabilitate a pump station, and install new water lines. This project benefits 440 users.


Rural Business Enterprise Grants
