REA Bulletin 43-9 (Electrification), 344-3 (Telephone), "Buy American' Requirement," attached, deals with compliance with "Buy American" provisions of the Rural Electrification Act of 1936, as amended.

In the past, it was necessary, with few exceptions, for borrowers to obtain special authorization from REA when purchasing foreign articles, materials and supplies. It will no longer be necessary to do so if:

- The articles, materials and supplies are determined by the borrower to be manufactured "substantially all" from articles, materials or supplies mined, produced or manufactured in the United States, under the test applied in paragraph IV. B., that is, that the cost of the products of foreign origin used therein constitutes less than fifty percent of the cost thereof; or
- 2. The six percent price differential of paragraph IV. C. exists, in the case of articles, materials and supplies determined to be of foreign origin under paragraph IV. B.

Borrowers may request specific authorization from REA for the purchase of foreign products not meeting one or the other of the above conditions.

SUBJECT: "Buy American" Requirement

- I. <u>Purpose</u>: To notify borrowers and their engineers, contractors and materialmen, regarding compliance with the "Buy American" requirement in connection with the expenditure of REA loan funds. The term "materials" includes articles, supplies and equipment, and each item thereof, whether acquired by purchase order, contract, or otherwise.
- II. <u>Statutory Provision</u>: The Rural Electrification Act, as amended, includes the following provision:

"In making loans pursuant to this title and pursuant to the Rural Electrification Act of 1936, the Administrator of the Rural Electrification Administration shall require that, to the extent practicable and the cost of which is not unreasonable, the borrower agree to use in connection with the expenditure of such funds only such unmanufactured articles, materials, and supplies, as have been mined or produced in the United States, and only such manufactured articles, materials, and supplies as have been manufactured in the United States substantially all from articles, materials, or supplies mined, produced or manufactured, as the case may be, in the United States."

All loan contracts between REA and its borrowers contain a provision requiring compliance with this statutory requirement. REA standard forms of construction contracts, materials and equipment contracts and purchase orders contain similar provisions.

III. "Buy American" Certificates: Borrowers have heretofore been required to furnish REA with "Buy American" certificates executed by their contractors and suppliers. Such certificates need no longer be furnished to REA, except when specifically requested. However, borrowers shall continue to remain responsible for compliance with the "Buy American" requirement by their contractors and suppliers.

IV. Determinations Under "Buy American" Requirement;

A. Applicability of Executive Order 10582:

Executive Order 10582, issued on December 17, 1954 and published in Volume 19 Federal Register No. 246 (issue of December 21, 1954) is hereby applied as provided herein to purchases of materials made with REA loan funds. Where such purchases are made with general funds, the requirements of this Bulletin will be applicable if reimbursement from RLA loan funds is sought for such expenditures.

B. Manufactured Materials:

Manufactured materials are considered to be of foreign origin for the purpose of compliance with the "Buy American" requirement if the cost of the foreign products used therein constitutes fifty percent or more of the cost of all products used therein. The term "foreign products" means only those components of manufactured materials which are directly incorporated therein but does not include materials used in the manufacture of such components.

C. Price Differential:

Where the bid or offered price of materials of domestic origin exceeds the bid or offered price of like materials of foreign origin by a sum determined by computing six percent of the bid or offered price of materials of foreign origin, delivered at the place specified by the borrower including applicable duty and all costs incurred after arrival in the United States, purchases of such materials of foreign origin arc deemed to be in compliance with the "Buy American" requirement.

D. Availability of Domestic Materials:

Where materials of foreign origin do not meet the price differential requirement of paragraph C above, borrowers may nevertheless request authorization from the Administrator to purchase such materials upon a showing that the purchase of domestic materials is not practicable on the ground that:

- 1. Like or comparable products are not available from domestic sources; or
- 2. Like or comparable products of domestic origin are in such short supply as to unduly delay the borrower's construction progress.

E. Materials Constituting. Only Part of a Purchase Order or Contract:

Where a supplier or contractor offers or furnishes several items under a purchase order or contract, the provisions of this Bulletin are applicable to each of such items. If any such items do not meet the requirements of paragraphs IV. B. or IV. C., borrowers may request the Administrator's authorization to acquire such items in the same manner as provided in paragraph IV. D.

This Bulletin supersedes all other existing material in conflict with its provisions.

SUPPLEMENTARY INFORMATION: Section 320 of the 2001 Interior and Related Agencies Appropriations Act (Pub L. 106-389) authorizes the payments to States and counties from monies derived from receipts collected on Federal lands. These payments are to be used for the benefit of public education and other public purposes. The Act also created a Forest Counties Payments Committee to gather input from the public and elected officials to help develop recommendations to Congress on a long-term solution for making payments to eligible States and counties in which Federal lands are situated. The Committee will evaluate the methods and use of these payments. The Committee will also consider the impact on eligible States and counties of revenues from the historic multiple use of Federal lands; evaluate the economic, environmental, and social benefits which accrue to counties containing Federal lands; evaluate the expenditures by counties on activities occurring on Federal lands which are Federal

responsibilities; and monitor payments and implementation of the Act.

At the November 29 meeting in Albuquerque, the Committee asks that respondents provide information that is responsive to the following questions:

1. Do counties receive their fair share of federal revenue-sharing payments made to eligible States?

2. What difficulties exist in complying with, and managing all of the federal revenue-sharing payments programs? Are some more difficult than others?

3. What economic, social, and environmental costs do counties incur as a result of the presence of public lands within their boundaries?

4. What economic, social, and environmental benefits do counties realize as a result of public lands within their boundaries?

5. What are the economic and social effects from changes in revenues generated from public lands over the past 15 years, as a result of changes in management on public lands in your State or county?

6. What actions has your State or county taken to mitigate any impacts associated with declining economic conditions, or revenue-sharing payments?

7. What effects, both positive and negative, have taken place with education and highway programs that are attributable to the management of public lands within your State or county?

8. What relationship, if any, should exist between federal revenue-sharing programs, and management activities on public lands?

9. What alternatives exist to provide equitable revenue-sharing to States and counties and promote "sustainable forestry"?

10. What has been your experience regarding implementation of Pub L. 106–291, The Secure Rural Schools and Community Self-Determination Act?

AGENCY: Rural Utilities Service and Rural Telephone Bank, USDA. **ACTION:** Notice of the "Buy American" status of certain countries under the Rural Electrification Act. **SUMMARY:** The Rural Utilities Service (RUS) published notice in the **Federal Register** for February 18, 1997, at 62 FR 7205 that the Uruguay Round Agreements Act, (108 Stat. 4954, Pub. L. 103-465, December 8, 1994), amended the "Buy American" provision, (7 U.S.C. 903 note) of the Rural Electrification Act of 1936, as amended (7 U.S.C. 901 et seq.,) (the "RE Act"). Under the amendment, the United States Trade Representative (USTR) is authorized to determine which countries ("eligible countries") are eligible to have their products receive the same treatment as manufactured and unmanufactured products produced in the United States. This notice lists the current eligible countries for RUS electric and telecommunications programs, respectively. Please refer to the Federal Register notice published February 18, 1997, at 62 FR 7205, for additional information on RUS Buy American requirements.

The USTR may at any time declare one or more additional countries to be "eligible countries" for either electric or telecommunications borrowers. The Chair of Technical Standards Committee "A" (Electric) will be the point of contact for RUS with respect to USTR determinations of eligible countries. Each RUS borrower is responsible for assuring that its procurement complies with the requirements of the RE Act "Buy American" provision.

Amendment to the Rural Electrification Act's "Buy American" Provision

AGENCY: Rural Utilities Service and Rural Telephone Bank, USDA. **ACTION:** Notice of Amendment to the Rural Electrification Act's "Buy American" Provision.

SUMMARY: The Uruguay Round Agreements Act, (108 Stat. 4954, Public Law 103–465, December 8, 1994), amends the "Buy American" provision, (7 U.S.C. 903 note) of the Rural Electrification Act of 1936, as amended (7 U.S.C. 901 *et seq.*) (the "RE Act"). In the provision, as amended by the Uruguay Round Agreements Act, the words "Mexico, or Canada" are replaced with "or in any eligible country". The United States Trade Representative (USTR) determines what countries are 'eligible''. As amended, the provision directs the Secretary of Agriculture, for the Rural Utilities Service (RUS). (previously the Rural Electrification Administration) to require that, to the extent practicable and the cost not unreasonable, a borrower use funds lent under the RE Act only for such unmanufactured articles, materials, and supplies, as have been mined or produced in the United States or eligible country and only such manufactured articles, materials, and supplies as have been manufactured in the United States or an eligible country substantially all from articles, materials or supplies mined, produced, or manufactured, as the case may be, in the United States or an eligible country.

This action is intended to provide borrowers receiving loans made by the Rural Telephone Bank (RTB) or loans made or guaranteed by RUS, as well as material and equipment manufacturers and the public, with information for compliance with the amended RE Act "Buy American" provision.

SUPPLEMENTARY INFORMATION: Section 342(g) of the Uruguay Round Agreements Act, amended the RE Act "Buy American" provision by replacing the words "Mexico, or Canada" with "or in any eligible country" and by authorizing the United States Trade Representative (USTR) to determine what countries are eligible. The "Buy American" provision now reads:

"In making loans pursuant to * * * the Rural Electrification Act of 1936 * * the Secretary of Agriculture shall require that, to the extent practicable and the cost of which is not unreasonable, the borrower agree to use in connection with the expenditure of such funds only such unmanufactured articles, materials and supplies, as have been mined or produced in the United States or in any eligible country, and only such manufactured articles, materials, and supplies as have been manufactured in the United States or in any eligible country, substantially all from articles, materials, or supplies mined, produced, or manufactured, as the case may be, in the United States or in any eligible country. For purposes of this section, an 'eligible country' is any country that applies with respect to the United States an agreement ensuring reciprocal access for United States products and services and United States suppliers to the markets of that country, as determined by the United States Trade Representative."

The RUS "Buy American" provision applies to any loan made by the RTB or made or guaranteed by the RUS. Whether a particular product is domestic or non-domestic for purposes of the RE Act "Buy American" provision depends upon such factors as the country of origin of the product and its component parts and whether the product is purchased by an electric borrower or a telecommunications borrower.

The eligibility status of Canada and Mexico has not changed. Products produced in Canada or Mexico substantially consisting of components produced in Canada, Mexico, or the United States and purchased with RTB or RUS electric or telephone loan funds are treated as United States domestic products.

At this time the USTR has determined that only Canada and Mexico are eligible countries for purchases made by telecommunications borrowers. Therefore, products produced in countries other than the United States, Canada, or Mexico and purchased by RUS telecommunications borrowers are not treated as domestic products for purposes of the RE Act "Buy American" provision. The amendment makes no change in the treatment of these purchases unless and until the USTR determines additional "eligible countries" for telecommunications borrowers.

At this time, the USTR has determined that the following countries have agreements ensuring reciprocal access regarding products used by electric borrowers, and are therefore "eligible countries" for purchases made by electric borrowers:

Austria Belgium Denmark Finland France Germany Greece Ireland Israel Italy Japan Korea Luxembourg The Netherlands Norway Portugal Singapore Spain Sweden Switzerland United Kingdom

Products from an eligible country consisting substantially of components produced in the United States or any eligible country and purchased by RUS electric borrowers with RUS loan funds will be considered to be domestic products for purposes of the RE Act "Buy American" provision.

The USTR may at any time declare one or more additional countries to be "eligible countries" for either electric or telecommunications borrowers. The Chair of Technical Standards Committee "A" (Electric) will be the point of contact for RUS with respect to USTR determinations of eligible countries. Each RUS borrower is responsible for assuring that its procurement complies with the requirements of the RE Act "Buy American" provision.

RUS is making technical revisions to its existing forms of loan contracts and loan contract amendments to conform them to the RE Act "Buy American" provision as amended. In addition, RUS will make similar technical revisions to its standard forms of contracts providing for the purchase of materials and equipment and for "furnish and install" type construction. Until these forms are revised, the borrower should make the appropriate changes in its contract forms.

Amendment to the Rural Electrification Act's "Buy American" Provision

AGENCY: Rural Electrification Administration and Rural Telephone Bank, USDA.

ACTION: Notice of Amendment to the Rural Electrification Act's "Buy American" Provision.

SUMMARY: The recently passed North America Free Trade Agreement Implementation Act has amended the Rural Electrification Act's "Buy American" provision. Previously, the provision required borrowers, when using loan funds, to purchase only equipment that was manufactured in the United States and that was made mostly from materials and supplies originating in the United States. The amended provision permits borrowers to also purchase equipment, under similar conditions, from Canadian or Mexican manufacturers.

SUPPLEMENTARY INFORMATION: The North American Free Trade Agreement Implementation Act, Public Law 103-182, (NAFTA Implementation Act) was signed into law on December 8, 1993. Section 381 (d) of Subtitle G of Title III of the NAFTA Implementation Act amends the REA "Buy American" provision established by Section 401 of the Rural Electrification Act of 1938, 52 Stat. 313, 318, 7 U.S.C. 901 et. seq., (1938 RE Act). The REA "Buy American" provision was revised by adding ", Mexico, or Canada" after every reference therein to the "United States."

Prior to its amendment by the NAFTA Implementation Act, the 1938 RE Act generally required borrowers, when using loan funds, to purchase equipment that was manufactured in the United States that was made mostly from materials and supplies originating in the United States. The NAFTA Implementation Act amendment of the 1938 RE Act takes effect on January 1, 1994. Generally speaking, after December 31, 1993, borrowers using funds from loans which have been made or guaranteed by REA or the Rural Telephone Bank will be able to satisfy REA's "Buy American" provision by purchasing equipment that has been manufactured in North America and made mostly of materials and supplies originating in North America, i.e., in the United States, Mexico, or Canada.

The REA "Buy American" provision as revised by the NAFTA Implementation Act reads as follows:

In making loans pursuant to this title and pursuant to the Rural Electrification Act of 1936, the Administrator of Rural Electrification Administration shall require that, to the extent practicable and the cost of which is not unreasonable, the borrower agree to use in connection with the expenditure of such funds only such unmanufactured articles, materials, and supplies, as have been mined or produced in the United States, Mexico, or Canada, and only such manufactured articles, materials, and supplies as have been manufactured in the United States, Mexico, or Canada substantially all from articles, materials or supplies, mined, produced, or manufactured, as the case may be, in the United States, Mexico, or Canada.

The amended provision applies to all procurements within REA's jurisdiction that commence after December 31, 1993, which involve any REA, Rural Telephone Bank or guaranteed loan funds. REA is notifying borrowers, as well as Canadian and Mexican manufacturers with current REA technically-accepted products, of this change in the REA "Buy American" provision.

REA is also making technical revisions to its existing forms of loan contracts and loan contract amendments to conform them to the 1938 RE Act as amended by NAFTA. REA will begin using these revised forms for all transactions entered into after December 31, 1993. In addition, REA is making similar technical revisions to its recommended forms of contracts providing for the purchase of materials and supplies. These changes will have no effect on any contract which is fully in effect prior to January 1, 1994.
