

Helena, Montana

Demographics¹

- Population (2000 Census): 25,780
- Race/Ethnicity (2000 Census): 93.8% white; 0.2% black/African American; 2.0% American Indian/Alaska Native; 0.8% Asian; 0.1% Native Hawaiian/Other Pacific Islander; 0.0% some other race; 1.5% two or more races; 1.7% Hispanic/Latino (of any race)

Programs/Initiatives

- High Intensity Drug Trafficking Area (HIDTA)⁷ The Rocky Mountain HIDTA is responsible for Cascade, Flathead, Lewis and Clark, Missoula, and Yellowstone counties in Montana as well as counties in Colorado, Utah, and Wyoming.
- Lewis and Clark County Drug Abuse Resistance Education Program (D.A.R.E.)⁸ The Lewis and Clark County D.A.R.E. Program is a shared effort between the school districts, the community, and law enforcement. The core curriculum consists of 17 lessons that teach 5th grade students to identify and resist the pressures to try drugs and alcohol as well as teaches students how violence and violent acts affect the entire community. D.A.R.E. instructors also teach similar programs to kindergarten through 4th grade students dealing with personal safety and drug awareness. The Lewis and Clark County D.A.R.E. division consists of a D.A.R.E. coordinator, two full-time instructors, and two part-time instructors. These officers teach at 22 schools in 9 school districts and graduate approximately 850 students from the program each year.

Federal Funding

- Drug-Free Communities Support Program⁹
 - Since FY 1998 when Drug-Free Communities funding was first available, Helena has been awarded funding one time. In FY 2003, \$99,270 was awarded to Helena's Safe and Drug Free Schools Advisory Board and Community Coalition.
- Executive Office for Weed and Seed¹⁰
 Helena has not been officially recognized as a Weed and Seed site.

- Substance Abuse and Mental Health Services Administration Discretionary Funds awarded to Helena in FY 2002:¹¹
 - Center for Mental Health Services: \$100,000
 - Center for Substance Abuse Prevention: \$0
 - Center for Substance Abuse Treatment: \$300,000
- There were no Helena recipients of the FY 2002 Office of Justice Programs Drug Court Grant.¹²
- There were no Helena recipients of the FY 2002 Community Oriented Policing Services Methamphetamine Grant.¹³
- There were no Helena recipients of the FY 2001 Housing and Urban Development Drug Elimination Grant.¹⁴

Juveniles

During 2000, there were 145 juvenile drug offenses known to law enforcement in Lewis and Clark County. This number has since decreased to 98 during 2002.¹⁷

Enforcement

- As of October 2001, there were 66 law enforcement personnel in Helena (47 officers and 19 civilians).¹⁸
- ▶ Drug Task Force, Helena Police Department¹⁹

The Drug Task Force was implemented in 1992 to investigate and eliminate illegal drug trafficking, sales, and the availability of dangerous within a multi jurisdictional area, including Helena. During July 1994 the Helena Police Department Drug Task Force was combined with task forces from six other jurisdictions/counties, forming the Missouri River Drug Task Force. The task force has been active in investigations and arrests of individuals involved in the transport and sale of marijuana, cocaine, methamphetamine, LSD, and other illicit drugs.

Courts

 \blacktriangleright Drug Courts²⁰

As of September 2003, there were no drug courts operating or being planned in Helena.

Corrections

The Lewis and Clark County Detention Center is responsible for the temporary detention of persons awaiting trial or who are serving sentences as set by the court. The detention center's average daily population is 72. AA meetings are held three nights a week at the detention center.²¹

Consequences of Use

As of September 2002, 7.9% of motor vehicle accidents in Lewis and Clark County involved alcohol.²²
