Demographics¹

- ➤ Population (2000 Census): 184,256
- Race/Ethnicity (2000 Census): 27.8% white; 70.6% black/African American; 0.1% American Indian/Alaska Native; 0.6% Asian; 0.0% Native Hawaiian/other Pacific Islander; 0.2% other race; 0.7% two or more races; 0.8% Hispanic/Latino (of any race)
- ➤ The majority of the Jackson population resides in Hinds County (99.7%), while the remainder reside in Madison County (0.3%).

Programs/Initiatives

➤ High Intensity Drug Trafficking Area (HIDTA)⁶
Designated in 1996, the Gulf Coast HIDTA is responsible for areas of Alabama, Louisiana, and Mississippi, including Hinds and Madison counties.

- ▶ Drug-Free Communities Support Program⁷ Only one coalition in Jackson has ever received funding as part of the Drug-Free Communities Support Program. In FY 2001, \$100,000 was awarded to the West Jackson Community Development Corporation.

Crime and Drug-Related Crime

From January 1 through February 29, 2004, there were 5 homicides known to the Jackson Police Department. This is an increase over the 7 homicides known to police from January through February 2003.¹⁶

➤ Preliminary data indicate that there were 22 murders known to the Jackson Police Department from January to June 2003. From January to June 2002, there were 26 murders known to police in Jackson.¹⁷

➤ During FY 2002, the Hinds County Street Sales Narcotics Enforcement Team initiated 400 cases resulting in the arrests of 175 offenders. ¹⁸

Enforcement

- ➤ Hinds County Street Sales Narcotics Enforcement Team (NET)¹⁹
 The purpose of the Hinds County NET initiative is to reduce and ultimately eliminate illicit drug activities in targeted areas through community efforts, enforcement, arrest, prosecution, sentencing, and incarceration of drug violators.
- As of October 31, 2002, there were 668 full-time law enforcement employees working in Jackson (436 officers and 232 civilians).²⁰

Trafficking and Seizures

- ➤ In FY 2002, efforts of the Hinds County NET initiative resulted in the seizure of \$31,552 in U.S. currency, 16 weapons, and 5 vehicles.²¹
- ➤ During FY 2001, the Jackson Police Department seized illicit drugs valued at \$560.203. 22

Courts

- ➤ Drug Courts²³
 - As of November 2003, there was 1 drug court in operation and 1 drug court being planned in Jackson.
- During FY 2002, efforts of the Hinds County NET initiative resulted in 146 indictments.²⁴

Corrections

As of June 30, 2002, approximately 6.46% of the inmates (1,427 inmates) within the Mississippi Department of Corrections were committed in Hinds County. 25
