

Programs/Initiatives

➢ Reconnecting Youth⁶

Reconnecting Youth is a school-based prevention program targeted at freshmen and sophomores at Juneau-Douglas High School who show signs of poor school performance, potential for dropping out, or multiple problem behaviors. The program encourages the students to develop and strengthen mood control, to decrease or stop drug involvement, and to improve overall school performance. The students work on these goals in small groups that meet 2-3 times per week and are facilitated by adults. The curriculum and group bonding are reinforced by 2½-day retreats where the students work on drug use prevention and other healthy life choices.

 \blacktriangleright Keep A Clear Mind (KACM)⁷

This prevention program is targeted to fourth graders at all six elementary schools in Juneau. KACM teaches students prevention skills by using classroom discussion and activities that the kids complete at school and then teach to their parent or caregiver. The students bring the workbooks back to class after having completed lessons with an adult on tobacco, alcohol, marijuana, inhalants, and other basic resistance skills.

Federal Funding

Drug-Free Communities Support Program⁸

Since FY 1998 when Drug-Free Communities funding was first available, Juneau has not received funding.

Executive Office for Weed and Seed⁹
Juneau has not been officially recognized as a Weed and Seed site.

Juveniles

During 2002, there were 598 total juveniles charged in Juneau. Of those juveniles charged, 42 cases were related to drug and alcohol charges.¹⁵

Enforcement

As of October 2001, there were 78 total full time law enforcement employees in Juneau (43 officers and 35 civilians).¹⁶

Trafficking and Seizures

In Southern Alaska, particularly in Juneau, methamphetamine arrives in the area in large amounts that have already been processed into a usable form.¹⁷

Courts

➢ Drug Courts¹⁸

As of May 2003, there were 3 drug courts in Juneau that were recently implemented or being planned. Two drug courts were recently implemented and one tribal drug court was being planned.

> During 2000, there were 126 court cases in Juneau involving underage drinking.¹⁹

Corrections

- During 2000, there were 2 inmates in the Juneau Community Residential Center Monitoring program. This was a decrease from the 13 inmates in the program during 1999.²⁰
- Of the 2 inmates in the Juneau Community Residential Center Monitoring program during 2000, one had received a controlled substance charge.²¹
- During 2000, there were 208 persons under supervision for probation/parole in Juneau.²²

Consequences of Use

From 1991-1998, there was one youth alcohol-related injury resulting in death in Juneau. From 1991 to 1998, there were 17 alcohol-related injuries requiring hospitalization in Juneau for persons ages 20 years or younger.²³

Treatment

➢ Juneau Alcohol Safety Action Program (ASAP)²⁵

The Juneau ASAP is based on a national model that seeks to reduce the frequency of alcohol-related traffic accidents through early identification of problem-drinkers and the initiation of appropriate interventions to deter alcohol-related drinking behavior. During 1999, of the 272 total persons in the Juneau ASAP program, 163 had completed treatment. In the Juneau ASAP program, a re-offense occurs when an ASAP client convicted of an alcohol-related misdemeanor is convicted of a subsequent alcohol-related offense within a three year period. During 1999, 43.6% of persons in the Juneau ASAP program had committed a re-offense.²⁶
