Wireless Telecommunications Bureau Releases Enhanced Attachment Interface for the Universal Licensing System and Ownership Filing

The new user interface for attaching documents to wireless applications and Ownership filings¹ offers greater flexibility, reliability, and usability for customers of the Universal Licensing System.

In a continuing effort to enhance the Universal Licensing System (ULS), the ULS Attachment Utility has been redesigned to improve upload and conversion of documents submitted as attachments to wireless applications and ownership filings. A New **User Interface** provides everything you need to upload, view, manage, or delete attachments. In addition, the system will now accept a greatly expanded list of common computer **File Formats** for upload.

New Interface

The new attachment utility interface offers a simpler design that allows you to upload and manage attachments in a single web browser window, an improvement over the old utility, which used two screens. Improved processing behind the scenes makes the utility more reliable and speeds processing time. The interface is divided into two main sections: Uploading Attachments and Viewing and Managing Attachments.

Uploading Attachments

To upload attachments, choose the **Attachment** button that appears at the bottom of appropriate applications in ULS Online Filing. The new Attachments Interface will open in a separate window. At the top of the page, identify the type of attachment you are submitting, the location of the file on *your computer*, and a description of the attachment. Click **Submit**, and your file will be uploaded to ULS. For complete instructions see the ULS website http://wireless.fcc.gov/uls/support/help/help_attach.html.

Please note: Attachment file-sizes remain limited to a maximum of 10 megabytes. Documents larger than 10 megabytes must be split into smaller files and uploaded as two or more attachments.²

Viewing and Managing Current Attachments

Attachments that you have uploaded with your application are available for you to view and manage in the new attachments interface. Information about each attachment is displayed horizontally, including the type of attachment, the date you uploaded the attachment, and the text of the description. Once the attachment utility is "refreshed," or another attachment is uploaded, the description text becomes a hyperlink. Click on the description to view the attachment. You can also easily delete specific attachments by selecting one or more of those listed and clicking the **Delete** button, or delete all listed attachments by clicking the **Delete All** button.

Please Note: After upload, all attachments are converted to Adobe Portable Document Format (PDF). You must have Adobe Acrobat Reader installed with your web browser to view Attachments. You can download a free copy of Adobe Acrobat Reader from the Adobe website, http://www.adobe.com/products/acrobat/readstep.html.

Acceptable File Formats

Prior to this release of the ULS Attachment Interface, ULS could accept only a limited number of file-types as attachments. The new interface allows you to upload many common computer file formats, such as word processing documents, spreadsheets, text files, PowerPoint presentations, and graphic files. After upload, all of these file types are converted to Adobe PDF format.

Some of the most common file types accepted are displayed below. For a complete list of all file types accepted as attachments by ULS go to http://www.activepdf.com/en/Products/DocConverter/FileFormats.asp.

Note: If the file format of your document is not listed, your attachment must be converted to PDF prior to uploading it. This type of conversion requires proprietary software from Adobe, http://www.adobe.com.

Filing Attachments Manually

If you need to include an attachment with your application but cannot transmit the file(s) to the FCC electronically, or you are filing attachments for the Cellular Radiotelephone Service that requires full-size maps, you may submit your attachments manually to the Commission.³
