March 2002 DoD Report Addresses Implementation of Defense Acquisition 2005 Task Force Recommendations

In response to section 825 of the National Defense Authorization Act for Fiscal Year (FY) 2002, P.L.107-107, the Office of the Secretary of Defense prepared and sent a required report to the House and Senate Committees on Armed Services. The report addresses the implementation of 31 recommendations set forth in the final report of the Defense Acquisition 2005 Task Force. Of the 31 recommendations, 14 are in implementation, 14 are being merged into follow-on strategies, and 3 were not pursued. See the DoD report at www.ar.navy.mil/reflib/acq05rptimpl.pdf.

Modifications to Clinger-Cohen Act (CCA) Compliance Policy

The purpose of the Mar 2002 OSD policy memo is to clarify and simplify the requirements for judging compliance with the CCA. The memo specifies modifications to DoD 5000.2 regarding CCA compliance. ASN(RD&A) Discusses FY03 Navy/Marine Corps Budget Request Before House Armed Services Subcommittees

On 06 Mar 02, ASN(RD&A), The Honorable John J. Young, Jr., appeared before the House Armed Services Subcommittees to discuss the DON's FY03 Procurement and Research, Development, Test, and Evaluation (RDT&E) Budget request. He cited specific programs targeted in the budget request, including: shipbuilding programs, aviation programs, expeditionary forces, theater combat systems, logistics, and science and technology transition. Program Focus: Office of Naval Research (ONR) Dragon Eye

The Dragon Eye program, a joint Marine Corps/Naval Research Laboratory (NRL) effort, in collaboration with industry, has successfully produced a low-cost robotic sensor system. Dragon Eye, a 4.4 pound remote controlled battery powered Unmanned Aerial Vehicle (UAV), can fit inside a standard Marine backpack. Plans are underway to deploy a pre-production version to support Marine security forces protecting the re-established American Embassy in Kabul, Afghanistan. Dragon Eye is a CY01 DON David Packard Award nominee and was recently featured in Defense Daily and Popular Science. The PMCoP Risk Management (RM) Community is taking the lead in a Risk ROI (Return on Investment) Metrics project with members from the Project Management Institute (PMI) and the International Council on Systems Engineering (INCOSE) Risk groups. The output will include case studies on successful RM projects and a more comprehensive understanding of how to calculate risk ROI.

The PMCoP is working with the Office of the Secretary of Defense for Acquisition, Technology, and Logistics/Software Intensive Systems (AT&L/SIS) representatives to establish a roadmap for how PMCoP & SIS can work together to provide a S/W Management support effort in PMCoP.

Camp Pendleton, Oceanside, CA, a 2001 Defense Acquisition Executive winner, is now one of the recipients of the 2002 Commander in Chief's Annual Award for Installation Excellence. The Camp Pendleton Housing Privatization program, a pioneering public-private venture, successfully negotiated a 50 year agreement to privatize the construction, renovation, operation, and management of housing at the Marine Corps Base Camp for \$19.4M. Traditional military construction would have cost approximately \$97M, with more funding needed for future renovations during the 50 year term.
