The filer returns the completed form to the OCC district office.</li> <li>• After review, OCC personnel forward the completed form to the IRS.</li> </ul>

Optional	District	<b>Local court records</b>	<p>Consult with District Counsel.</p> <p>Local court personnel may respond to phone call requests, and many jurisdictions have computerized records for rapid search. To research court records, contact the clerks of the appropriate local courts by calling the trial court located in the filer's jurisdiction. Be prepared to provide the filer's name, any variations of it, and any related business entities that might have been involved in litigation.</p>
