Registered mail may be sent through the Bolivian postal services and return receipts obtained. International reply coupons should be used when it is desired to prepay a reply. The term casilla in the text means post office box, and refers to the mailing address. Calle means street, Edificio means building.

Credit reports can usually be obtained through banks or through commercial reporting agencies such as Dunn and Bradstreet, Inc. and Arthur Young. City Bank NA has a branch in La Paz, Bolivia. A Bolivian bank, Banco de Santa Cruz has a branch in Miami.
