#### **Major Duties:**

The incumbent performs the full range of operation, maintenance, repair and troubleshooting of the heating, air conditioning, ventilating, water and steam service systems in the laboratories and office buildings. Incumbent performs the full range of operation of maintenance, repair and troubleshooting of the greenhouse, growth rooms and chambers. Services electrical and lighting systems. Operates and maintains other systems in support of the facility such as the security systems, fire suppression system, emergency power generation equipment and several other systems. Implements and oversees a scheduled preventative maintenance program for all facilities.

#### Working Conditions and Other Considerations:

Incumbent is exposed to varying abnormal temperatures and conditions both indoors and outside buildings. Works in areas where equipment is in continual operation, noise levels are abnormal and temperatures in excess of 100 degrees Fahrenheit are common. Subject to possible infection, mechanical injury, cuts, bruises, fumes, burns and grease.

Work requires active walking, prolonged periods of standing, climbing, stooping, bending, crawling, and working in cramped positions or confined spaces. Will be required to lift equipment and materials weighing up to 75 pounds.
