## **COMSC NOTICE 5040**

Subj: COMMANDER, MILITARY SEALIFT COMMAND MISSION CAPABILITY ASSESSMENT SCHEDULE

- 1. <u>Purpose</u>. To publish the Mission Capability Assessment (MCA) schedules for Military Sealift Command (MSC).
- 2. <u>Background</u>. The Department of the Navy Inspection Program (DONIP) includes all inspections, evaluations, assessments and other such activities, by whatever names, which ensure readiness, effectiveness and efficiency of commands and units. The DONIP, per reference (a), requires Immediate Superiors in Command to periodically evaluate subordinate activities in the performance of assigned mission, functions and tasks. Commander, Military Sealift Command (COMSC) will conduct MCAs of subordinates at least triennially. Enclosure (1) is the schedule of MCAs to be conducted by COMSC in FY03 and FY04; dates for FY05 and beyond are approximate and provided for general planning purposes. Requests for changes to the schedule should be made to COMSC Inspector General (N00I) immediately upon review of this notice and in no case less than 9 months prior to a scheduled assessment date.
- 3. <u>Action</u>. Area Commanders and Headquarters directorates (e.g., Program Managers, Functional Directors except for N2, Special Assistants, Field Offices [i.e., NFAF West, PM2 and PM5] and Afloat Personnel Management Center [APMC]) will prepare for MCAs per references (a) and (b).
