Clarification Question: There is an apparent contradiction in the answers to Question #27 and Question #47, having to do with the timeframe in which the report for each applicant exam is to be submitted to the INS MRO:

The answer to Question #27 states that the contractor must submit a complete report to the INS MRO within 5 business days after the exam is completed.

The answer to Question #47 states that the provider must submit the completed examination forms and test results to the contractor within 5 business days of the examination, and that "the contractor must then" submit the completed medical to the INS MRO "within 5 business days."

Does this mean, then, that the report and the original examination forms are to be submitted to the INS MRO within 10 days after the exam has been performed?

Clarification Response: Correct, the report and the original examination forms are to be submitted to the INS MRO within 10 days after the examination has been performed.
