Section 1 Purpose of this Addendum

Since the implementation of IPAC, many government-wide initiatives have begun affecting the way intra-governmental transactions are processed. As a result, IPAC is being enhanced to support the (1) Governmentwide Accounting and Modernization Project (GWA), (2) Intra-governmental Transaction Elimination Efforts, and (3) Intra-governmental Transaction Portal (IGTP) initiatives.

The changes in support if these efforts are being implemented in Phases; Phase I is being implemented on October 11, 2003. Effective with the implementation of Phase I, all IPAC payment, collection and adjustment transactions will be required to contain Sender Treasury Account Symbol (TAS) and Sender Standard General Ledger (SGL) account information. ALC(s) receiving IPAC transactions will have the capability to supplement the transaction with the Receiver SGL data; however the Receiver's SGL information will be optional in the Phase I 2003 implementation.

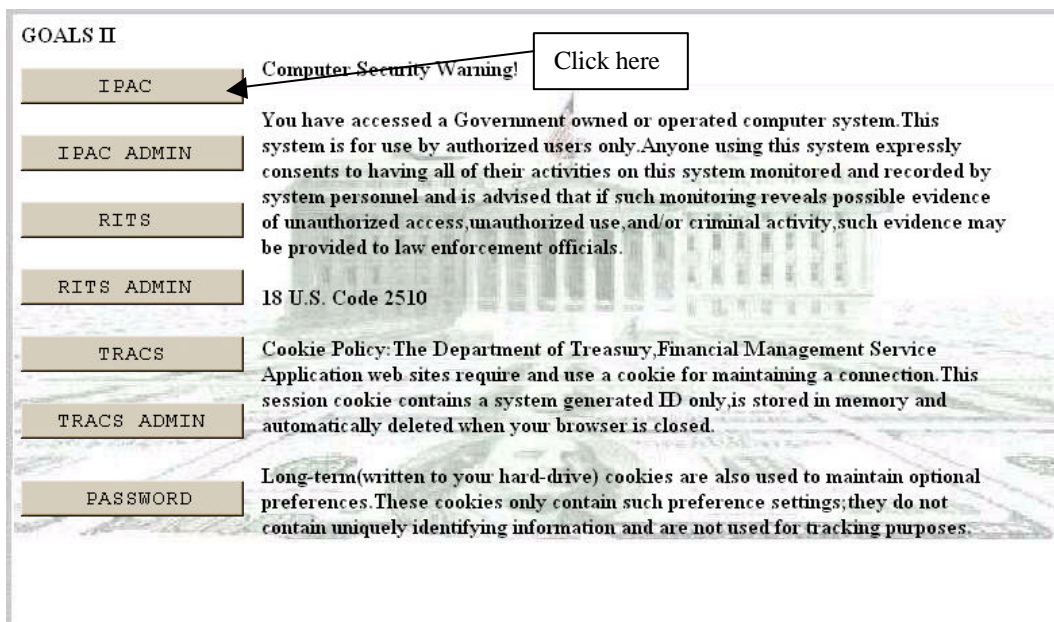


Figure 1.1 IPAC System Main Menu

In addition, optional fields for Sender and Receiver DUNS & Sender and Receiver DUNS +4 are added for all IPAC transactions. These new fields are not required for Phase I. To access this new functionality select through the IPAC option on the IPAC System Main Menu shown Figure 1.1 below.

Section 2 Enhancements for Payments and Collections

As part of Elimination changes, users will be required to provide Sender TAS and Sender SGL account information for all payment, collection and adjustment transactions. There are also new buttons and optional data entry fields for payment and collections that will be discussed in this section. Adjustment changes will be discussed in *Section 3*.

Note: Some Treasury Account Symbols that you may use in IPAC do not require SGL accounts with the transaction detail. “A” accounts, which are cash control accounts in the Central Summary General Ledger of the United States, are not subject to SGL rules and thus do **not** require SGL accounting data. An example of an “A” account is “20A8056”. Deposit funds and clearing accounts are required to do SGL accounting, but have special requirements that make them unsuited for SGL reporting through IPAC. Receipt accounts, on the other hand, do require SGL data. The lack of proper reporting on receipt accounts contribute significantly to intra-governmental elimination problems. In summary, funds that do **not** require SGL data in IPAC at this time are “A” accounts, **Deposit funds** and **Clearing accounts**. As agencies and FMS become more familiar with SGL reporting in IPAC, these rules may change.

To process a payment, enter in your ALC and a Customer ALC and select the “Payment” button from the **IPAC Main Menu** screen as shown below in Figure 2.1.

When you select the “Payment” button, the **Payment Entry** screen shown in Figure 2.2 will display.

Payment Entry New Data Fields

The **Payment Entry** screen has the following new data entry fields:

Sender DUNS

A 9-digit number that is assigned by Dun and Bradstreet associated with the registered entity (Office or Division) for the Sender

Sender DUNS + 4

This is a 4-digit extension to your Sender DUNS that the user creates. It is used if you have more than one ALC or DO per office and need to differentiate between the lines of business in one office.

Receiver DUNS

A 9-digit number that is assigned by Dun and Bradstreet associated with the registered entity (Office or Division) for the Receiver.

Receiver DUNS + 4

This is a 4-digit extension to your Receiver DUNS that the user creates. It is used if you have more than one ALC or DO per office and need to differentiate between the lines of business in one office.

Note: Prior to October 2003, the Sender TAS was an optional field. With the implementation of Phase I, the Sender TAS will be required.

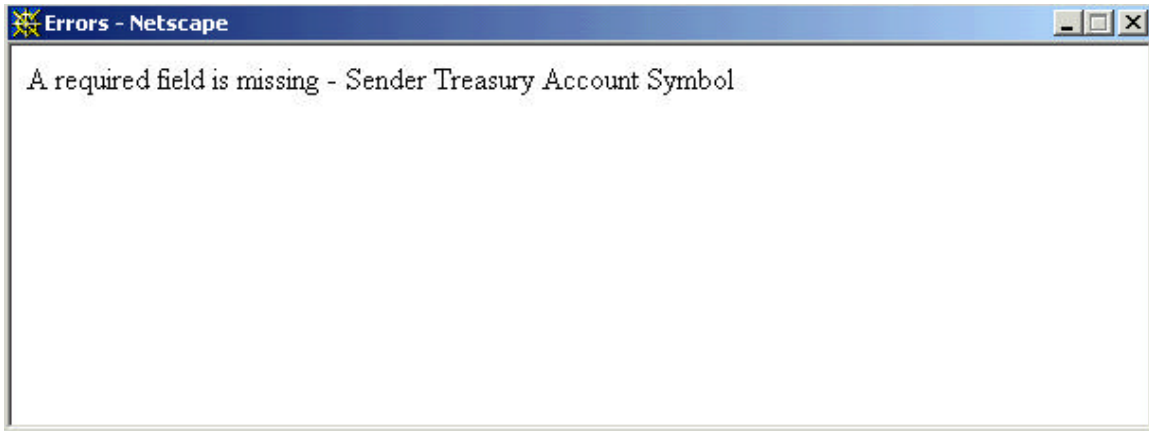


Figure 2.3 Required field missing- Sender TAS error message

If the Sender Treasury Account Symbol is not entered on the **Payment Entry** (Figure 2.2) screen, the following error message (Figure 2.3) will display if you click on the “Finished”, “More Detail”, “SGL Accounts” or the “Review Detail” buttons.

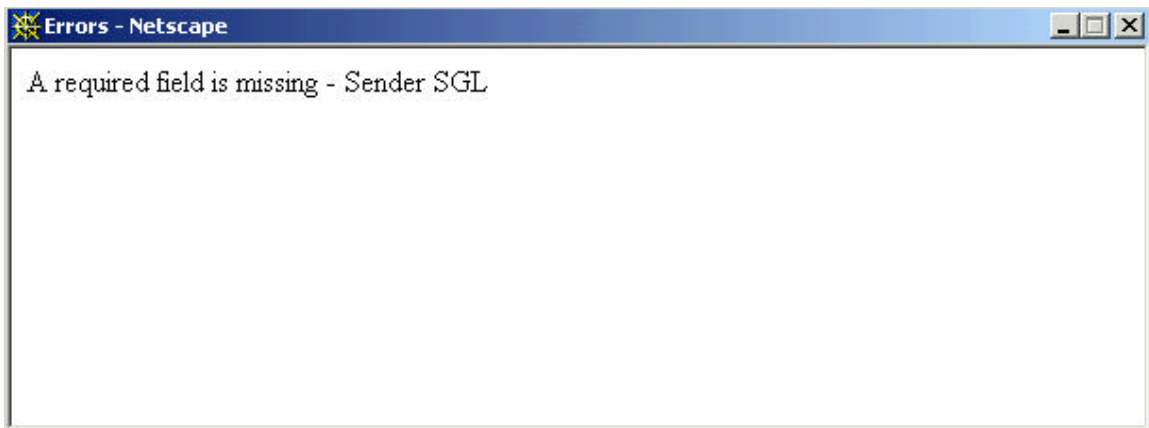


Figure 2.4 Required field missing- Sender SGL

If the Sender SGL information is not entered by clicking the “SGL Accounts” on the **Payment Entry** (Figure 2.2) screen, the following error message (Figure 2.4) will display if you click on the “Finished”, “More Detail” or the “Review Detail” buttons.

IPAC-Payment Entry Function Buttons

“Finished”

Finalizes the transaction, submitting the Header information, all entered lines of Detail information & sender SGL information. If no error is detected, a confirmation screen, similar to the one in Figure 2.11, will display.

“More Detail”

Takes you to another Payment Entry screen to enter more detail information. If no error is detected, the detail information will be saved and the Summary Amount and the Number of Details fields in the Header Section will be updated to reflect the amounts entered for this line item.

“SGL Accounts”

Standard General Ledger (SGL) accounts are assigned at the detail, or line item, level of a transaction. This function provides a way to allocate detail amounts to specific Standard General Ledger Accounts. The **SGL Accounts** screen is shown in Figure.2.7.

“Review Detail”

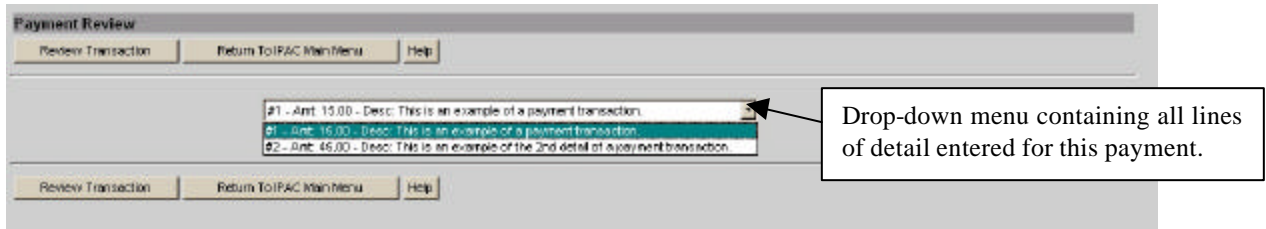


Figure 2.5 Payment Review

Review all of the details (line items), which have been entered for this transaction. If no error is detected, **Payment Review** screen (Figure 2.5) will display with the detail (line items) for the current transaction. Highlight the applicable detail and click the “Review Transaction” button to bring up all the elements of the detail line. The **Payment Review** window will close and the highlighted transaction will display on the **Payment Entry** screen for editing.

“Special Requirements”

In addition to the standard IPAC required fields, an ALC can make additional data fields required, thus ensuring its trading partners supply the specific information needed for its accounting practices. All required data entry fields will be indicated with an asterisk, including those fields made required by an Agency Special Requirement. If the transaction you are entering involves an agency with Special Requirements, you may review the ALC’s description of the Special Requirement field(s) by clicking the Special Requirements button from the **Payment Entry** screen (Figure 2.2) and the **IPAC Payment Special Requirements** screen will display, as shown in Figure 2.6.

Data Element	Description
Contract Number	Provide the Interagency Agreement Number in the Contract Number field.

“Return To IPAC Main Menu”

Returns you to the **IPAC Main Menu**.

“Clear”

All data entry fields are reset to their values the last time the screen was displayed. No data is submitted to IPAC.

“Help”

Displays the system help information

As mentioned in *Section 1* of this Addendum, the Sender SGL information is required in Phase 1. You will not be able to complete your transaction without entering Sender SGL information. SGL Information must be entered for each detail of the transaction. The error message shown in Figure 2.4 would be received from the **Payment Entry** screen if you hit the “Finished” button before entering SGL information in the **SGL Accounts** screen.

After entering detail information on the **Payment Entry** screen, shown in Figure 2.2, click on the “SGL Accounts” button to proceed to **SGL Accounts** screen (Figure 2.7).

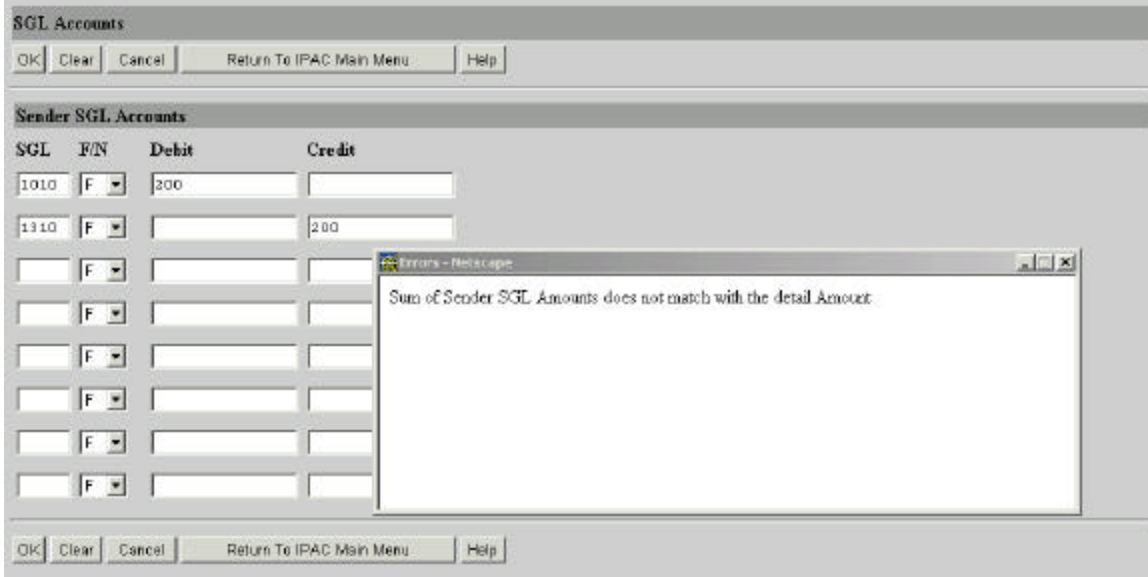


Figure 2.8 SGL amounts does not equal detail amount error message

You must enter a valid SGL account number, the SGL debit and credit amounts must equal the detail amount and each other. If the SGL debit & credit amounts entered do not equal the detail amount on the **Payment Entry** screen the error message (shown in Figure 2.8) will display.

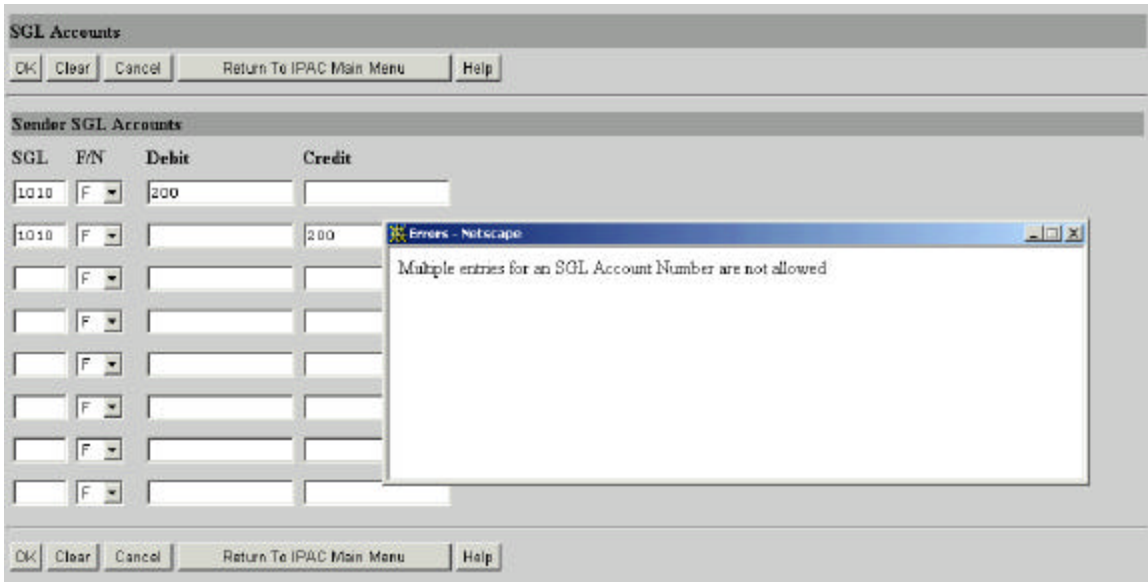


Figure 2.9 Multiple entries for an Account Number are not allowed error message

An SGL account can only be used once; therefore the user will receive an error message (Figure 2.9) if a SGL account number is entered twice.

The SGL Accounts information is limited to 4 credits and 4 debits (8 SGL accounts) as shown in Figure 2.10.

SGL Accounts Data Fields

The **SGL Accounts** screen has the following new data entry fields:

SGL

This data entry field is for the SGL account number. All SGL account numbers are assigned to a specific category, which is stored in the database and are 4 digits in length.

F/N

This dropdown is used to indicate the Federal/Non-Federal status of the SGL account entered.

Debit

You may allocate a detail amount to one SGL debit or you may break the amount into as many as four different debit SGL accounts. The sum total of the debits must equal the sum total of the credits before this information can be stored and the screen closed.

Credit

You may allocate a credit amount to one SGL credit or you may break the amount into as many as four different credit SGL accounts. The sum total of the credits must equal the sum total of the debits before this information can be stored and the screen closed.

SGL Accounts Function Buttons

The **SGL Accounts** screen has the following new data entry fields:

“OK”

Accepts the SGL accounts information entered, if there are no errors, and returns you to the **Payment Entry** screen.

“Clear”

All data entry fields are reset to their values the last time the screen was displayed. No data is submitted to IPAC.

“Cancel”

Returns you to the **Payment Entry** screen without saving any information you have entered.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu** screen without saving any information entered.

“Help”

Displays help information for this screen.

As mentioned above, clicking on the “OK” button from the **SGL Accounts** (Figure 2.7) screen returns you to the **Payment Entry** (Figure 2.2) screen. Clicking on the “Submit” button from the **Payment Entry** screen will complete your transaction, store Sender SGL information and generate a confirmation, shown in Figure 2.11.

Confirmation Screen Fields

This screen contains the following fields:

Originating ALC

The agency (Sender) initiating the payment.

Customer ALC

The agency (Receiver) being paid by the Originating ALC.

Document Ref. No.

The reference number generated by IPAC for the transaction.

Accomplished Date

The date a transaction was processed by IPAC.

Summary Amount

The total amount of the transaction (a sum of Detail Amounts).

Number of Details

The number of line items that were entered for this transaction.

Time

The time a transaction was processed by IPAC. Displayed in military time, please reference *Appendix B* for military time conversion chart.

These fields are for display only. You cannot change the information in any of these fields from this screen.

Confirmation Screen Function Buttons

This screen contains the following functions buttons:

“OK”

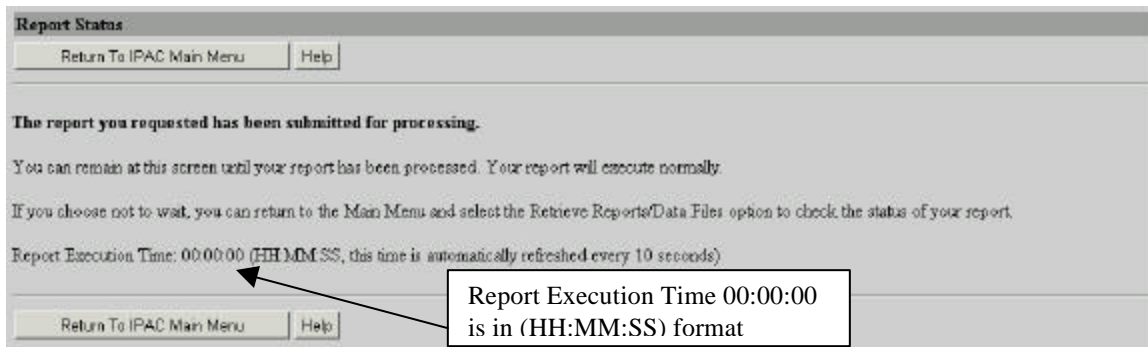


Figure 2.14 Report Status

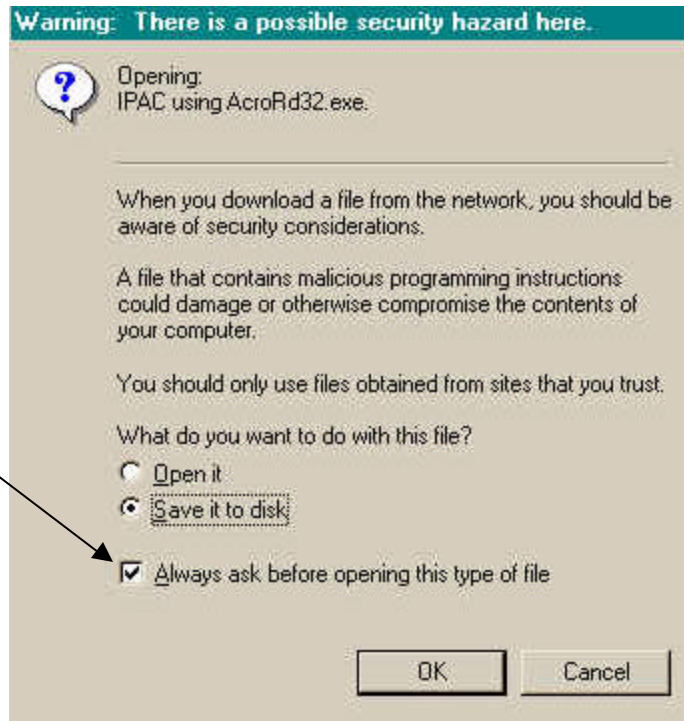


Figure 2.15 File Download Warning

Confirmation Report Header Information

Originating ALC:

This is the ALC originating (sending) the PCA (payment, collection, or adjustment) transaction to the Customer (receiving) ALC.

Customer ALC:

This is the ALC receiving the PCA transaction from the originating ALC.

Submitter ALC:

This is the Third Party Submitter's ALC if applicable. For more information regarding Submitter ALC, see *Section 6*.

Payment/ Collection/ Adjustment:

This column indicates whether the transaction is a payment, collection or adjustment.

Document Reference:

The number that is assigned to each transaction. The document reference numbers are assigned by the application if all transactions entered on-line; bulk file submitters have the capability to assign their own document reference numbers.

Summary Amount:

The total amount of the transaction (a sum of Detail Amounts).

Accomplished Date:

The date a transaction was processed by IPAC.

Accounting Date:

The last date of the month during which a transaction was processed by IPAC.

Number of details:

Number of details in the transaction.

Originator DO Symbol:

DO Symbol for the originating ALC

ALC Contact:

The name of the person that entered the IPAC transaction.

Contact Email:

The email address of the person that entered the IPAC transaction.

Contact Phone:

The telephone number of the person that entered the IPAC transaction.

The Confirmation Report displays transaction and detail information under the header information.

Collections

The data entry screens, new fields, new function buttons and **SGL accounts** screen (Figure 2.7) functionality for collections are the same as those for payments. The major difference between the two is that payments are disbursements of funds from one agency to another while collections are collections of funds from one agency to another.

Section 3 Post SGL Information

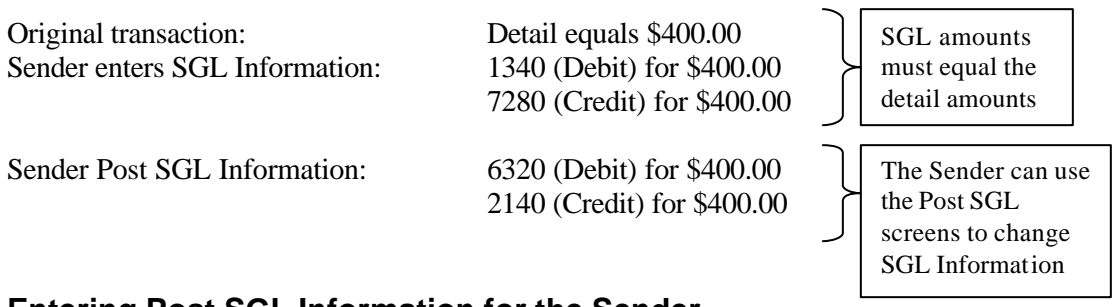
The new “SGL Information” button from the **IPAC Main Menu** (Figure 3.2) can be used to update SGL information for the Sender (Originating ALC) or to add or change the Receiver (Customer ALC) SGL Information. As mentioned in *Section 1*, the Sender will be required to enter SGL information on the original transaction, however they can change/update their SGL Information after their transaction is complete through the Post SGL screens. The Receiver will not be required in Phase I to enter corresponding SGL information; however the application will allow the Receiver to enter this information, if desired.

One of the purposes of the changes in Phase I is to enable agencies to communicate with one another about how they are classifying the IPAC transaction in their books in SGL terms. As the Sender or Receiver provides their SGL information, IPAC will associate the SGL transaction with the proper category. In order for the transaction to properly eliminate both the Sender and receiver side of the SGL transaction, the SGLs must be within the same categories. Category information will not be provided as data entry fields on the Post SGL screens; however this information will be provided by IPAC and available on the SGL Report and the IPAC Transaction Report (*Section 7*).

Please see the following example:

Using the above SGL information example, if a Sender enters an original transaction with a detail amount of \$400.00, they are required to enter SGL information equaling \$400.00. The Sender can use the Post SGL screens to change the SGL account information; however the SGL amount must equal the detail amount from the original transaction. For instance:



Entering Post SGL Information for the Sender

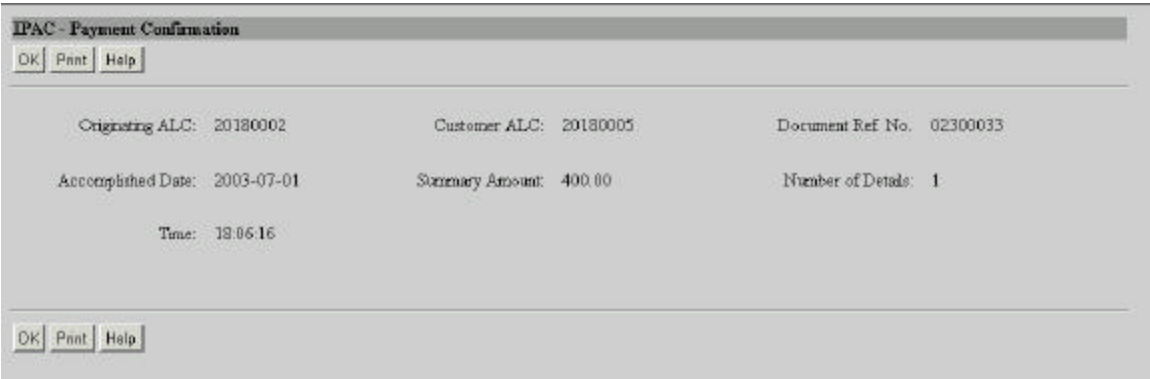


Figure 3.1 IPAC-Payment Confirmation

This option allows the Sender update/change SGL Information after the original transaction has been completed. The user will need information from the original transaction to enter Post SGL information. Information from the original transaction confirmation, shown in Figure 3.1, can be used.

To enter the Post SGL screens as the Sender, enter in your Originating ALC in the ALC field on the IPAC Main Menu screen as shown in Figure 3.2.

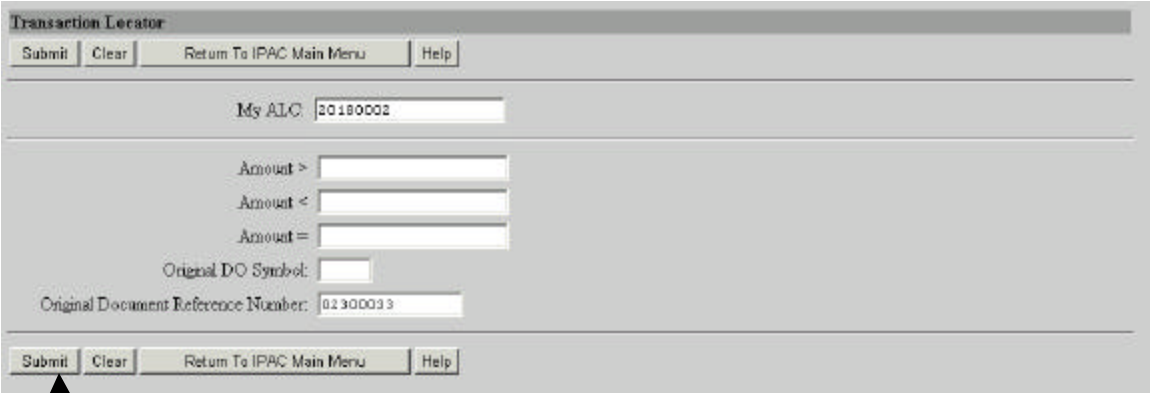


Figure 3.3 Transaction Locator

The user will be taken to the **Transaction Locator** screen, shown in Figure 3.3.

This screen allows you to search for transactions for a specified amount, greater and/or less than specified amounts, Original DO Symbol or Original Document Reference Number. The ALC is carried over from the IPAC Main Menu into the My ALC data entry field. The Original Document Reference Number is a data entry field that can be used exclusively, because document reference numbers are unique within ALC/DO Symbol combination. Therefore, no other criterion is needed when searching by Original Document Reference number. The other data fields may be used together or separately to narrow the search for your transaction(s). For instance, to search for transaction amounts greater than \$20.00 but less than 100.00, you would enter “20” in the Amount > data field and “100” in the Amount < data field.

Transaction Locator Data Entry fields

The **Transaction Locator** screen has the following new data entry fields:

My ALC

The ALC entered on the IPAC Main Menu and carried over to the **Transaction Locator** screen.

Amount >

This data entry field can be used to confine the search for the transaction(s) desired. If you want to narrow your search for a transaction(s) **greater than** a specified amount, you would enter that amount in the Amount > data entry field.

Amount <

This data entry field can be used to confine the search for the transaction(s) desired. If you want to narrow your search for the transaction(s) **less than** a specified amount, you would enter that amount in the Amount < data entry field.

Amount =

This data entry field can be used to confine the search for the transaction(s) desired. If you want to narrow your search for the transaction(s) **equal to** a specified amount, you would enter that amount in the Amount = data entry field.

Original DO Symbol

This data entry field can be used to search for the transaction(s) using the DO Symbol for the originating ALC. This search criterion is most helpful for the Receiver (Customer ALC), when they want to search the transaction(s) sent to them by a specific agency.

Original Document Reference Number

This data entry field can be used to search for a specific transaction by entering the document reference number for the original transaction. Since the document reference number is unique within ALC/DO Symbol combination, the user should only expect the application to return one transaction, with the corresponding detail(s) if applicable, when using this search criterion.

Transaction Locator Function Buttons

The **Transaction Locator** screen has the following function buttons:

“Submit”

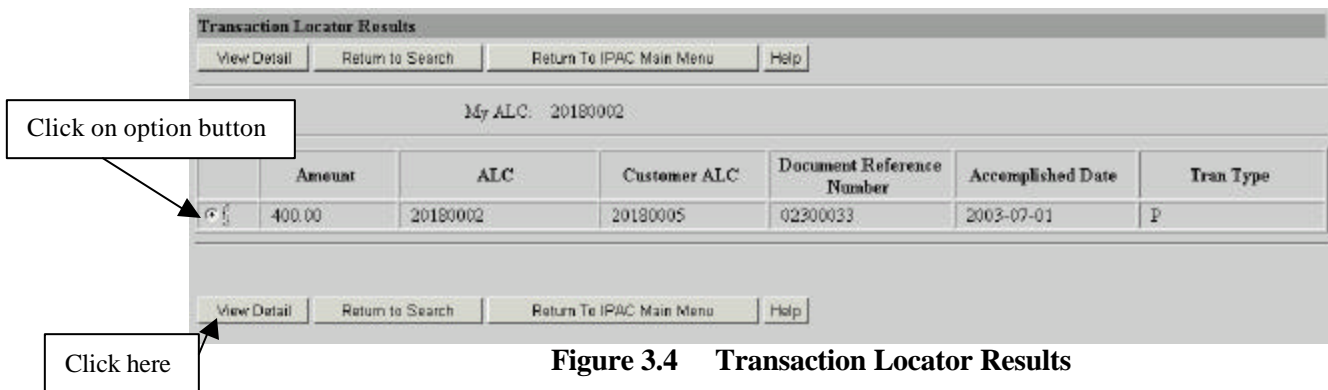


Figure 3.4 Transaction Locator Results

Accepts the Transaction Locator criteria entered, if there are no errors, and displays the **Transaction Locator Results** screen shown in Figure 3.4.

“Clear”

All data entry fields are reset to their values the last time the screen was displayed. No data is submitted to IPAC.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu** screen without saving any information entered.

“Help”

Displays help information for this screen.

Once you entered your criteria on the **Transaction Locator** screen, clicking on the “submit” button, as shown in Figure 3.3, will display the **Transaction Locator Results** screen (Figure 3.4).

Note: The application is limited to retrieving 100 rows (results) at 25 rows per page. If there are more than 25 rows, the “Next” and “Previous” button will be displayed.

The **Transaction Locator Results** screen, shown above in Figure 3.4, displays your ALC number entered on the **IPAC Main Menu** screen (Figure 3.2) as the heading of the screen.

Transaction Locator Results Columns

Amount:

Displays the amount of the transaction.

ALC:

Displays the originator ALC for the transaction.

Customer ALC:

Displays the Customer ALC for the transaction.

Document Reference Number:

Displays the transaction document reference number.

Accomplished Date:

Displays the date the transaction was processed by IPAC.

Tran Type:

Displays the type of transaction, “P” for Payment, “C” for Collection and “A” for Adjustment.

Transaction Locator Results Function Buttons

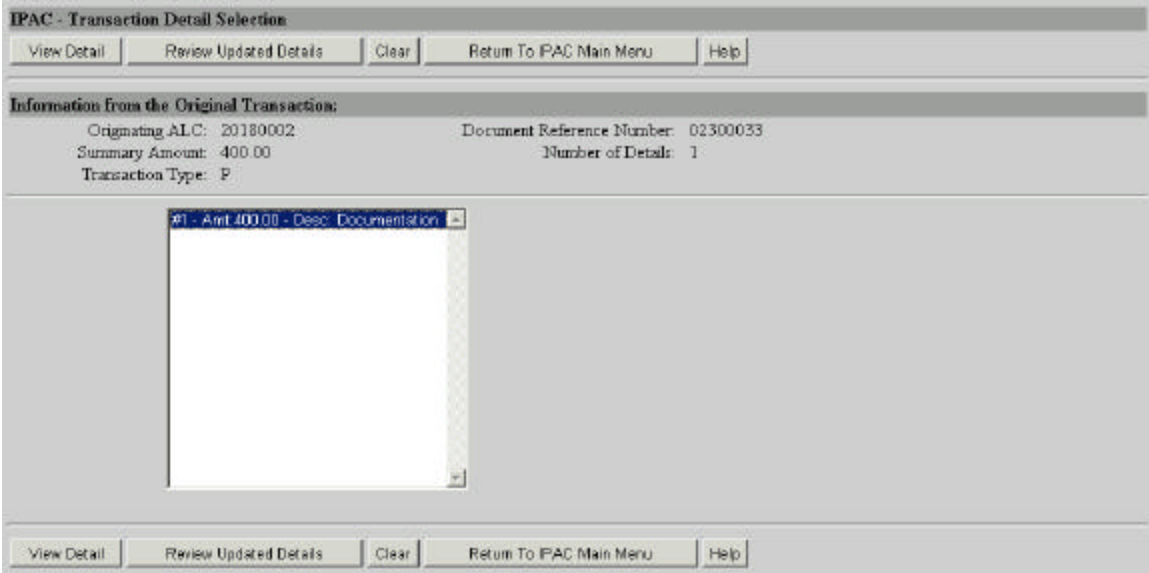


Figure 3.5 Transaction Detail Selection

If you want to review detail information and update SGL information for a transaction listed on the **Transaction Locator Results** screen (Figure 3.4), you must select the option button for transaction detail information you want to view. Once you have selected the transaction, you may select the “View Detail” button and the **Transaction Detail Selection** screen, shown in Figure 3.5, will display. The option buttons are mutually exclusive and you can only select one transaction at a time. The function buttons for the **Transaction Locator Results** screen (Figure 3.4) are as follows:

“View Detail”

Displays the **Transaction Detail Selection** screen (Figure 3.5).

“Return to Search”

Returns you to the Transaction Locator screen (Figure 3.3)

“Next”/“Previous”

If there are more than 25 transactions (rows), a “Next” button will display and this button will bring up the next 25 files or less. A “previous” button will display when needed to allow you to navigate between the **Transaction Locator Results** screens. The application is limited to retrieving a total of 100 transactions.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu**.

“Help”

Displays the system help for this screen.

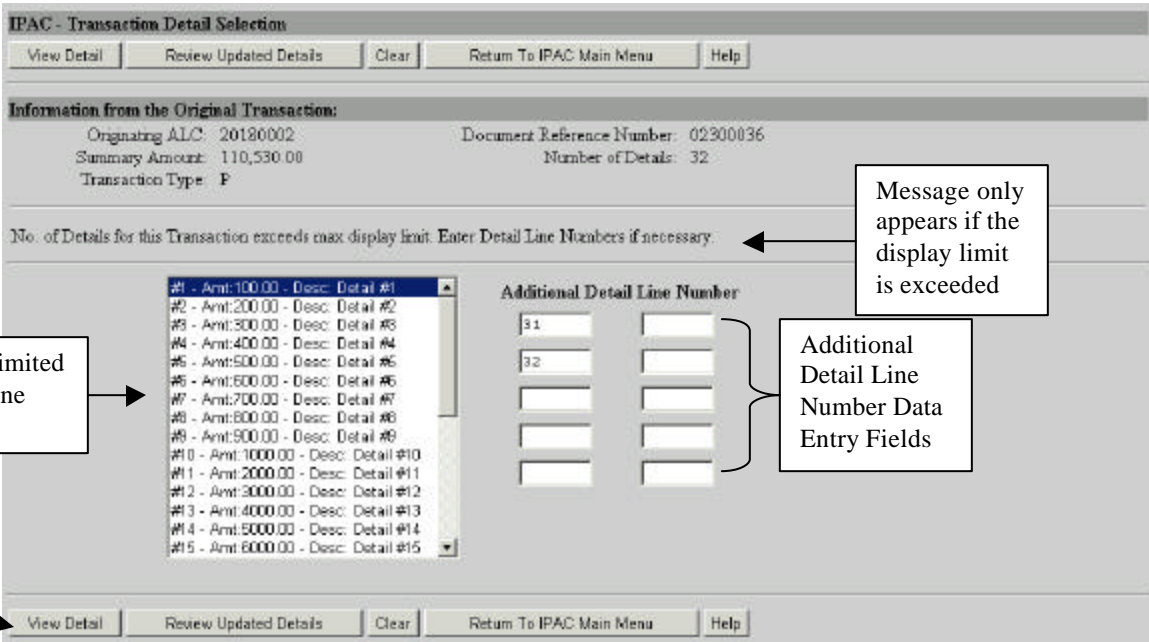


Figure 3.6 Transaction Detail Selection- additional data entry fields

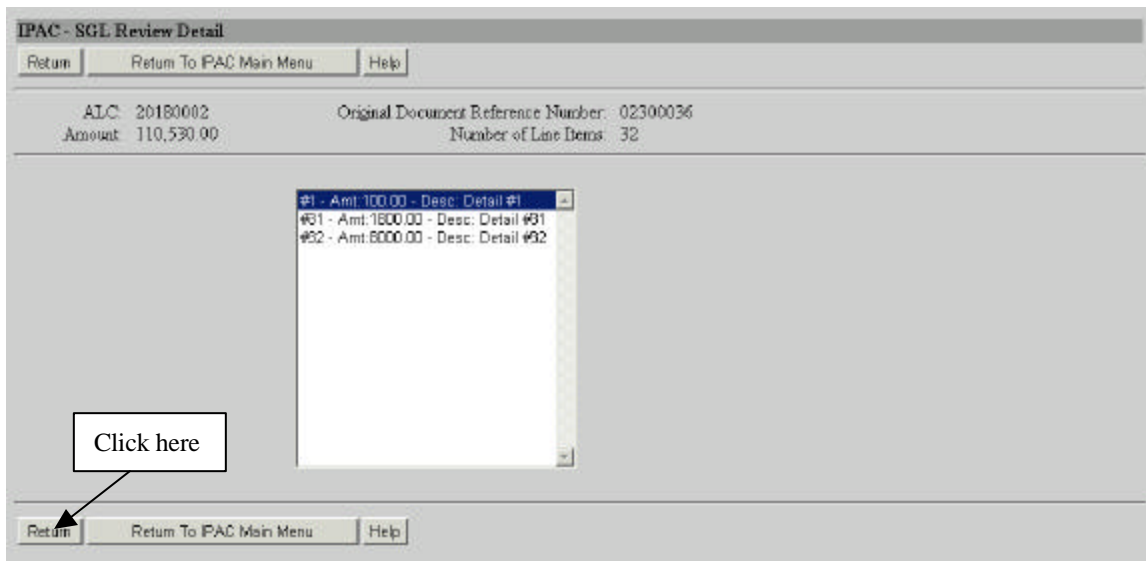


Figure 3.7 SGL Review Detail

The document reference number from the original transaction.

Note: A voucher number will be displayed if the transaction was an adjustment.

Original Accomplished Date:

The date the original transaction was processed by IPAC.

Original Accounting Date:

The last date of the month during which the original transaction was processed by IPAC.

ALC Contact:

The name of the person that entered the IPAC transaction.

Contact Email:

The email address of the person that entered the IPAC transaction.

Contact Phone:

The telephone number of the person that entered the IPAC transaction.

The **SGL Detail View** screen displays the selected detail information from the original transaction under the header information.

SGL Detail View Function buttons

“SGL Account”

Displays the **SGL Accounts** screen (Figure 3.10).

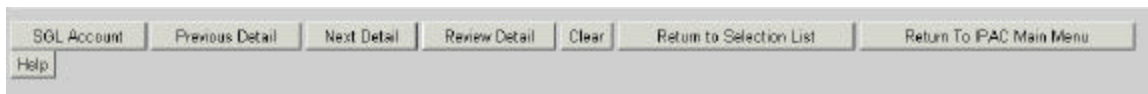


Figure 3.9 SGL Detail View function Buttons

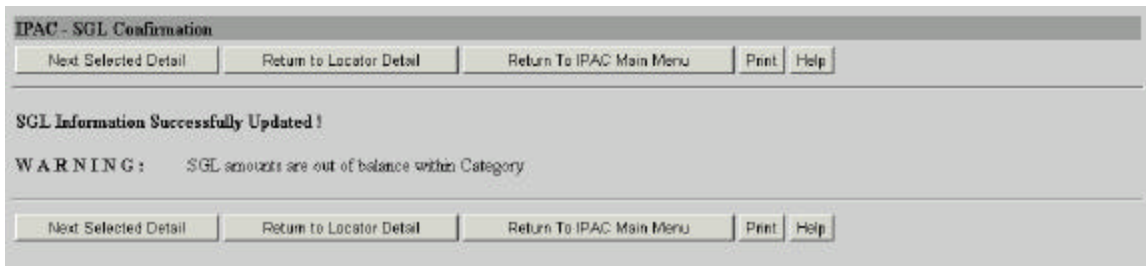


Figure 3.11a SGL Confirmation

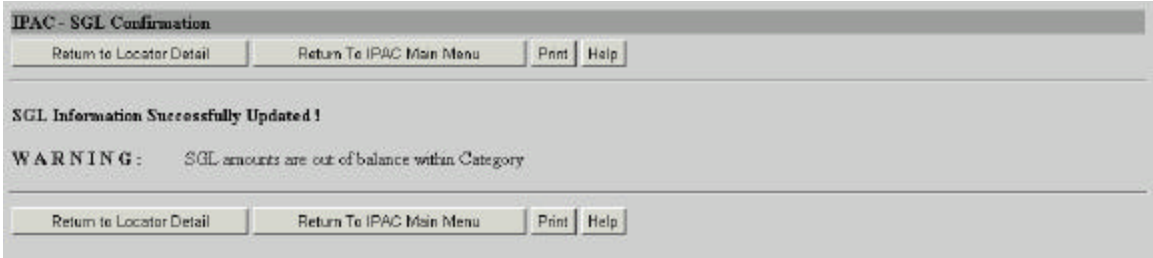


Figure 3.11b SGL Confirmation screen excluding the “Next Selected Detail” Button

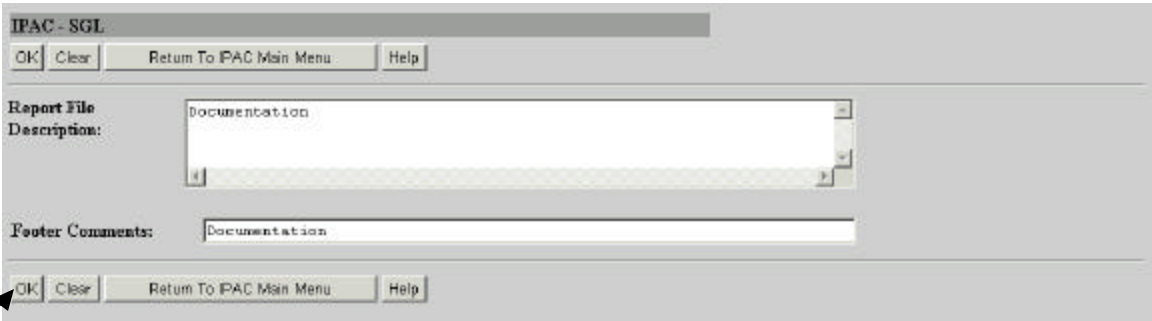


Figure 3.12 SGL Report Request

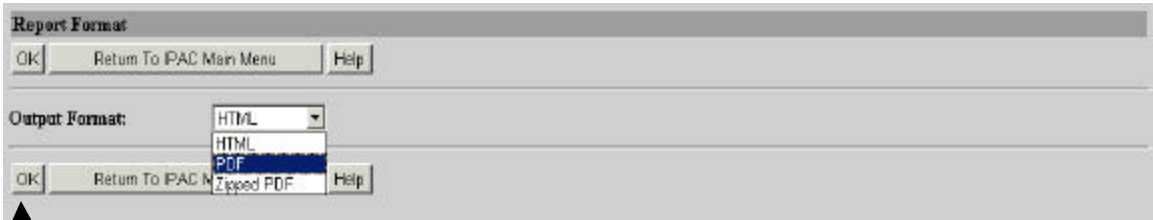


Figure 3.13 Report Format

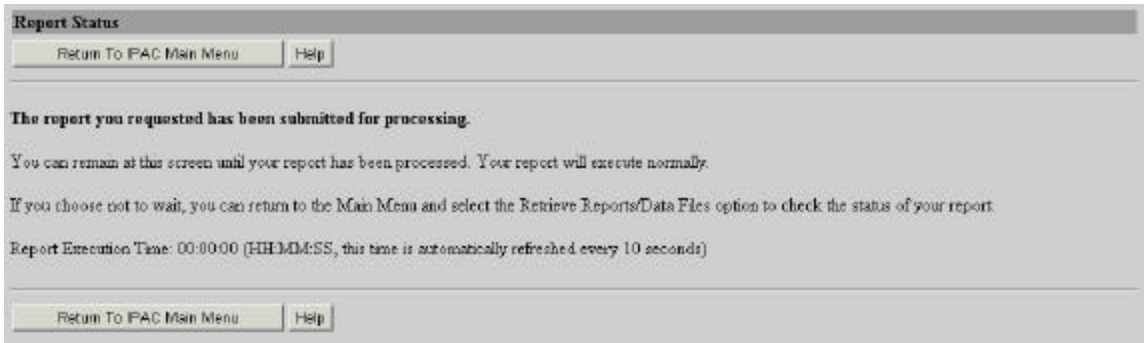


Figure 3.14 Report Status

SGL Report Columns

Sender/Receiver

Indicates whether the SGL information displayed is for the Sender or Receiver.

Note: The Report will present the most recent updated SGL information and not a history of all SGL changes that may have been made.

Category

Displays the Category information associated with the SGL account number(s).

Debit/Credit

Indicates whether the user debited or credited the SGL account for a specified SGL amount.

Amount

Displays the SGL amount.

Entering Post SGL Information for the Receiver

This option allows the Receiver to add or change SGL Information after the original transaction has been completed. As mentioned in *Section 1*, the Receiver's SGL information is not mandatory in Phase I; however the Receiver can use the Post SGL screens to enter SGL information at their discretion. The user will need information from the original transaction to enter Post SGL information. Information from the original transaction confirmation, shown in Figure 3.16, can be used.

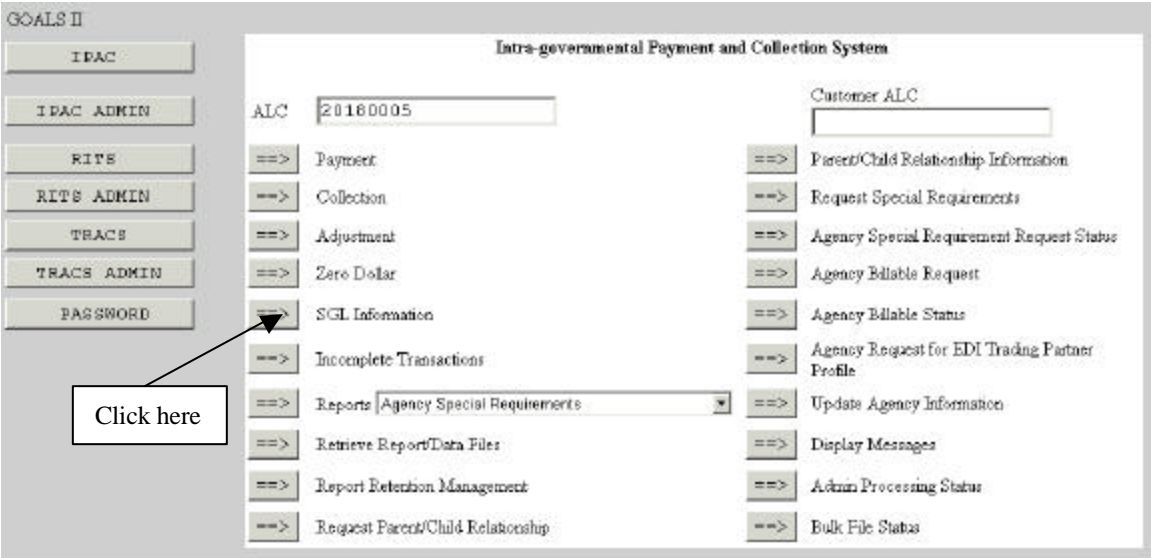


Figure 3.17 Selecting SGL Information from the IPAC Main Menu (Receiver)

To enter SGL information for the receiver side of the transaction, enter the **customer ALC** from the original transaction in the ALC field on the **IPAC Main Menu**, and click on the “SGL Information” button as shown in Figure 3.17.

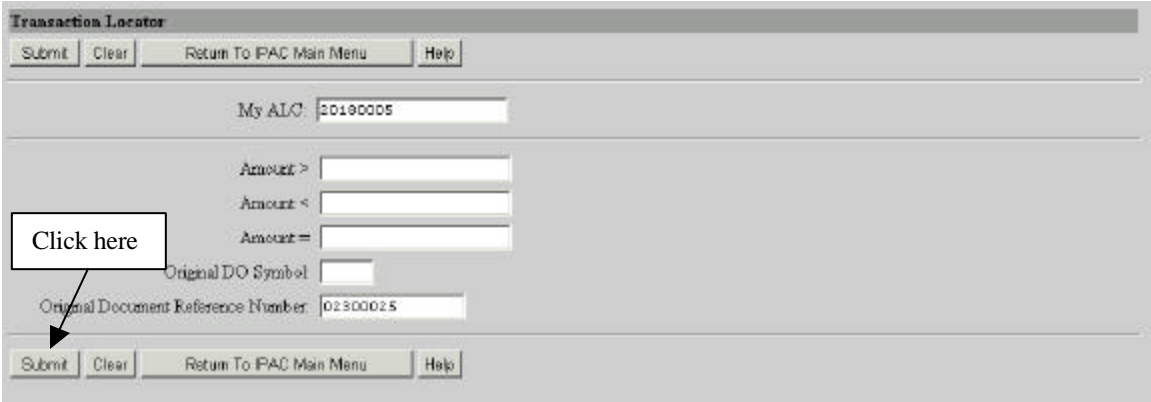


Figure 3.18 Transaction Locator

The user will be taken to the **Transaction Locator** screen, shown in Figure 3.18

Note: The data entry fields and the function buttons for this screen are the same for the Sender & Receiver and have been previously discussed in this section under **“Entering Post SGL Information for the Sender”**.

This screen allows you to search for transactions for a specified amount, greater and/or less than specified amounts, Original DO Symbol or Original Document Reference Number. The ALC is carried over from the IPAC Main Menu into the My ALC data entry field. The Original Document Reference Number is a data entry field that can be used exclusively, because document reference numbers are unique within ALC/DO symbol combination. Therefore, no other criterion is needed when searching by Original Document Reference number. The other data fields may be used together or separately to narrow the search for your transaction(s). For instance, to search for transaction amounts greater than \$20.00 but less than 100.00, you would enter “20” in the Amount > data field and “100” in the Amount < data field.

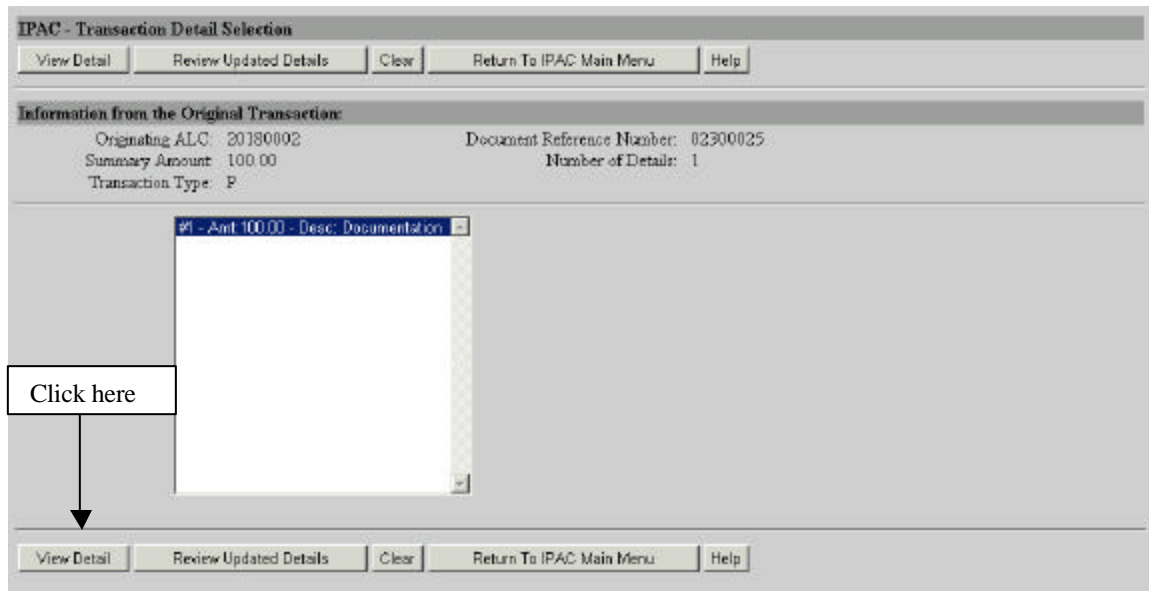


Figure 3.19 Transaction Detail Selection

The **Transaction Detail Selection** screen (shown above in Figure 3.19) allows you to select the detail for which you would like to enter SGL Information.

Note: The data entry fields and the function buttons for this screen are the same for the Sender & Receiver and have been previously discussed in this section under “**Entering Post SGL Information for the Sender**”.

Selecting the desired detail and clicking on the “View Detail” button displays the **SGL Detail View** screen (Figure 3.20).

The Receiver can choose, from the dropdown box, reciprocal SGL accounts within the same category in the “Receiver SGL Accounts (within category)” section of the **SGL Accounts** screen. Every SGL account number is associated with a category as mentioned earlier in this section. Users should be familiar with SGL accounts and their association with categories. Category and SGL accounts associations are established by FMS.

Using the SGL information shown in the above example (Figure 3.22), SGL accounts 1310 & 1610 are in categories 22D & 01D. The “Receiver SGL Accounts (within category)” section of the **SGL Accounts** screen should display SGL accounts in 22C & 01C, as shown in Figure 3.23.

If the Receiver enters “out of category” SGL accounts on the **SGL Accounts** screen, the Sender will need to enter the Post SGL screens to enter SGL accounts that will be in category with the Receiver's SGL accounts. However, the Sender does have the option (like the Receiver) to disagree with the SGL information and to enter “out of category” SGL accounts.

Note: The Sender or Receiver is not allowed to enter the same SGL number on the **SGL Accounts** screen; however the same SGL number can be used between the Sender and Receiver (if applicable). For instance, if the Sender uses SGL account number 1010, the Receiver can also use SGL account number 1010, since this SGL account number are in two corresponding categories (30C & 30D). However, the Sender can not enter 1010 twice when entering SGL data on the **SGL Accounts** screen, and the same rule applies for the Receiver.

The Receiver can enter comments to the Sender in the “Receiver’s Comments” section of the **SGL Accounts** screen, as shown in Figure 3.25.

The confirmation (Figure 3.27) **does not** display warning message “Sender and Receiver SGL/Amounts are not out balance” since the Sender and Receiver SGL accounts are within the category for that particular detail.

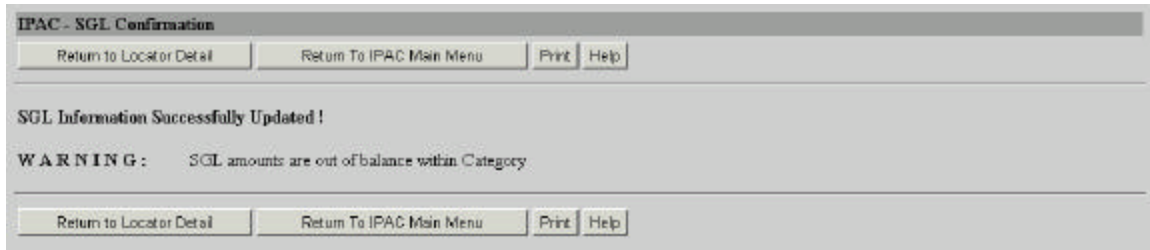


Figure 3.29 SGL Confirmation

If the Receiver enters out of category SGL accounts on the **SGL Accounts** screen (Figure 3.28) and clicks on the “Finished” button, the **SGL Confirmation** (Figure 3.29) will display.

The above confirmation (Figure 3.29) **does** display warning message “Sender and Receiver SGL/Amounts are out of balance within Category,” because the Receiver entered SGL information that was not in category with the Sender SGL accounts.

The Function buttons for the **SGL Confirmation** screen have been discussed earlier in this section under “Entering Post SGL Information for the Sender.”

Note: The Sender and Receiver can enter Post SGL information for a detail until the SGL accounts are within category.

Section 4 Adjustments

Users may enter SGL information for Adjustment transactions. To process an Adjustment to an IPAC payment or collection transaction, you must have the Document Reference Number and the Disbursing Office (DO) Symbol that was assigned to the original transaction at the time the transaction was processed and your adjustment transaction must be processed within 90 days.

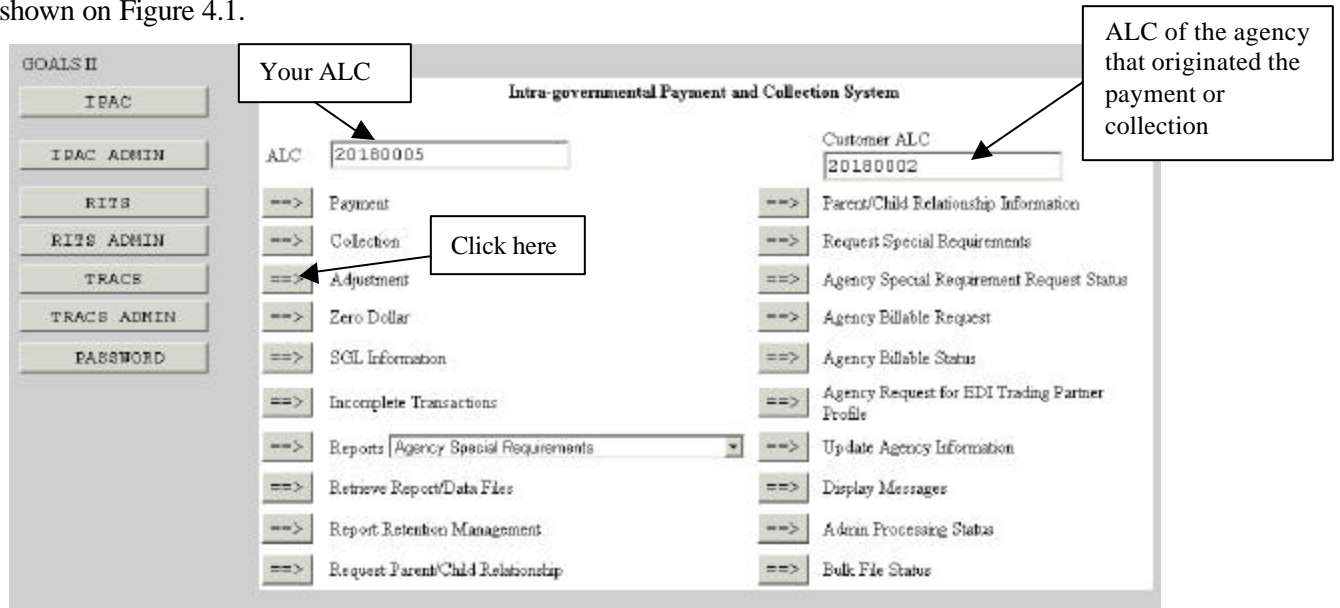


Figure 4.1 IPAC Main Menu

Entering an Adjustment through IPAC begins with the same steps as entering a Payment or Collection. Log on the IPAC system and choose the IPAC option from the IPAC Main Menu, shown on Figure 4.1.

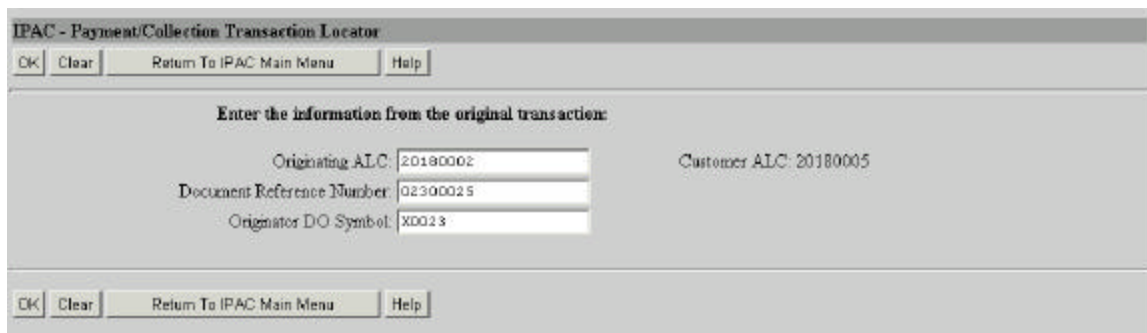


Figure 4.2 Payment/Collection Transaction Locator

Once you click the “Adjustment” button, the **IPAC- Payment/Collection Transaction Locator** screen (Figure 4.2) will display.

The **Payment/Collection Transaction Locator** screen displays information relative to the original transaction that you are adjusting. Since you can only make an adjustment to a transaction originated by another ALC, the ALC and Customer ALC are populated on this screen as the Customer ALC and Originating ALC respectively. You can, at this point, change the

Originating ALC if you want to adjust a transaction made by a different ALC. In the Document Reference Number field, you must enter the Document Reference Number which was assigned to the original payment or collection. In the Originator DO Symbol field, you must enter the DO Symbol for the ALC that originated the transaction you are adjusting.

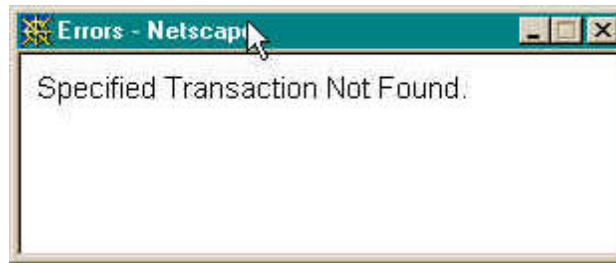


Figure 4.3 Transaction Not Found Error Message

If the transaction you have requested cannot be found, you will receive an error message similar to the one in Figure 4.3. Close the error message window and verify the document information, including the Originating and Customer ALCs, the Document Reference Number and DO Symbol.

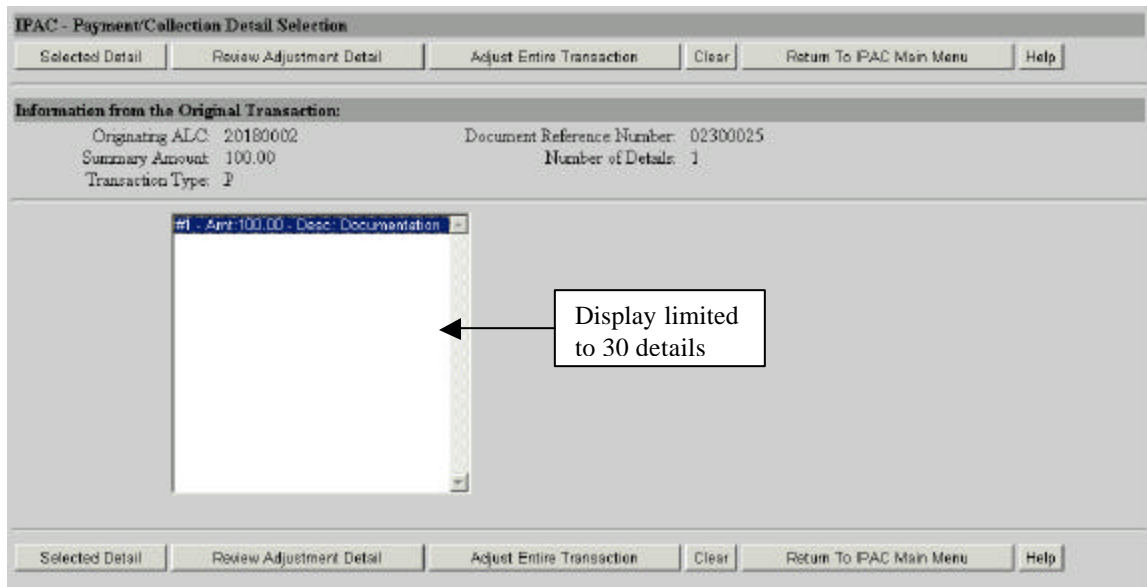


Figure 4.4 Payment/Collection Detail Selection

Note: If the number of details in a transaction exceeds the max display limit (30), additional line number data entry fields will display on this screen.

Header

This section contains the Originating ALC, the Document Reference Number, the Summary Amount, the Number of Details, and the Transaction Type (“P”ayment or “C”ollection). You cannot change the information in the header section of the screen.

All details (or line items) for the original payment or collection will appear in a scrolling window in the center of the screen. The visible items include the Detail Number, the Amount, and the beginning of the Description that was entered for this detail. You can highlight multiple line item(s) to be adjusted by using the control key.

Payment/Collection Detail Section Function Buttons

The function buttons for this screen are as follows:

“Selected Detail”

To enter an adjustment, highlight the detail line(s) to be adjusted, and click “Selected Detail”. An **Adjustment Entry** screen will display which is similar to the screen used to enter Payment and Collection transactions shown in Figure 4.6. The entire screen may not be visible when it first displays in your browser, but it can be viewed using the scroll bars on your browser window.

“Review Adjustment Detail”

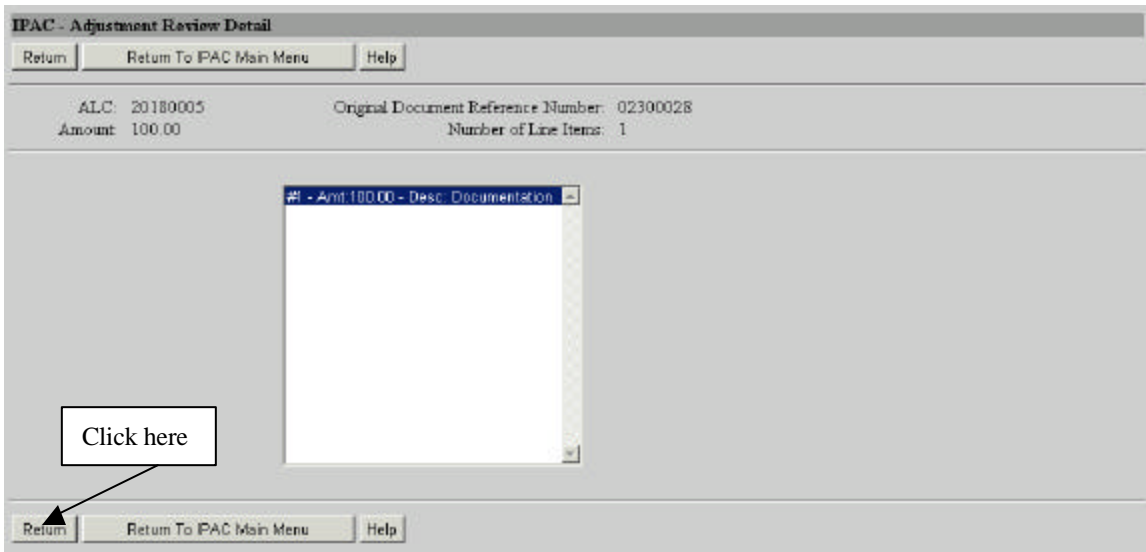


Figure 4.5 Adjustment Review Detail

To review the adjustments that have been entered, click “Review Adjustment Detail.” The **Adjustment Review Detail** screen shown in Figure 4.5, will display the adjustments which have already been made to the transaction. From that screen you can return to the **Adjustment Entry** screen, the **IPAC Main Menu**, or you can display the help screen for this page.

“Adjust Entire Transaction”

This will allow you to adjust the entire transaction.

“Clear”

All data entry fields are reset to their values the last time the screen was displayed. No data is submitted to IPAC.

“Return To IPAC Main Menu”

Returns to the **IPAC Main Menu** without entering any further adjustments. No information currently on the screen will be saved.

“Help”

Displays help information for this screen.

Adjustment Entry Header Information

Originating ALC:

This is the ALC sending the Adjustment transaction to the Customer ALC.

Customer ALC:

This is the ALC receiving the Adjustment transaction from the Originating ALC.

Number of Details:

Number of details in the transaction.

Summary Amount:

The total amount of the Adjustment.

Original Document Reference Number:

The document reference number from the original transaction.

Original Accomplished Date:

The date the original transaction was processed by IPAC.

Original Accounting Date:

The last date of the month during which the original transaction was processed by IPAC.

ALC Contact:

The name of the person that entered the IPAC transaction.

Contact Email:

The email address of the person that entered the IPAC transaction.

Contact Phone:

The telephone number of the persons that entered IPAC transaction.

Detail Information

This section displays the detail information for the detail item being adjusted. Most of these fields display information from the original transaction detail and **cannot be updated**.

The following fields from the original transaction that **can be updated** are as follows:

Receiver Treasury Account Symbol

Allows the user to provide the Treasury Accounts Symbol for the Receiver.

Sender Treasury Account Symbol

A required field for the Treasury Account Symbol of the Sender.

Note: The Sender's Treasury Account Symbol should always be pre-filled and carried over from the original transaction, since the Sender's Treasury Account Symbol is mandatory. However, IPAC allows the Sender to provide different Treasury Account Symbol data from the Original transaction in case the ALC had re-classified the funds after the original IPAC had been processed.

Detail Amount

This is the amount of your adjustment to the detail line of this payment or collection. It represents the net change to the originally processed amount, NOT a replacement amount,

for the detail item. Adjustments can only reduce the original amount. This is NOT calculated from the Quantity and Unit Price fields. This field is required and must be greater than zero, but less than or equal to the original detail line item amount.

Contact Name

Allows the user to enter the name of the person entering the adjustment.

Contact Phone

Allows the user to telephone number of the person entering the adjustment.

Transaction Description

This is your description of the adjustment being made to this detail item. This is not a required field, but it is recommended that you provide the reason for the adjustment. This field is indicated with an (*) on this screen because ALC 20180002 has a special requirement that requires all adjustment transactions processed against this ALC to provide a reason for the adjustment in the transaction description field.

When you have entered the adjustment detail amount and description, you have a choice of several function buttons in the next section of the screen.

Adjustment Entry Function Buttons

“Finished”

This button finalizes the adjustment, submitting the Header information and all entered lines of Detail adjustment information for processing. If a required field is blank or an error is detected, an error message will display and the cursor will be placed in the entry field where the error occurred. If no error is detected, an **Adjustment Confirmation Screen**, similar to the one in Figure 4.12, will display.

“Previous or Next Detail”

These buttons will display as appropriate to allow you to move from one detail item of a transaction to another.

“Sender SGL Account”

This button provides a way to allocate the detail amount of the Adjustment into **Standard General Ledger (SGL) Accounts**. It is required in Phase I to provide Sender SGL information for an Adjustment transaction.

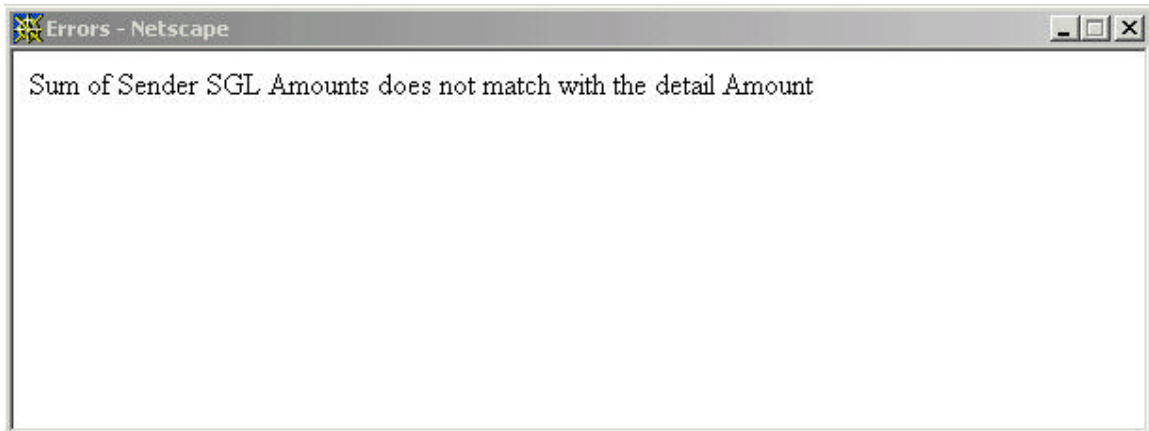


Figure 4.8 SGL Error Message

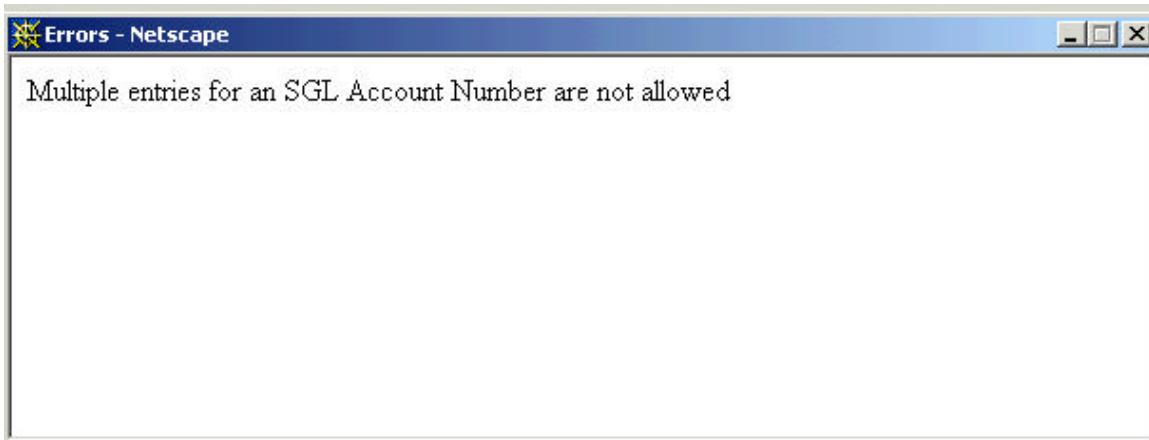


Figure 4.9 Multiple Entries for an SGL Account Number error message

Note: The Originating ALC (Sender) or the Customer ALC (Receiver) of the Adjustment transaction can enter the Post SGL screens to update SGL information via the SGL information button on the IPAC Main Menu.

“Review Detail”

This button is selected when you have finished entering the information for the current line of detail. If no error is detected, the detail information will be saved to temporary storage and the Summary Amount and the Number of Details fields in the Header Section will be updated to reflect the amounts you have entered for this line item. You will be returned to the **Adjustment Review Detail** screen shown in Figure 4.5. No information is permanently committed to the database at this point. The information is not committed to the IPAC database until the “Finished” button is clicked to submit the entire adjustment.

“Special Requirements”

This will display the **Adjustment Special Requirements** screen as shown in figure 4.11.

“Clear”

All data entry fields are reset to their values the last time the screen was displayed. No data is submitted to IPAC.

“Return to Selection List”

No data on the current screen will be saved. You will be returned to the **Payment/Collection Detail Selection** screen shown in Figure 4.4.

“Return to IPAC Main Menu”

No data entered on the current screen will be saved to IPAC. Partial transactions may be stored temporarily for later completion through the “Incomplete Transaction” option on the IPAC Main Menu. You will be returned to the **IPAC Main Menu**.

“Help”

Displays help information for this screen.

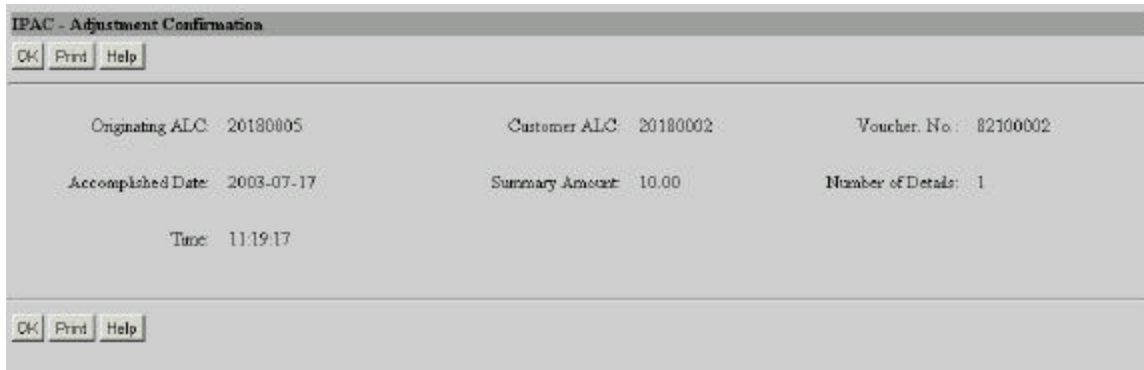


Figure 4.12 Adjustment Confirmation

Note: The Voucher Number can be used in the Post SGL screens to locate an adjustment transaction. The user may use the Voucher Number in the “Original Document Reference Number” data entry field on the “**Transaction Locator** screen (see *Section 3 Post SGL Information*) as a search criterion.

Accomplished Date

The date the adjustment transaction was processed by IPAC.

Summary Amount

The total amount of the adjustment.

Number of Details

The number of line items entered for the adjustment.

Time

The time the adjustment was processed by IPAC. Displayed in military time.

Note: These fields are for display only. You cannot change the information in any of these fields.

Adjustment Confirmation Screen Buttons

“OK”

Confirms that you have viewed the information displayed and returns you to the **IPAC Main Menu**.

“Print”

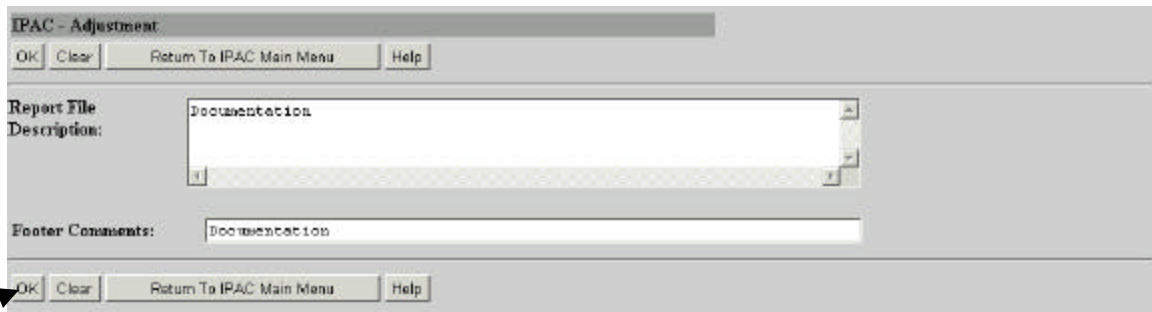


Figure 4.13 Adjustment Report Request

Prints the transaction just entered. Clicking on the “Print” button from the **Adjustment Confirmation** screen (Figure 4.12) will display the **Adjustments Report Request** screen (Figure 4.13).

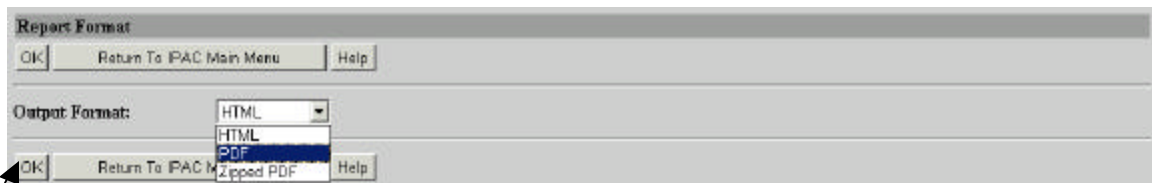


Figure 4.14 Report Format

Zipped PDF (Compressed Portable Document Format)

A compressed file format which must be “unzipped” or decompressed before being read or printed with the Adobe Acrobat Reader.

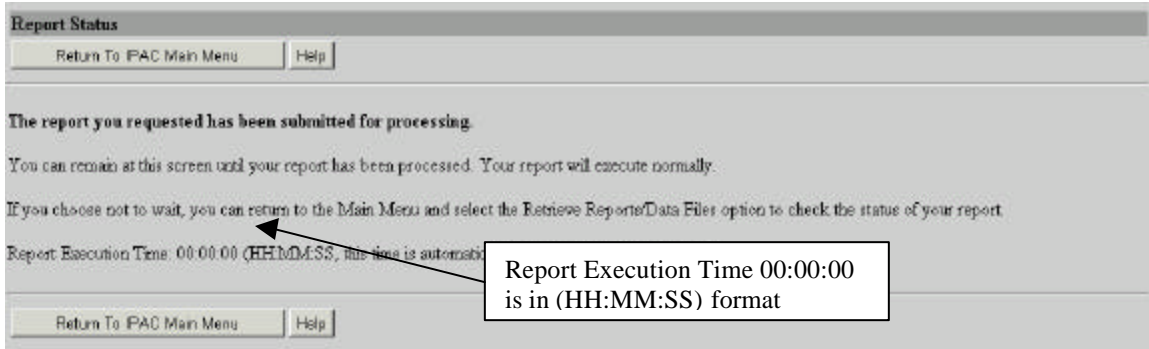


Figure 4.15 Report Status

Adjustment Confirmation Report Header Information

Originating ALC:

The agency sending the adjustment.

Customer ALC:

The agency receiving the adjustment.

Voucher Number:

The document number generated by IPAC for the adjustment transaction. This is similar to the Document Reference Number in Payments and Collections and the Trace Number in Zero Dollar.

Summary Amount:

The total amount of the adjustment transaction.

Adjustment:

The type of transaction. (Should always read "Adjustment")

Original Transaction Type:

The type of transaction for the Original Transaction ("Payment" or "Collections")

Accomplished Date:

The date a transaction was processed by IPAC.

Accounting Date:

The last date of the month during which a transaction was processed by IPAC.

Number of details:

Number of details in the adjustment transaction.

Adjuster DO Symbol:

Do Symbol for the ALC sending the Adjustment.

ALC Contact:

The name of the person that entered the IPAC transaction.

Contact Email:

The email address of the person that entered the IPAC transaction.

Contact Phone:

The telephone number of the person that entered the IPAC transaction.

The Adjustment Confirmation Report displays transaction and detail information under the header information. It will also display any updates to the Receiver Treasury Account Symbol and Sender Treasury Account Symbol.

Section 5 Zero Dollar

With the implementation of Phase I, zero dollar transactions are no longer used to provide SGL account information to your trading partner, however this functionality can still be used to correct information sent in an earlier transaction or convey additional information. The Post SGL screens discussed in *Section 4* will be used to update/change SGL information for the Sender and Receiver. Zero dollar transactions are not used to transfer funds. The additional data entry fields discussed in *Section 2* are included on the Zero Dollar transaction.

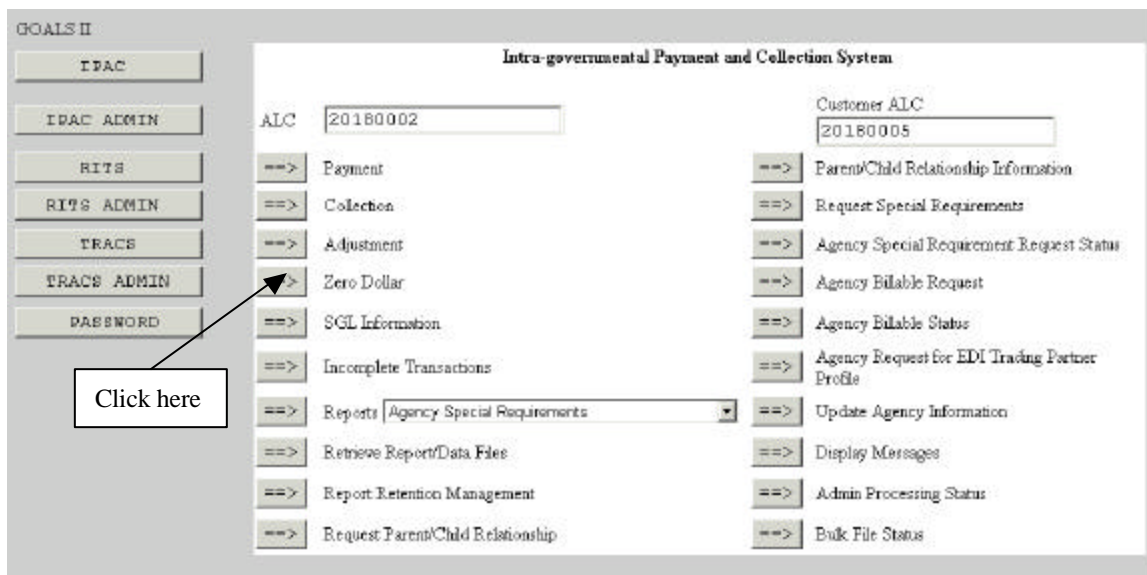


Figure 5.1 IPAC Main Menu

Entering a Zero Dollar transaction through IPAC is very similar to processing a payment or collection transaction. Enter your ALC and Customer ALC and click the “Zero Dollar” button from the **IPAC Main Menu** is shown in Figure 5.1.

After completing both ALC fields, click on "Zero Dollar" as shown in Figure 5.1. The **Zero Dollar Entry** screen will display as shown in Figure 5.2.

Header

The Header section of the **Zero Dollar Entry** screen (Figure 5.2) contains the Originating ALC, which is the ALC of the agency generating the transaction. This is the ALC that you entered, or selected, in the ALC field on the **IPAC Main Menu** (Figure 5.1). It also contains the Customer ALC, which is the Customer ALC you entered on the **IPAC Main Menu** for the agency receiving this transaction.

The ALC Contact listed is the name of the person associated with the Logon ID used to access the IPAC System. The Contact Phone and Contact Email are the telephone number and e-mail address associated with the Logon ID as well.

The Summary Amount shown is the sum of all the Detail Amounts that have been entered for this transaction. Since Zero Dollar transactions are used for informational purposes only and not to

transfer funds, this amount will always be \$0.00. The Number of Details is the number of detail lines (line items), which have been entered for this transaction. Since you cannot enter multiple lines of detail for a Zero Dollar transaction, this field will always be 0 or 1.

None of the fields in the Header area of this screen can be entered or changed.

Detail Information

The Detail Information section contains data entry fields, none of which are required for a Zero Dollar Transaction, though a description is recommended for reference. The **Zero Dollar Entry Screen** now displays the new fields Sender Duns, Sender Duns + 4, Receiver Duns and Receiver Duns + 4.

Zero Dollar Entry New Data Fields

The **Zero Entry** screen has the following new data entry fields:

Sender DUNS

A 9-digit number that is assigned by Dun and Bradstreet associated with the registering entity (Office or Division) for the Sender. This number serves as the unique ID for each record.

Sender DUNS + 4

This is a 4-digit extension to your Sender DUNS that the user creates. It is used if you have more than one ALC or DO per office and need to differentiate between the lines of business in one office.

Receiver DUNS

A 9-digit number that is assigned by Dun and Bradstreet associated with the registering entity (Office or Division) for the Receiver. This number serves as the unique ID for each record.

Receiver DUNS + 4

This is a 4-digit extension to your Receiver DUNS that the user creates. It is used if you have more than one ALC or DO per office and need to differentiate between the lines of business in one office.

Although the Detail Information section contains no required fields, if you choose to enter a Sender Treasury Account Symbol, Receiver Department Code or Unit of Issue, IPAC will verify that they contain valid data.

The Cross Reference Document Reference Number is a field where you may enter the document reference number from the original transaction that is being updated or corrected by this Zero Dollar transaction.

Since Zero Dollar transactions are used to transmit information and not to transfer money, the Detail Amount is set to \$0.00 and cannot be changed.

Zero Dollar Entry Function Buttons

“Finished”

Processes the transaction you have entered in the IPAC database and displays the confirmation screen (Figure 5.3).

“Return to IPAC Main Menu”

No data entered on the current screen will be saved to the IPAC database. You will be returned to the **IPAC Main Menu**.

“Clear”

All data entry fields are reset to their values the last time the screen was displayed. No data is submitted to the IPAC database.

“Help”

Displays help information for this screen.

Note: The ““Sender SGL Accounts” button has been removed from this screen since the new Post SGL screens discussed in *Section 3* will be used to update/change SGL information for the Sender and Receiver.

Zero Dollar Confirmation Screen Columns

Originating ALC

The agency initiating the Zero Dollar transaction.

Customer ALC

The agency receiving the Zero Dollar transaction from the Originating ALC.

Trace Number

The document number generated by IPAC for the Zero Dollar transaction. This is similar to the Document Reference Number in Payments and Collections and the Voucher Number in Adjustments.

Accomplished Date

The date a transaction was processed by IPAC.

Summary Amount

The Summary Amount will always be \$0.00 since Zero Dollar transactions are used only to transmit information and not to transfer money.

Number of Details

The number of line items entered for this transaction, which will always be 1.

Time

The time a transaction was processed by IPAC. Displayed in military time.

Zero Dollar Confirmation Screen Buttons

“OK”

Confirms that you have viewed the information displayed. You will be returned to the **IPAC Main Menu**.

“Print”

Prints the transaction just entered. Clicking on the “Print” button from the **Zero Dollar Confirmation** screen will display the **Zero Dollar Report Request** screen (Figure 5.4).

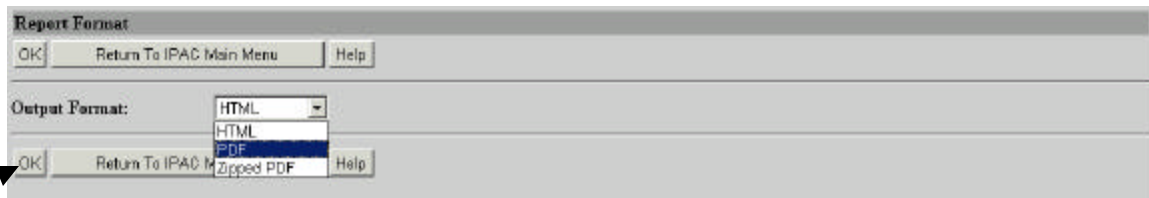


Figure 5.5 Report Format

Report Output Menu Options

HTML (Hyper Text Markup Language)

The document format used on the World Wide Web. Choose this option to view the report immediately. This is the default choice. The report is generated in HTML format and displays in the IPAC Report Viewer.

PDF (Portable Document Format)

A file format, read with Adobe Acrobat™ Reader, for saving the report to be viewed or printed on-line. The Acrobat reader must be available to view or print the report.

Zipped PDF (Compressed Portable Document Format)

A compressed file format which must be “unzipped” or decompressed before being read or printed with the Adobe Acrobat Reader.

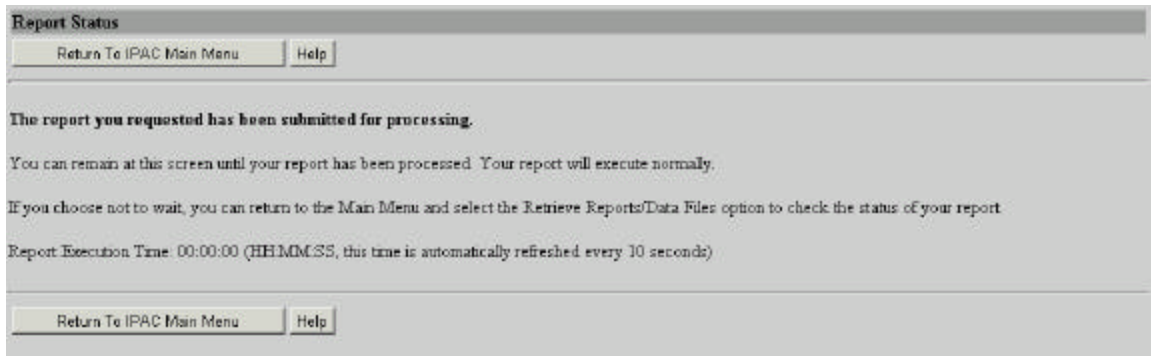


Figure 5.6 Report Status

Clicking on the “OK” button from the **Report Format** screen (Figure 5.5), displays the **Report Status** screen (Figure 5.6).

Originating ALC:

The agency initiating the Zero Dollar transaction.

Customer ALC:

The agency receiving the Zero Dollar transaction from the Originating ALC.

Trace Number:

The document number generated by IPAC for the Zero Dollar transaction. This is similar to the Document Reference Number in Payments and Collections and the Voucher Number in Adjustments.

Summary Amount:

The Summary Amount will always be \$0.00 since Zero Dollar transactions are used only to transmit information and not transfer money.

Zero Dollar:

The type of transaction. (Should always read "Zero Dollar")

Cross Document Reference Number:

The Document Reference number from the Original transaction that the user would like to refer to when making a Zero Dollar transaction.

Accomplished Date:

The date the zero dollar transaction was processed by IPAC.

Accounting Date:

The last date of the month during which a transaction was processed by IPAC.

Number of details:

Number of details in the transaction.

Original DO Symbol:

DO Symbol for the Originating ALC.

ALC Contact:

The name of the person that entered the IPAC transaction.

Contact Email:

The email address of the person that entered the IPAC transaction.

Contact Phone:

The telephone number of the person that entered the IPAC transaction.

The Zero Dollar Confirmation Report displays transaction and detail information under the header information, if applicable.

Section 6 Third Party Submitter

Beginning on October 11, 2003, with the implementation of Phase I, users with access to the third party functionality will be able to submit bulk files for other agencies and pull Third Party Reports. Third Party agencies will be assigned to an ALC and given 2 logon IDs, one giving the Third Party Submitters access to send bulk files for all ALCs and the other giving them the access to pull reports via the online IPAC application. However, the Third Party agencies will only be allowed to view transaction data via the online system for bulk files they have submitted.

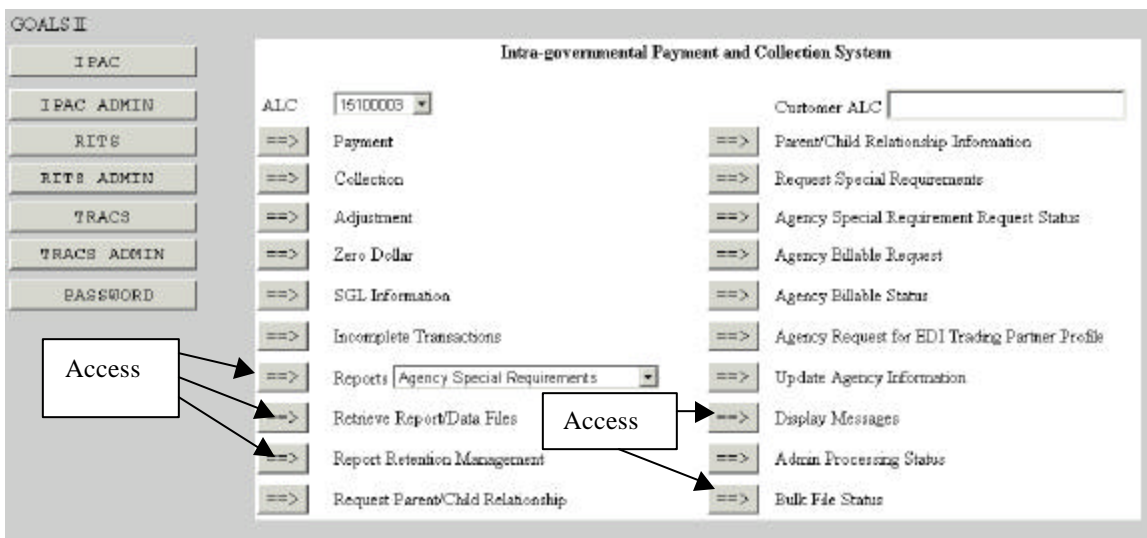


Figure 6.1 IPAC Main Menu- Third Party Submitter Access

Third Party Submitters only have access to Retrieve Reports/ Data Files, Report Retention Management, Display Messages, Bulk File Status, and Reports on the IPAC Main Menu as shown in Figure 6.1.

Functionality for Retrieve Report/Data Files, Report Retention Management, and Display Messages are discussed in the *IPAC Base Manual*. This Addendum will only discuss some functionality for Bulk File Status, however all functionality for the Bulk File Status can be reviewed in the *Bulk File Addendum*. The Third Party Report is the only report discussed in this section; Agency Special Requirements, IPAC Transactions Report Download and IPAC Transaction Report Selection are covered in *Sections 7, 8, and 9*. Treasury Reporting Requirements and Predecessor/Successor reports are covered in the *IPAC Base Manual*.

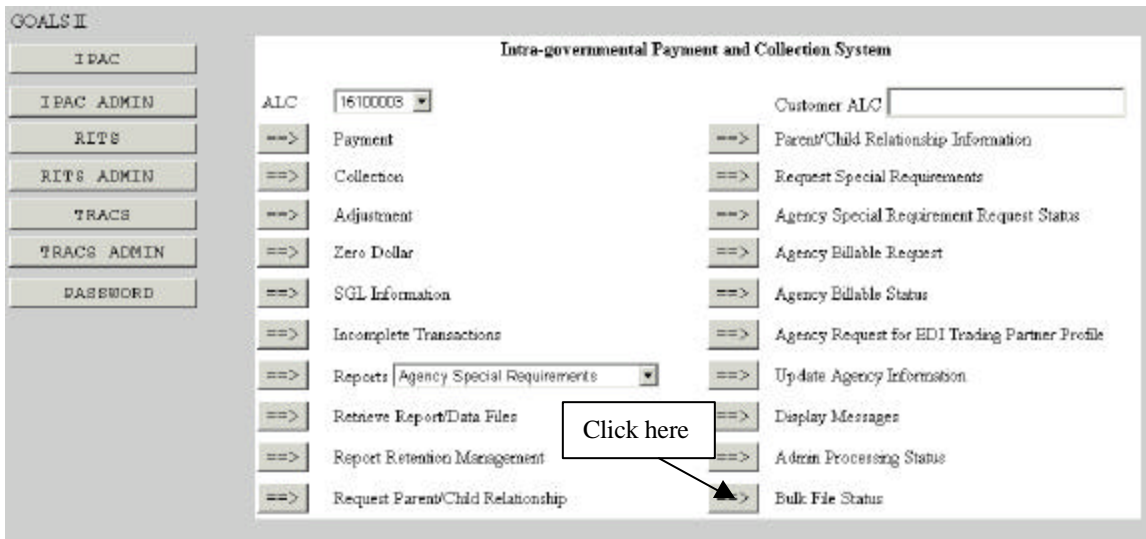


Figure 6.2 Selecting the Bulk File Status from the IPAC Main Menu

The Primary purpose of the third party functionality is to enable an ALC to submit transactions on behalf of an originating ALC and a Customer ALC, neither which ALC is their own. Once the Third party submitter has uploaded their bulk file, they can check the status of the file by clicking on the “Bulk File Status” button from the IPAC Main Menu shown in Figure 6.2.

This section will only cover the "Bulk File Status Inquiry" and "Bulk File Confirmation" screens and functionality for Third Party Submitters.

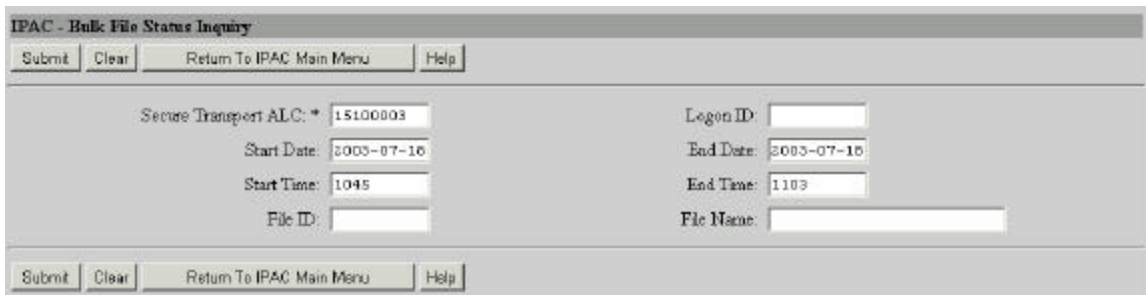


Figure 6.3 Bulk File Status Inquiry

This screen allows you to enter specific parameters to retrieve the status of the bulk file(s) desired. The Secure Transport ALC is the only required field on this screen, which is denoted with an asterisk. If you enter your Secure Transport ALC and leave other data entry fields on this screen blank, and select the "submit" button, you will receive bulk file status information for the previous 100 files (25 per page) submitted by the Secure Transport ALC provided. All other data entry fields for the **Bulk File Status Inquiry** (Figure 6.3) screen are optional fields. However, if you enter a Start Date, you must enter an End Date.

Bulk File Status Inquiry Data Entry Fields

The **Bulk File Status Inquiry** screen has the following data entry fields:

Secure Transport ALC:

This is the Secure Transport ALC directory that was used to submit the bulk file. This is not always the ALC for which transactions originate from within your bulk file.

Start Date:

The date, to be entered in YYYY-MM-DD format, that the search for Bulk File Status information is to begin.

End Date:

The date, to be entered in YYYY-MM-DD format, that the search for Bulk File Status information is to end.

Start Time:

The time, to be entered in military format, that the search for Bulk File Status information is to begin. Please reference *Appendix B* for a military time conversion chart.

End Time:

The time, to be entered in military format, that the search for Bulk File Status information is to end. Please reference *Appendix B* for a military time conversion chart.

Logon ID:

The alphanumeric characters assigned to the user to uniquely identify that user. The Logon ID of the person that submitted the file(s) can be entered in this data entry field.

File ID:

A unique number assigned by the application for each PCA bulk file submitted.

Note: You will not know the File ID for your file until you access the **Bulk File Status Inquiry Results** screen, shown in Figures 6.4 and 6.5. You may record the File ID for your file from the **Bulk File Status Inquiry Results** screen, and you can then use the File ID number as a parameter on the Bulk File Inquiry screen, shown in Figure 6.3, at a later time.

File Name:

This is the name of the file that was submitted. The Bulk File Submitter names the file. You may use the asterisk (*) and the percent (%) signs, as wild cards in the File Name data entry field. For instance, if you want to retrieve all your files that start with the letter "T", you could simply enter the following in the File Name data entry field: T*

Bulk File Status Inquiry Function Buttons

There are 4 function buttons on Bulk File Status Inquiry screen (Figure 6.3):

“Submit”

Accepts the information on the screen, and displays the specified results on the **Bulk File Status Inquiry Results** screen shown in Figures 6.3 and 6.4.

“Clear”

Resets the data entry fields to their values the last time the screen was displayed. No data is submitted.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu** without generating bulk file status results.

“Help”

Displays the system help information.

Selecting **“Submit”** from the **Bulk File Status Inquiry Results** screen will display the screen shown in Figure 6.4.

This screen displays the results from the parameters entered on the **Bulk File Status Inquiry** screen.

Bulk File Status Inquiry Results Columns

The **Bulk File Status Inquiry Results** screen has the following columns:

Date:

Displays the file(s) submission date.

Time:

Displays the file(s) submission time, in military time. Please reference *Appendix B* for a military time conversion chart.

Current Status:

Displays the current status of files submitted. The following messages are possible status messages for your file(s):

- File Transfer Started
- File Transfer Completed
- File Storage Started
- File Storage Completed
- Transaction Processing Started
- Transaction Processing In Process
- Transaction Processing Completed

Additional Information:

Displays any additional information for your file(s). For example, if your file receives a current status message of “Transaction Processing Started,” you may receive a “50% transactions processed” message under the Additional Information column for your file, as well as number of errors in the file, if any. The messages in the Additional Information column are designed to give you a more descriptive status of your file.

File Name:

Displays the name of the file. This column contains the file name that was used to upload the bulk file.

File ID:

A unique number assigned by the application for each PCA bulk file submitted.

Secure Transport ALC:

This is the Secure Transport ALC directory that was used to submit the bulk file. This is not always the ALC for which transactions originate from within your bulk file.

Logon ID:

Displays the Login ID of the person that submitted the file.

Bulk File Status Inquiry Results Function Buttons

If you want to review processing information related to a bulk file listed on the **Bulk File Status Inquiry Results** screen, you must select the option button for the status of the bulk file you want to view. Once you have selected the bulk file, you may select the “View History”, “View Confirmation”, “View Errors”, or the “View File” button to get information about the file. The option buttons are mutually exclusive and you can only select one bulk file at a time. If you want to refresh the screen results, perform a new search, return to the Main Menu or obtain help, an option does not need to be selected. The function buttons for the **Bulk File Status Inquiry Results** screen (Figure 6.4) are as follows:

“View History”

Displays the **View History** screen. This screen is further discussed in the *Bulk File Addendum*.

“View Confirmation”

Displays the **View Confirmation** screen, shown in Figure 6.5.

“View Errors”

Displays the **View Errors** screen. This screen is further discussed in the *Bulk File Addendum*.

“View File”

This allows you to view the data contained in your file on the **View File** screen. This screen is further discussed the *Bulk File Addendum*.

“Refresh”

Updates the information for “Current Status” and “Additional Information” to the most current information for your file(s).

“New Search”

Returns you to the **Bulk File Status Inquiry** screen.

“Next”/“Previous”

If there are more than 25 files, a “Next” button will display and this button will bring up the next 25 files or less. A “previous” button will display when needed to allow you to navigate between the **Bulk File Status Inquiry Results** screens.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu**.

“Help”

Displays the system help for this screen.

Clicking on the “View Confirmation” from the **Bulk File Status Inquiry Results** screen, will display the **View Confirmation** screen, shown in Figure 6.5.

View Confirmation Header Information

Submitted Date:

Displays the submission date of your file.

Submitted Time:

Displays the submission time of your file, in military time. Please reference *Appendix B* for a military time conversion chart.

Logon ID:

Displays the Logon ID of the person that submitted the file.

File ID:

The unique number assigned by the application for this particular bulk file submitted.

File Name:

Displays the name of the file.

Grand Net Total:

Payment, Collection and Adjustments are netted together. There will be a “CR” if the net total is a collection and there will not be a “CR” if the net total is a disbursement.

Trans Submitted:

The number of transactions in the file received by IPAC for that Sender ALC.

Trans Accepted:

The number of transactions accepted and processed successfully by IPAC for that Sender ALC.

Trans Rejected:

The number of transactions rejected by IPAC for that Sender ALC.

Note: A confirmation will only be generated if at least one transaction in the file processed successfully.

View Confirmation Columns

Sender ALC

This is the ALC(s) sending the transaction(s) to the receiving (customer) ALC(s).

Net Total

Total dollar amount of the transactions (payment, collection and adjustment) netted together in the file **per** Sender ALC.

Starting Document Reference Number

The first document reference number used by the Sender ALC for the bulk file. The document reference number can be assigned by IPAC or by the bulk file submitter.

Ending Document Reference Number

The last document reference number used by the Sender ALC for the bulk file. The document reference number can be assigned by IPAC or by the bulk file submitter.

Note: The document reference numbers assigned by the application may not be sequential because of multi-threading of files. There may be more than one file processing simultaneously and document reference numbers are assigned as transactions are completed.

Trans Submitted

The number of transactions in the file received by IPAC for that Sender ALC.

Trans Accepted

The number of transactions accepted and processed successfully by IPAC for that Sender ALC.

Trans Rejected

The number of transactions rejected by IPAC for that Sender ALC..

View Confirmation Function Buttons

The function buttons on the **View Confirmation** screen are as follows:

“Print”

Allows you to print the Bulk File Confirmation Report, see Figure 6.9 for a sample report.

“View Errors”

If you have errors in your file (rejected transactions), this selection will direct you the **View Errors** screen. Please refer to the *Bulk File Addendum* for more information on the **View Errors** screen.

“Next”/“Previous”

If there are more than 50 rows, a “Next” button will display and this button will bring up the next 50 files or less. A “previous” button will display when needed to allow you to navigate between the **View Confirmation** screens

“Return to Bulk File Status Inquiry Results”

Returns you to the **Bulk File Status Inquiry Results** screen.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu** screen.

“Help”

Displays the system help information.

Bulk File Confirmation Report

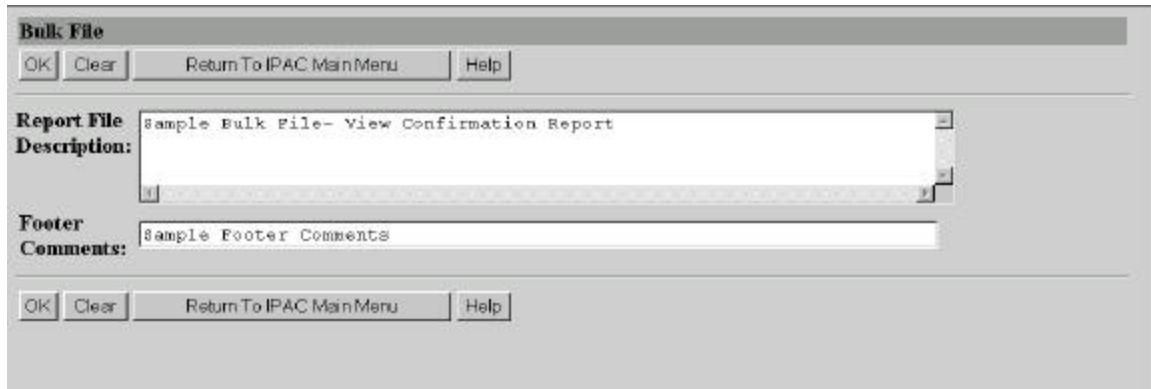


Figure 6.6 Bulk File Report Request Screen

From the **View Confirmation** screen, shown in Figure 6.5, you may print your results. To print the Bulk File Confirmation Report, select the “Print” function button from **View Confirmation** screen, and the **Bulk File Report Request** screen will display, shown below in Figure 6.6.

Bulk File Report Request Data fields

There are two data entry fields on this screen. It is not mandatory that you complete either field, but it is highly recommended the Report File Description field be completed.

Report File Description

This field is used to name and/or describe the report. It will be this name or description that displays in the system when a report is later retrieved for viewing, printing or deleting. This description does not print on the report itself.

Footer Comments

This field is printed on the bottom of each page of the report.

Bulk File Report Request Function Buttons

There are 4 function buttons on the **Bulk File** Report Request screen.

“OK”

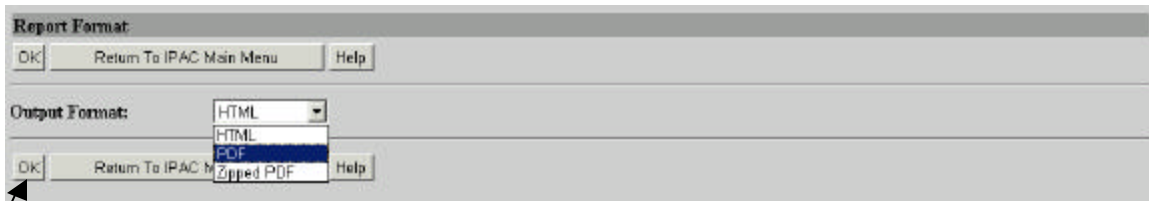


Figure 6.7 Report Format Screen- Output Format Menu

Accepts the report description and footer comments on the screen, extracts the report contents from the database and displays the Report Format shown in Figure 6.7.

“Clear”

Resets the data entry fields to their values the last time the screen was displayed. No data is submitted.

“Return to IPAC Main Menu”

Returns you to the **IPAC Main Menu**.

“Help”

Displays the system help for this screen.

Selecting “OK” from the **Bulk File** Report Request Screen will display the **Report Format** screen shown in 6.7. This screen provides you with a drop-down menu option of output formats. Select the drop down arrow next to the Output Format: box to display the format menu, as shown in Figure 6.7.

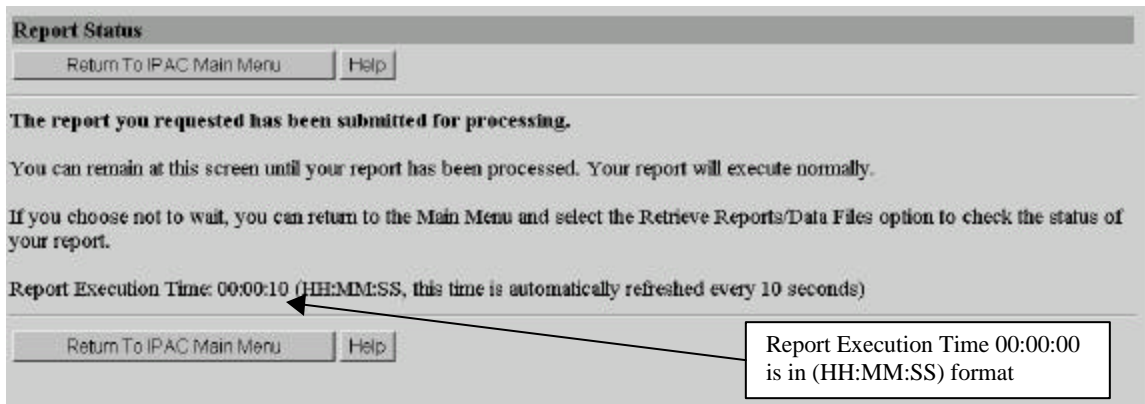


Figure 6.8 Report Status

The **Report Status** screen displays when the IPAC application begins report generation. You can remain at this screen until your report has been completed, and the report will execute normally. The Report Execution Time is displayed on this screen, which is the elapse time it takes the application to generate your report. The Report Execution Time is shown in (HH:MM:SS) format, which stands for Hour(s): Minute(s): Second(s). This time is automatically refreshed every 10 seconds. If you choose not to wait, you can return to the Main Menu and select the “**Retrieve Reports/Data Files**” option to check the status of your report. For a sample of a Bulk File Confirmation Report, see Figure 6.9.

Trans Submitted:

The number of transactions in the file received by IPAC.

Trans Accepted:

The number of transactions accepted and processed successfully by IPAC.

Trans Rejected:

The number of transactions rejected by IPAC.

Logon ID:

Displays the Logon ID of the person that submitted the file.

File ID:

A unique number assigned by the application for each bulk file submitted.

File Name:

Displays the name of the file.

Current Status:

Displays the current status of file submitted.

Bulk File Confirmation Report Columns

Sender ALC

This is the ALC(s) sending the transaction(s) to the receiving (customer) ALC(s).

Net Total

Total dollar amount of the transaction (payment, collection and adjustment) netted together in the file per Sender ALC.

Trans Submitted

The number of transactions in the file received by the IPAC for that Sender ALC.

Trans Accepted

The number of transactions accepted and processed successfully by IPAC for that Sender ALC.

Trans Rejected

The number of transactions rejected by the IPAC system for that Sender ALC.

Starting Document Reference Number

The first document reference number used by the Sender ALC for the bulk file. The document reference number can be assigned by IPAC or by the bulk file submitter.

Ending Document Reference Number

The last document reference number used by the Sender ALC for the bulk file. The document reference number can be assigned by IPAC or by the bulk file submitter.

Note: The document reference numbers assigned by the application may not be sequential because of multi-threading of files. There may be more than one file processing simultaneously and document reference numbers are assigned as transactions are completed.

Third Party Submitter Report

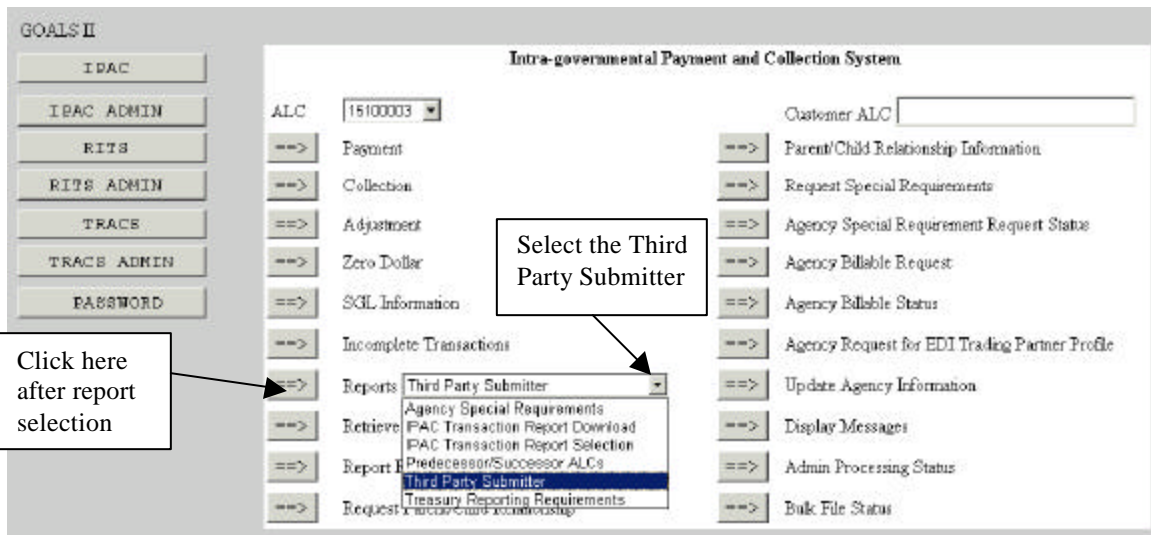


Figure 6.10 Selecting the Third Party Report from the IPAC Main Menu

To retrieve the Third Party Submitter Report, and view transactions submitted by the Third Party ALC, highlight and select the **Third Party Submitter** option from the “Reports” drop-down menu on the IPAC Main Menu. The **Third Party Submitter** will then show in the selection window next to the “Reports” button. Click “Reports” as shown in Figure 6.10.

This description does not print on the report itself. If the field is left blank, the IPAC system will automatically add "Third Party Submitter" in this data entry field.

Third Party ALC

Enter the Third Party ALC.

Start Date

The date of the first transaction(s) to be retrieved in the report.

End Date

The date of the last transaction(s) to be retrieved in the report.

Footer Comments

This field is printed on the bottom of each page of the document or report. The footer comments can be used for miscellaneous purposes.

Transaction Type

Select a Transaction Type to be reflected on the report. You can choose Payment, Collection, Adjustment or All. Selecting All will cause the report to show Payment, Collection and Adjustment transactions. Each Transaction Type label has an option button to its left. These choices are mutually exclusive and only one may be selected at a time. A selection is required.

You have the option of retrieving your report in one of the following three Report Formats:

Standard

This option is the default choice. It allows one detail per page on the IPAC Transaction Report with a second page that contains the Sender and Receiver SGL Information.

Condensed

This option allows you to retrieve an IPAC Transaction Report showing more than one detail per page including Standard General Ledger (SGL) information.

Report Request Screen Function Buttons

There are 4 function buttons on the Report Request screen (Figure 6.11):

“OK”

Accepts the information on the screen for the report description and report footer comments, extracts the report contents from the database and displays the **Report Format** screen shown Figure 6.12.

“Clear”

Resets the data entry fields to their values the last time the screen was displayed. No data is submitted.

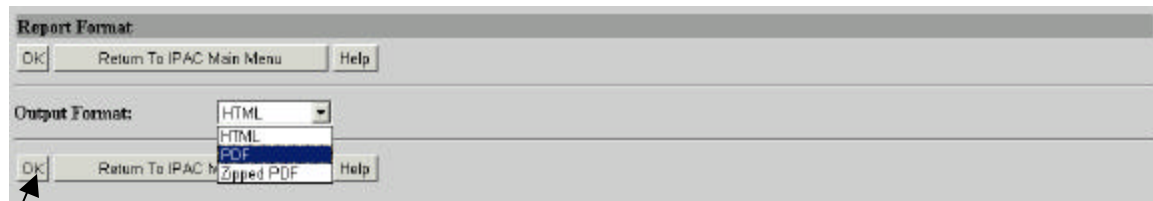

A file format, read with Adobe Acrobat™ Reader, for saving the report to be viewed or printed on-line. The Acrobat reader must be available to view or print the report.

Zipped PDF (Compressed Portable Document Format)

A compressed file format which must be “unzipped” or decompressed before being read or printed with the Adobe Acrobat Reader.

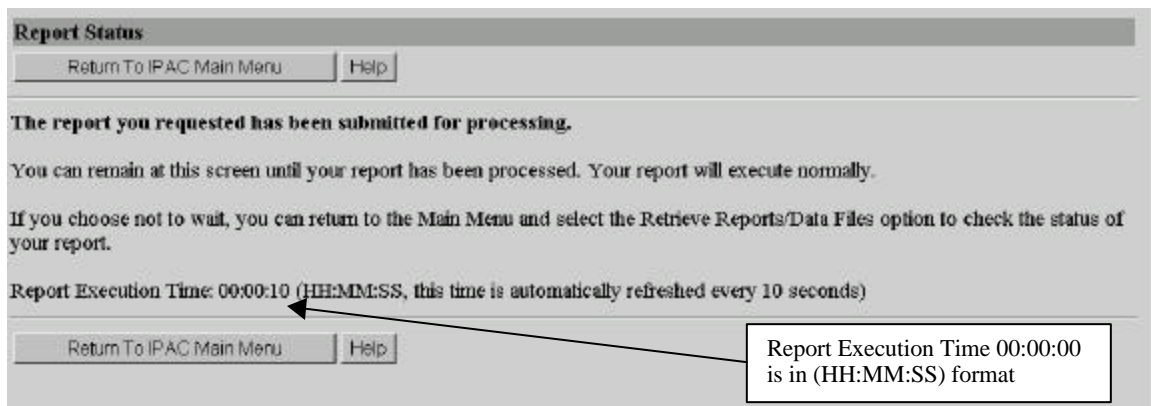


Figure 6.13 Report Status

Third Party Report Header Information

Originating ALC:

This is the ALC originating (sending) the transaction to the Customer (receiving) ALC.

Customer ALC:

This is the ALC receiving the transaction from the originating ALC.

Submitter ALC:

This is the ALC that was used to submit the transaction on behalf of the Sender and Receiver ALCs. This is the Third Party Submitter's ALC.

Payment/ Collection/ Adjustment:

This column indicates whether the transaction is a payment, collection or adjustment.

Document Reference:

The number that is assigned to the transaction.

Note: A voucher number will be displayed if the transaction is an adjustment.

Summary Amount:

The total amount of the transaction (a sum of Detail Amounts).

Accomplished Date:

The date a transaction was processed by IPAC.

Accounting Date:

The last date of the month during which the transaction was processed by IPAC.

Number of details:

Number of detail in the transaction.

Originator DO Symbol:

DO Symbol for the originating ALC.

ALC Contact:

The name of the person entered the IPAC transaction.

Contact Phone:

The telephone number of the person that entered IPAC transaction.

Contact Email:

The email address of the person that entered the IPAC transaction.

The Third Party Report displays transaction and detail information under the header information.

Section 7 IPAC Transaction Report Selection

This report option allows an individual ALC to produce IPAC transaction reports for a specified ALC. As mentioned in *Section 6*, Third Party Submitters have to the capability to submit files for all ALCs, therefore users will now have the capability to retrieve the IPAC Transaction Report including, excluding or isolating the transactions submitted by the Third Party Submitter for that user's ALC.

Since SGL information is mandatory for the Sender (Originating) ALC, the Report Formats for the IPAC Transaction Report have been limited to "Standard" and "Condensed". The Condensed with and without SGL formats have been eliminated.

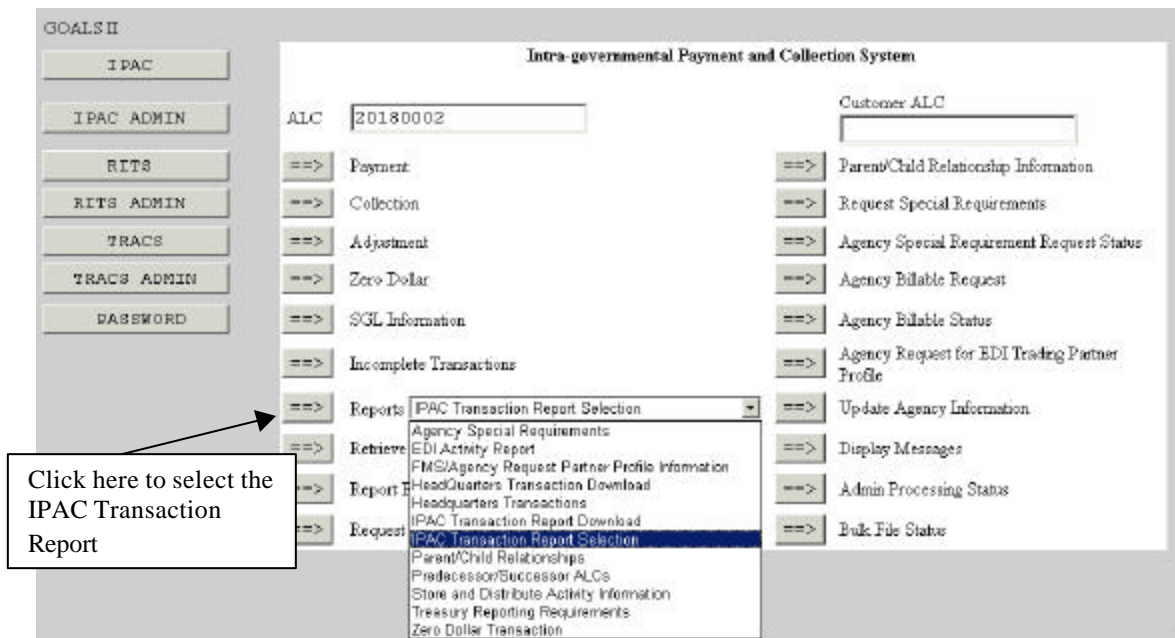


Figure 7.1 Selecting the IPAC Transaction Report from the IPAC Main Menu

To retrieve the IPAC Transaction Report, highlight and select the **IPAC Transaction Report Selection** option from the "Reports" drop-down menu on the IPAC Main Menu. **The IPAC Transaction Report Selection** will then show in the selection window next to the "Reports" button. Click "Reports" as shown in Figure 7.1

This description does not print on the report itself. If the field is left blank, the IPAC system will automatically add “ – IPAC Transaction Report Selection” in this data entry field.

ALC

Enter the ALC whose transactions you are authorized to retrieve reports for.

Start Date

The date of the first transaction(s) to be retrieved in the report.

End Date

The date of the last transaction(s) to be retrieved in the report.

Footer Comments

This field is printed on the bottom of each page of the document or report. The footer comments can be used for miscellaneous purposes.

Third Party Submitter Data:

Indicate whether you would like to retrieve the IPAC Transaction Report including, excluding or isolating (only) the transactions submitted by the Third Party Submitter for that user’s ALC.

Transaction Type

Select a Transaction Type to be reflected on the report. You can choose Payment, Collection, Adjustment or All. Selecting All will cause the report to show Payment, Collection and Adjustment transactions. Each Transaction Type label has an option button to its left. These choices are mutually exclusive and only one may be selected at a time. A selection is required.

Sorting Options

Different sorting options are offered depending on whether you are retrieving transactions Sent By Your ALC or transactions Received by Your ALC. Select whether you want the report to reflect transactions sent by your ALC or received by your ALC by choosing a sort order listed under one of these options. Each sorting option label has an option button to its left. These options are mutually exclusive and only one may be selected at a time.

Sent By Your ALC

If you are requesting information on transactions sent **by** your ALC, you have the following sort options:

ALC

The transactions will be sorted by the Customer ALC who received the transactions.

Document Reference Number

The transactions will be sorted by the Document Reference Number assigned to the transaction at the time it was processed. When assigned by the IPAC System, these numbers are assigned sequentially. In this case, the transactions will also be sorted in date order, by date of transaction completion. This may not be true for originators that assign their own document reference numbers.

Appropriation

An appropriation is also called a Treasury Account Symbol. The transactions will be sorted by the Sender Treasury Account Symbol.

Totals Only

Under this option, the individual transaction details will not be displayed. The report shows Transaction totals only, sorted by receiving ALC.

Received By Your ALC

If you are requesting information on transactions sent **to** your ALC, you have two sort options:

ALC

The transactions will be sorted by the Originating ALC who sent the transactions.

Totals Only

Under this option, the individual transaction details will not be displayed. The report shows transaction totals only, sorted by sending ALC.

Report Format

As mentioned earlier, since SGL information is mandatory for the Sender (Originating) ALC, the Report Formats for the IPAC Transaction Report have been limited to “Standard” and “Condensed”. The Condensed with and without SGL information have been eliminated.

Standard

This option is the default choice. It allows one detail per page on the IPAC Transaction Report. A second page is generated with the Standard General Ledger SGL information.

Condensed

This option allows you to retrieve an IPAC Transaction Report showing more than one detail per page including Standard General Ledger (SGL) information.

Note: The Totals Only Reports are only available in the Standard Report Format. However, the IPAC system will allow you to select the Condensed Report Format option for the Totals Only Reports. You will retrieve a Standard Report when selecting either one of the three Report Formats mentioned above.

Report Request Screen Function Buttons

There are 4 function buttons on the Standard Report Request screen (Figure 7.2):

“OK”

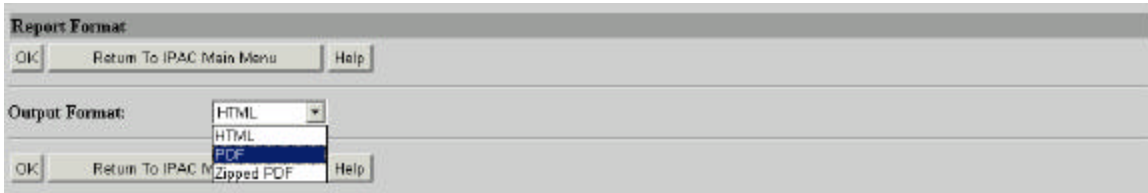


Figure 7.3 Report Format screen Output Format Menu

Accepts the information on the screen for the report description and report footer comments, extracts the report contents from the database and displays the **Report Format** screen shown in Figure 7.3.

“Clear”

Resets the data entry fields to their values the last time the screen was displayed. No data is submitted.

“Return to IPAC Main Menu”

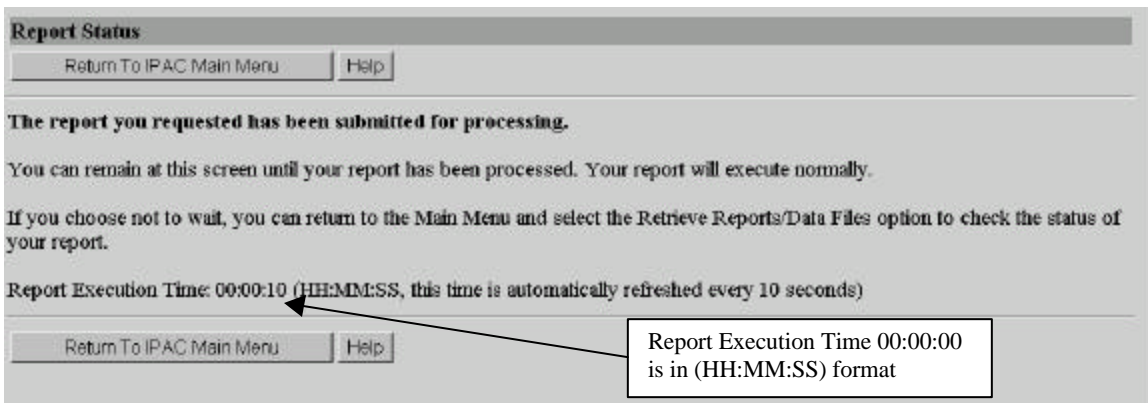


Figure 7.4 Report Status

The Report Execution Time is displayed on this screen, which is the elapse time it takes the application to generate your report. The Report Execution Time is shown in (HH:MM:SS) format, which stands for Hour(s): Minute(s): Second(s). This time is automatically refreshed every 10 seconds. If you choose not to wait, you can return to the Main Menu and select the **“Retrieve Reports/Data Files”** option to check the status of your report.

IPAC Transaction Report Header Information

Originating ALC:

This is the ALC originating (sending) the transaction to the Customer (receiving) ALC.

Customer ALC:

This is the ALC receiving the transaction from the originating ALC.

Submitter ALC:

This is the Third Party Submitter's ALC; this field will be blank if the transaction was not submitted by a third party.

Payment/ Collection/ Adjustment:

This column indicates whether the transaction is a payment, collection or adjustment.

Document Reference:

The number that is assigned to the transaction.

Note: A voucher number will be displayed if the transaction is an adjustment.

Summary Amount:

The total amount of the transaction (a sum of Detail Amounts).

Accomplished Date:

The date a transaction was processed by IPAC.

Accounting Date:

The last date of the month during which the transaction was processed by IPAC.

Number of details:

Number of detail in the transaction.

Originator DO Symbol:

DO Symbol for the originating ALC.

ALC Contact:

The name of the person that entered the IPAC transaction.

Contact Email:

The email of the person that entered the IPAC transaction.

The IPAC Transaction Report displays transaction and detail information under the header information.

Section 8 IPAC Transaction Download

This menu option exports transaction data by ALC from IPAC in a standardized format. It produces a Comma Separated Value (CSV) or Tab Separated Value (TSV) file that can be imported by other software for further data analysis or processing. The CSV and TSV layouts have been adjusted to accommodate new fields for Eliminations, like the Sender and Receiver DUNS & DUNS +4. The updated CSV and TSV layouts can be viewed in the updated *IPAC CSV/TSV Layout for Federal Program Agencies* on the GOALS II IPAC website: <http://www.fms.treas.gov/goals/ipac>.

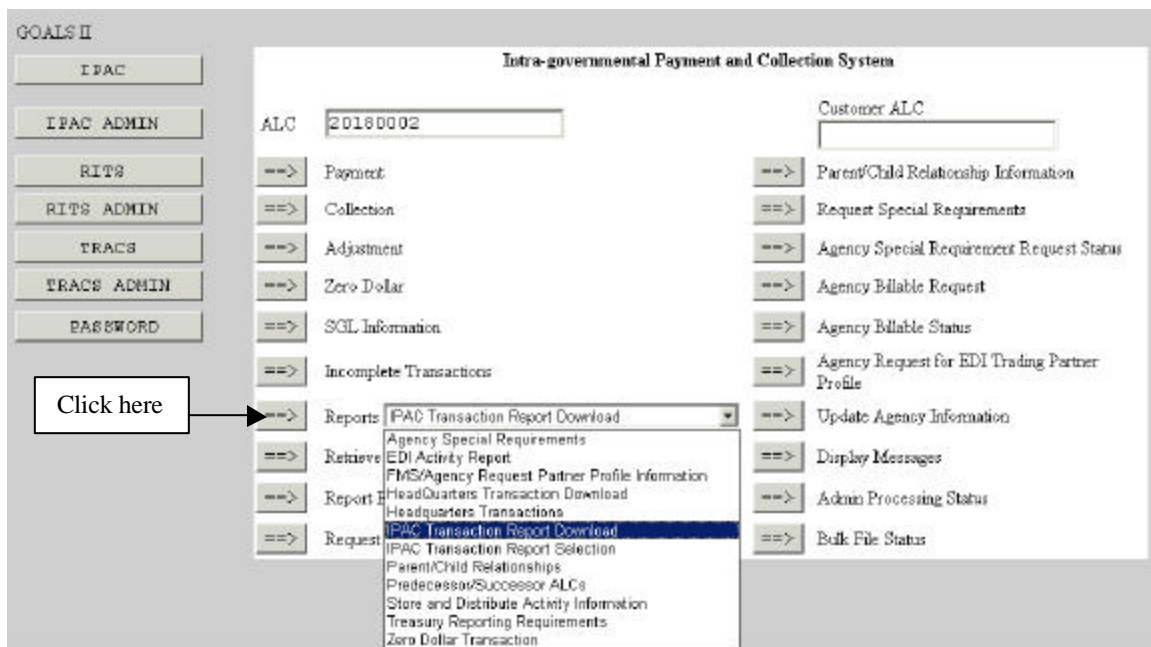


Figure 8.1 IPAC Transaction Report Download

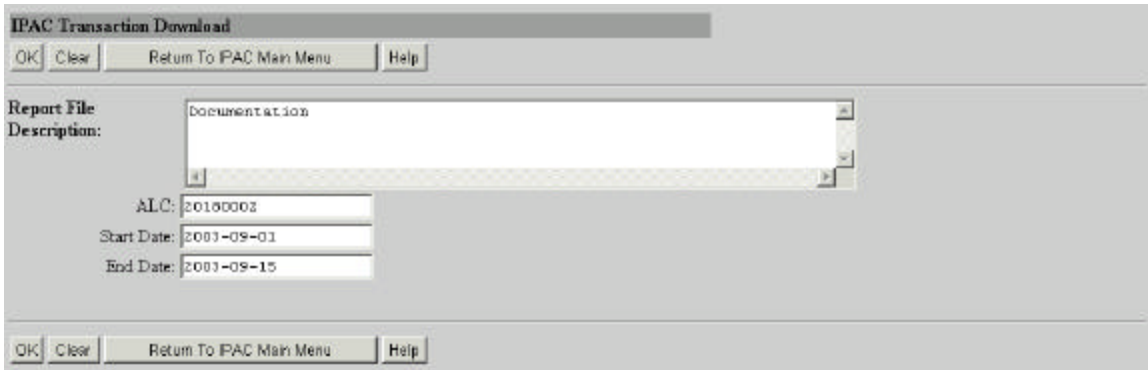


Figure 8.2 IPAC Transaction Download Report Selection

Selecting this menu option will not provide the capability to produce HTML or PDF files for direct viewing or printing. When you highlight the **IPAC Transaction Report Download** option and select the “Reports” button, from the IPAC Main Menu (Figure 8.1), the **Report Request** screen shown in Figure 8.2 will display.

Report File Description

Enter a Report File Description as described in the Viewing and Printing Documents segment of the *Introduction* in the IPAC Base Manual. Although this field is optional, it is strongly recommended that you enter a Report File Description to help you identify this report in the future. This information will later be used to identify and retrieve or delete the report from the IPAC System.

ALC

If you entered an ALC on the **IPAC Main Menu**, it will display in the ALC data entry box. You may enter an ALC if none displays, or you may change the ALC already in the box. This field is required.

Report Dates

Enter a Start Date and an End Date for the report in YYYY-MM-DD format. These fields are required. Selecting “OK” from the **IPAC Transaction Download Report Selection** screen will display the **Report Format** screen shown in Figure 8.3.

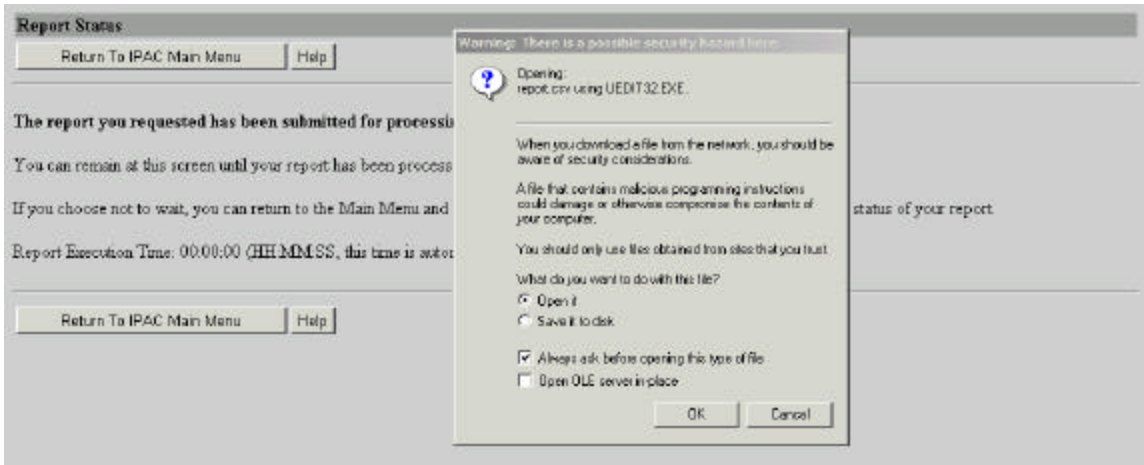


Figure 8.4 Report Status

Your output format choices are CSV, TSV, Zipped CSV & Zipped TSV. These file types are intended for exporting data to other software rather than for direct viewing by the user. Click “OK” from the **Report Format** screen and the **Report Status** screen, shown in Figure 8.4, will display.

You may receive a Warning Window, as shown above, giving you the option to open the file or save it to review at a time. Clicking “OK” from the Warning Window will display your report (Figure 8.5) or allow you to save your report.

Note: The report continues vertically for numerous pages, therefore the above example is not a complete CSV report.

Saving Data in CSV or TSV Format

Both CSV and TSV formats can be used to transfer the raw data from IPAC to another program, which will format the data for viewing, printing or internal use the user.

CSV is a file format that separates data fields with commas. The character data is usually surrounded by quotes. TSV is a file format that uses tab characters as separators between fields. Unlike CSV files, the character data is not usually surrounded by quotes. The format you choose will depend on the requirements of the program that will be importing the data. The standard Windows “Save File...” Dialogue Box is where you can name the output file, choose the location for the file and specify the type of file to save. The location and name you choose for the file will depend on your computer’s configuration, your agency’s procedures and the program that will be importing the data.

Zipped files are formats which must be “unzipped” or decompressed before being read or printed with the Adobe Acrobat Reader.

Section 9 Agency Special Requirements

There are certain fields on each Payment, Collection or Adjustment transaction that are required in order for IPAC to process the transaction. For Phase I, the Sender TAS and Sender SGL will be required for all IPAC transactions. These required fields should be set up by FMS as an IPAC required field, however agencies also have the capability of requesting fields as an agency requirement through the “Request Special Requirements” menu option from the IPAC Main Menu. After FMS’s approval, this will require any ALC submitting a transaction against your ALC to provide the specific information you need to reconcile your accounts.

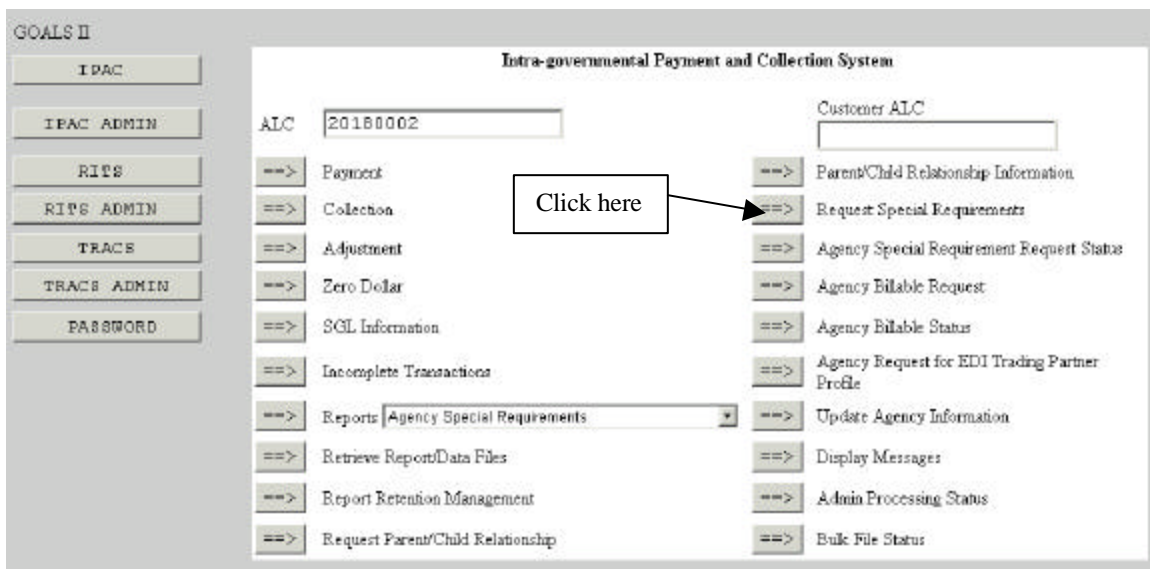


Figure 9.1 Request Special Requirements function from the IPAC Main Menu

To access this function, click on the “Request Special Requirement” from the **IPAC Main Menu** as shown in Figure 9.1.

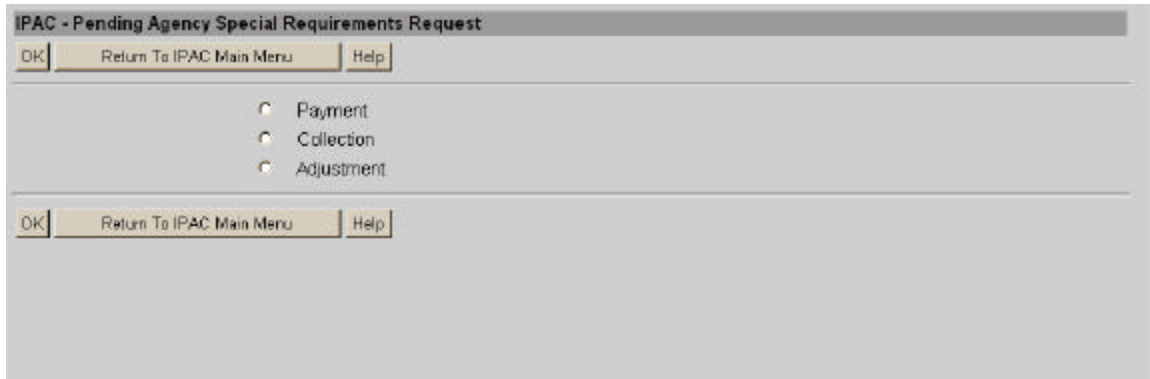


Figure 9.2 Pending Agency Special Requirements Request

Once you have completed the ALC field, and selected the “Request Special Requirements” button on the **IPAC Main Menu**, the **Pending Agency Special Requirements Request** screen shown in Figure 9.2 will display.

Special Requirements may be requested for Payment, Collection or Adjustment transactions. Each transaction type has an option button to its left and is mutually exclusive.

Pending Agency Special Requirements Request Function Buttons

“OK”

Displays the **Store Agency Special Requirements Request** screen for the selected transaction type as shown in Figure 9.3.

“Return to IPAC Main Menu”

With the exception of the header line in Figure 9.4, the **Store Agency Special Requirements Request** screen is identical in appearance and functionality for both Payments and Collections. Any data entry fields designated as an IPAC required field for a payment, collection or adjustment will be denoted with an asterisk (*). These fields will always be required.

Store Agency Special Requirements Request Data Columns

Required?

This column contains drop-down boxes with “Y”es and “N”o choices. Choose **Y** if you want the field to be required for transactions sent to your ALC, and **N** if you do not want the field to be required. All IPAC required fields denoted with an **asterisk (*)** must remain **Y**.

Data Element

This column specifies the field for which you are requesting a Special Requirement. All data entry fields from the Transaction Entry screens will display in the data element list.

Start Date

Date the Special Requirement is requested to start in YYYY-MM-DD format. For new requests, the Start Date must be the following day (tomorrow) or later. Please request the Special Requirement far enough in advance to allow your trading partner sufficient time to provide you with the new required information. For fields that you want to change from **N** to **Y**, the Start Date will default to tomorrow’s date. The date can be manually changed to a future date. The Special Requirement will not be in effect until it is approved by FMS.

End Date

Date the Special Requirement is requested to end in YYYY-MM-DD format. The End Date must be later than the Start Date. Default dates will display but can be manually changed.

Description

This is an optional description of your reason for requesting the Special Requirement.

Note: If an approved Special Requirement is already established, and a second is submitted, the first one in effect is replaced by the new one. (i.e. The start and end dates of the new request will replace those of the old one).

Store Agency Special Requirements Request Function Buttons

“Finished”

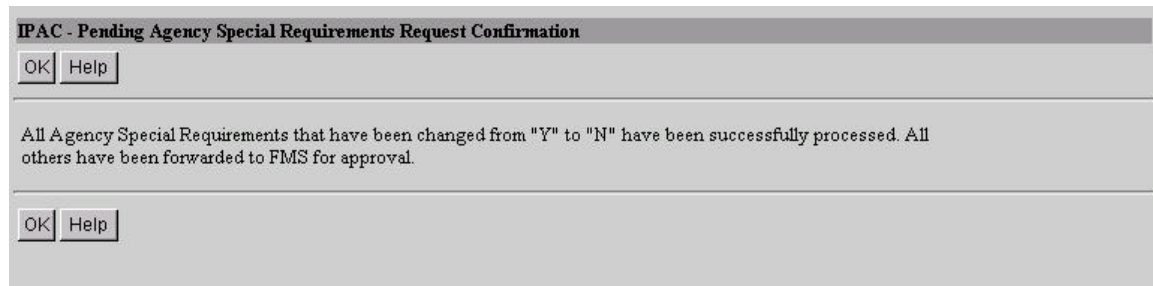


Figure 9.5 Pending Agency Special Requirements Request Confirmation

Submits the Special Requirements changes. Field changes from **Y** to **N** will be processed immediately and do not require FMS approval. Field changes from **N** to **Y** will be forwarded to FMS for approval as shown in Figure 9.5 - **Pending Agency Special Requirements Request Confirmation**.

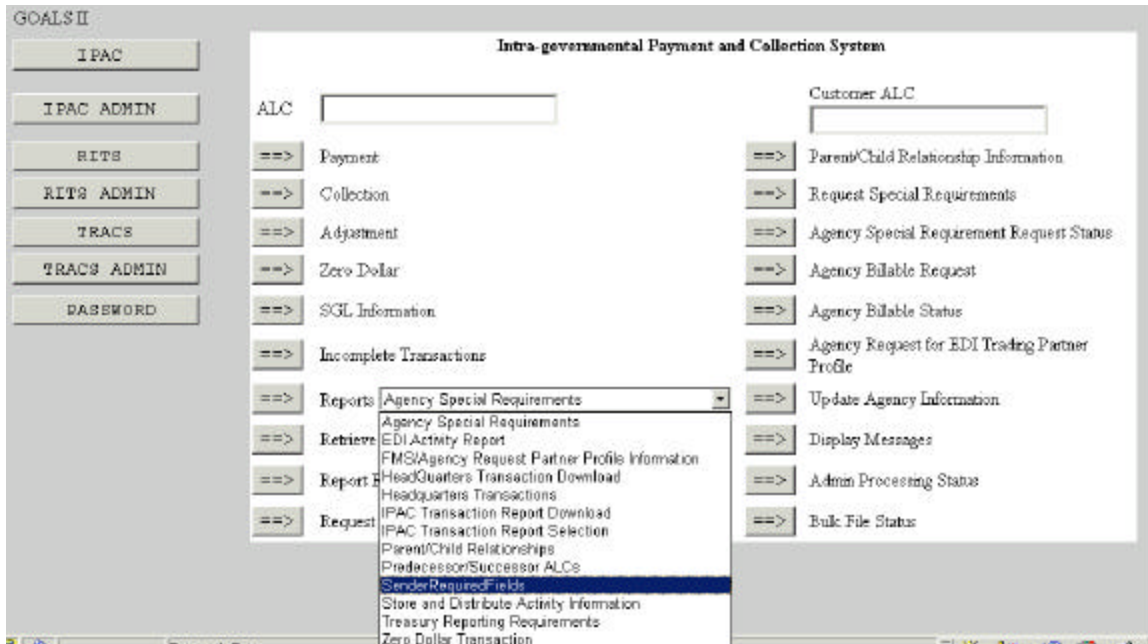


Figure 10.1 Selecting the Sender Required Fields Report from the IPAC Main Menu

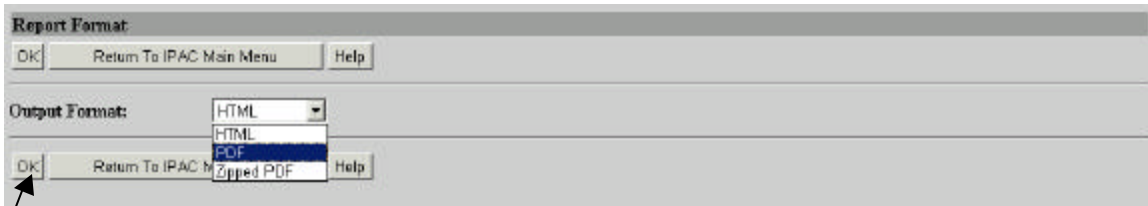

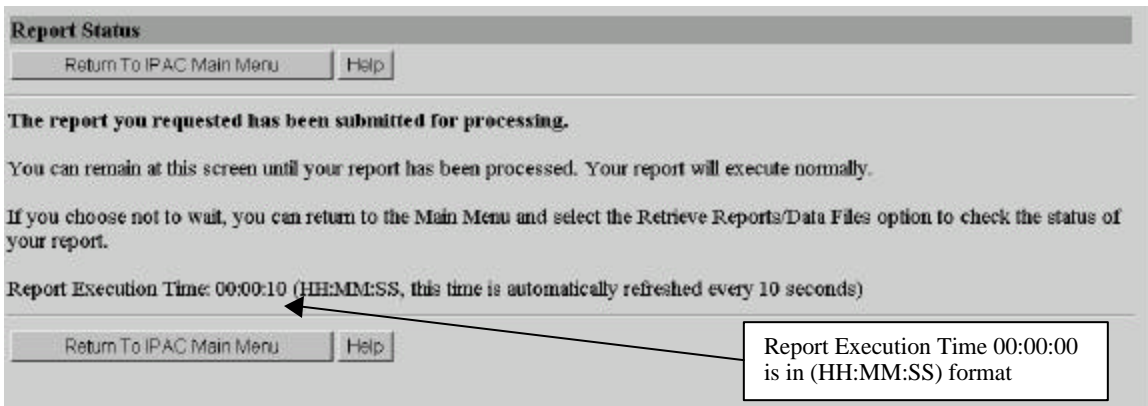


Figure 10.4 Report Status

Appendix D Glossary of New Terms and Acronyms

DUNS A 9-digit number that is assigned by Duns and Bradstreet associated with the registering entity (Office or Division). This number serves as the unique ID for each record.

DUNS + 4 This is a 4-digit extension to your DUNS that the user creates. It is used if you have more than one ALC or DO per office and need to differentiate between the lines of business.

SGL (Standard General Ledger) A uniform chart of accounts to standardize federal agency accounting. The SGL supports the preparation of standard external reports required by central agencies. The Office of Management and Budget's (OMB's) and FMS' regulations require agencies to use the SGL to accumulate and report standard financial data.

Post SGL Senders and Receivers of Payment, Collection and Adjustment transactions are allowed to update/change SGL information through the Post SGL screens, after the original transaction has been processed.

Treasury Account Symbol Formerly the Appropriation Symbol, the account number assigned by the Treasury to classify agency transactions.

Third Party Submitter Agencies given access to submit bulk files for other agencies as a Third Party and to pull corresponding reports.
