REVISED LIST OF CHANNELS AVAILABLE AT THE 157° W.L. ORBIT LOCATION IN THE AUCTION OF DIRECT BROADCAST SATELLITE SERVICE LICENSES SCHEDULED FOR JULY 14, 2004

Report No. AUC-04-52-F (Auction No. 52)

On February 6, 2004, the Wireless Telecommunications Bureau ("WTB") issued a Public Notice announcing procedures for Auction No. 52, the auction of three Direct Broadcast Satellite ("DBS") licenses that will begin on July 14, 2004.¹ Attachment A of the *Auction No. 52 Procedures Public Notice* set forth the specific channels on which each of the three licenses will authorize operations. The *Auction No. 52 Procedures Public Notice* also noted a pending application filed by EchoStar Satellite Corporation ("EchoStar") seeking to modify its DBS authorization at the 157° W.L. orbit location.²

On March 31, 2004, the International Bureau granted EchoStar's above-referenced application, thus approving EchoStar's request to modify its DBS authorization at the 157° W.L. orbit location to use channels 1, 7, and 11 instead of channels 1, 3, and 5.³ In light of the grant of this application, WTB hereby sets forth a revised list of the channels on which the 157° W.L. license offered in Auction No. 52 will authorize operations. Attachment A to this Public Notice corrects
