PUBLIC DEMONSTRATION OF THE NEW FCC FORM 602 FILING INTERFACE IN THE UNIVERSAL LICENSING SYSTEM WILL TAKE PLACE ON JULY 28, 2004

As part of a continuing effort to improve the license application process, the Wireless Telecommunications Bureau (WTB) announces the redesign of the FCC Form 602, Ownership Disclosure information for the Wireless Telecommunications Services, filing interface (Ownership Filing). WTB will hold a public demonstration and focus group for the new interface on July 28, 2004, from 11:00 AM to 1:00 PM. The event will take place in the South Conference Room (Room 8-B516), on the Eighth Floor of the Portals II building, at the Washington, DC headquarters, 445 Twelfth Street, S. W. WTB requests that interested parties pre-register for the event by July 27, 2004.

The new interface for Ownership Filing will be in the ULS Online Filing environment, called the ULS License Manager. License Manager provides an enhanced filing environment for working with wireless applications and allows for simplified filing of applications in question and answer format through an application wizard. In addition, the new interface is the first step in meeting WTB's long term goal of streamlining the submission of ownership data to avoid duplication between forms. The forum will include the following:

- Demonstration of how to file ownership information in the new environment
- Presentation of new capabilities, such as the ability to submit "proposed" (*i.e.*, post-transaction ownership structure) filings and the ability to upload ownership data
- Solicitation of feedback and suggestions from forum participants

Note: This public demonstration is intended to provide an overview of the redesigned online filing interface. We will not discuss issues pertaining to the particular types of information that must be submitted on Form 602 or who must file Form 602.
