**WIRELESS TELECOMMUNICATIONS BUREAU, MOBILITY DIVISION
ANNOUNCES THE DISMISSAL OF 220 MHZ SERVICE PHASE II CONSTRUCTION
NOTIFICATIONS**

On July 13, 2004, the Wireless Telecommunications Bureau (Bureau) released an Order which extended the five-year construction deadline for certain 220 MHz Service licensees until November 5, 2007.¹ In the Order, the Bureau concluded that, because of the unique narrowband characteristics of the band, it is in the public interest to extend the construction deadline for these 220 MHz Service Phase II economic area, regional, and nationwide licensees. Accordingly, pursuant to the July 13, 2004 Order, we dismiss without prejudice the notifications listed in the Appendix to this Public Notice. The new five-year construction deadline for the licenses listed in the Appendix is November 5, 2007.
