

# Department of Defense DIRECTIVE

NUMBER 6420.1 September 30, 1996

SUBJECT: Armed Forces Medical Intelligence Center (AFMIC)

References: (a) DoD Directive 6420.1, subject as above, December 9, 1982 (hereby canceled)

### 1. <u>REISSUANCE AND PURPOSE</u>

This Directive reissues reference (a) to reflect changes in the organization and conduct of DoD medical intelligence activities.

### 2. <u>APPLICABILITY</u>

This Directive applies to the Office of the Secretary of Defense, the Combatant Commands, the Military Departments, the Chairman of the Joint Chiefs of Staff, and the Defense Agencies (hereafter referred to collectively as "the DoD Components").

### 3. <u>DEFINITIONS</u>

- 3.1. <u>Administrative Control</u>. Direction or exercise of authority on administrative matters such as personnel management, supply, services and other matters not included in the operational mission.
- 3.2. <u>Administrative Support</u>. The provision of resources and services to accomplish activities not within the operational mission of the receiving organization,

including planning, programming, budgeting, financial management, manpower, personnel, career management, security administration, and related activities.

3.3. <u>Field Production Activity</u>. A DoD intelligence production organization with authority to conduct day-to-day operations, subject to overall policy and regulatory control of the Defense Intelligence Agency (DIA).

### 4. POLICY

It is the DoD policy under reference (b) that:

- 4.1. The AFMIC is hereby established as a field production activity of the DIA, administratively integrated with the DIA organization. The AFMIC shall be jointly staffed by personnel assigned or detailed from each of the Military Departments, as agreed between the Director, DIA, and the Secretaries of the Military Departments.
  - 4.2. The AFMIC has as its missions:
- 4.2.1. Sole responsibility within the Department of Defense for producing finished intelligence on foreign military and civilian medical capabilities, infectious disease and environmental health risks, and scientific and technical developments in biotechnology and biomedical subjects of military importance.
  - 4.2.2. Managing the medical aspects of the DoD Foreign Materiel Program.
- 4.2.3. Accomplishing such other production assignments as are tasked by the Director, DIA.

### 5. <u>RESPONSIBILITIES</u>

- 5.1. The <u>Assistant Secretary of Defense for Health Affairs</u>, under the <u>Under Secretary of Defense for Personnel and Readiness</u>, shall maintain responsibility for reviewing and revising this directive.
  - 5.2. The <u>Secretaries of the Military Departments</u> shall:
    - 5.2.1. Provide military staffing consistent with AFMIC's mission requirements.
- 5.2.2. On request of the Chair of the AFMIC Interdepartmental Advisory Panel (IAP), provide nominees for the position of Director, AFMIC.

- 5.3. The <u>Assistant Secretary of Defense for Command, Control, Communications, and Intelligence</u> shall:
- 5.3.1. Oversee the activities, manning, and funding of the AFMIC in accordance with DoD Directive 5137.1 (reference (b)).
  - 5.3.2. Ensure that the Director, Defense Intelligence Agency, shall:
- 5.3.2.1. Exercise supervision of the AFMIC activities under DoD Directive 5105.21 (reference (c)).
- 5.3.2.2. Manage the AFMIC as an integral element of the DIA, exercising administrative control and providing appropriate administrative support.
- 5.3.2.3. Coordinate appropriate support of the AFMIC by the Military Departments.
  - 5.3.2.4. Appoint the Chair of the AFMIC IAP.
- 5.3.2.5. Appoint the Director, AFMIC, upon recommendation by the AFMIC IAP.

### 6. <u>EFFECTIVE DATE</u>

This Directive is effective immediately.

## ARMED FORCES MEDICAL INTELLIGENCE CENTER INTERDEPARTMENTAL ADVISORY PANEL (AFMIC IAP)

- E1.1.1. To enhance coordination between the medical elements of the Department of Defense and the AFMIC, an AFMIC Interdepartmental Advisory Panel (AFMIC IAP) is hereby established. The AFMIC IAP mission is to provide Department-wide cooperation, as appropriate, on medical intelligence matters, to monitor and advise on the development of medical production requirements, to assess the responsiveness of AFMIC production to DoD needs for medical intelligence, and to support the necessary staffing of the AFMIC.
- E1.1.2. The AFMIC IAP shall be composed of one representative designated by each of the following:
- E1.1.2.1. Director, Defense Intelligence Agency (this representative shall Chair the AFMIC IAP).
  - E1.1.2.2. Assistant Secretary of Defense for Health Affairs.
- E1.1.2.3. Assistant Secretary of Defense for Command, Control, Communications, and Intelligence.
  - E1.1.2.4. Chairman, Joint Chiefs of Staff.
  - E1.1.2.5. Deputy Chief of Staff for Intelligence, Army.
  - E1.1.2.6. Director of Naval Intelligence.
  - E1.1.2.7. Assistant Chief of Staff for Intelligence, Air Force.
- E1.1.2.8. Assistant Chief of Staff for Command, Control, Communications, Computers, and Intelligence, United States Marine Corps.
  - E1.1.2.9. The Surgeon General, Department of the Army.
  - E1.1.2.10. The Surgeon General, Department of the Navy.
  - E1.1.2.11. The Surgeon General, Department of the Air Force.

### E1.1.3. The AFMIC IAP shall:

- E1.1.3.1. Provide recommendations to the Director, DIA, concerning AFMIC program guidance, policies, and procedures.
- E1.1.3.2. Nominate to the Director, DIA, as required, an officer to serve as Director of AFMIC. The nominee shall be an officer in the grade of O-6, from the medical department of one of the Military Departments, selected from candidates nominated by the Military Departments.
- E1.1.3.3. Ensure appropriate coordination within the DoD Components on matters referred by a member of the IAP; the Chair; or the Director, DIA.
