# Tallahassee, Florida

### **Demographics**

- Population: 153,938 (July 2003 Census estimate)<sup>1</sup>; 150,624 (2000 Census)<sup>2</sup>
- ➤ Race/Ethnicity (2000 Census): 57.8% white; 33.9% African American/black; 0.2% American Indian/Alaska Native; 2.4% Asian; 0.1% Native Hawaiian/Pacific Islander; 0.2% other; 1.3% two or more races; 4.2% Hispanic/Latino origin (of any race)<sup>3</sup>
- ➤ Tallahassee is located in Leon County.<sup>4</sup>

### **Crime and Drug-Related Crime**

➤ During 2003, the Tallahassee Police Department reported 4 murders. 9

➤ The Tallahassee Police Department reported 8 arrests for murder during 2003. <sup>10</sup> There were 16 arrests for murder reported during 2002. <sup>11</sup> In 2001, the Tallahassee Police Department reported 5 murder arrests. <sup>12</sup>

➤ The Tallahassee Police Department reported 1,380 drug arrests during 2003. There were 1,225 drug arrests reported during 2002. In 2001, the Tallahassee Police Department reported 1,432 drug arrests.

### **Drugs**

Cocaine

Powder and crack cocaine continue to be observed in the Tallahassee area. 16

➤ Methamphetamine
The Tallahassee Police Department reports meth manufacturing in local labs. 17

Club Drugs Ecstasy, GHB, LSD, and Rohypnol are frequently seen in the Tallahassee college community and at local nightclubs.<sup>18</sup>

#### **Juveniles**

➤ In 2002, 30% of Leon County high school students (grades 9-11) reported using marijuana at least once in their lifetime. Approximately 13% of Leon County middle school students surveyed in 2002 reported lifetime marijuana use. <sup>19</sup>

➤ Approximately 16% of Leon County students in grades 9 though 11 who were surveyed in 2002 reported using marijuana within the past 30 days. <sup>20</sup>

➤ During 2002, the mean age when Leon County middle school students first used marijuana was 12.2 years. Among Leon County students in grades 9 though 11, the average age of first marijuana use was 14.1 years.<sup>21</sup>

➤ Nearly 10% of Leon County students surveyed in 2002 reported being drunk or high at school. 22

#### **Enforcement**

As of October 31, 2002, there were 477 full-time law enforcement employees in Tallahassee (336 officers and 141 civilians).<sup>23</sup>

## **Trafficking and Seizures**

- ➤ During 2002, 25 marijuana plants were seized in Leon County as part of the Domestic Marijuana Eradication program. The plants were all found at 1 site. 24
- From FY 2001-2002, the Tallahassee Police Department Vice/Narcotics Unit seized \$1,000,000 worth of powder cocaine, \$322,697 worth of marijuana, \$61,685 worth of crack, and \$58,990 worth of designer drugs, steroids, and methamphetamine.<sup>25</sup>

#### **Corrections**

➤ In 2003, the average daily population at the Leon County Jail was 1,035. <sup>26</sup>

#### **Consequences of Use**

➤ There were 43 deaths in Tallahassee during 2003 in which cocaine was found in the body of the deceased. <sup>27</sup> This is up from 2002 when there were 33 deaths in which cocaine was present. <sup>28</sup> During 2001, there were 28 deaths in which cocaine was present. <sup>29</sup>
