1. NAPS Section 5207.103(c)(ii) numbering is corrected to 5207.103(d)(ii) as follows:

PART 5207

ACQUISITION PLANNING

SUBPART 5207.1-ACQUISITION PLANS

5207.103 (DFARS 207.103) Agency-head responsibilities.

(d)(ii) Written acquisition plans (APs) are not required for military construction; commercial items; spare and repair parts; items of supply which are managed on a national basis where requirements are computed in accordance with established DoD/DoN inventory management policy/regulation; overhaul and/or modification of naval vessels, small vessels and crafts (including MSC vessels/crafts); overhaul and/or

modification of engines; operation and maintenance of weapon test/training ranges; ocean towage; Commercial Activities; architect-engineer; major station maintenance and repair; and component overhaul/maintenance/repair at the depot, intermediate or

organizational levels.

- 2. NAPS Subpart 5209.2, including Section 5209.202, is deleted in its entirety.
- 3. NAPS Part 5223 title is changed as follows:

ENVIRONMENT, ENERGY, AND WATER EFFICIENCY, RENEWABLE ENERGY TECHNOLOGIES, OCCUPATIONAL SAFETY, AND DRUG-FREE WORKPLACE

5232.903 Responsibilities.

For Prompt Payment Act purposes, every contract, including actions accomplished by simplified acquisition procedures, should indicate on its face whether the payments under it are:

- (a) Subject to the 7 calendar day constructive acceptance period;
- (b) Subject to acceptance terms other than (a) above; or
- (c) Not subject to the Prompt Payment Act.

5232.905 Payment documentation and process.

If a Technical Representative or Contracting Officer's Representative has been assigned in the contract, the contracting officer should designate that individual to receive an information copy of the invoice.
