Section 13422.3 - Definitions of Lines One Through One Hundred Fifteen, Line 47 is changed to "Independent Diagnostic Testing Facility, specialty code 47; Line 62 is changed to clarify what to report on this line; Line 63 is changed to "Dietitian/Nutritionist, specialty code 71; Line 64 is changed to "Pain Management", specialty code 72; and Line 86 is changed to "Reserved for future use".

<u>Sections 13423 - Checking Reports</u>, provides revised instructions for Lines 90, 91, and 93 to reflect changes to lines used to determine sums for each line.

<u>Section 13424 - Exhibits</u>, revises the Participating Physician/Supplier Report screens to reflect the reporting changes described above.

Report on Number of Participating Physicians and Suppliers

13421. PARTICIPATING PHYSICIAN/SUPPLIER REPORT

Unless otherwise requested, prepare and transmit to CMS each year a report updating the number and category of participating physicians and suppliers. Complete a separate report for each office assigned a separate carrier number.

13421.1 <u>Purpose and Scope.</u>--This report enables CMS to gather data for administrative purposes on the number of physicians and suppliers, by category, electing to participate in CMS's Participating Physician/Supplier Program. The report is divided into two sections. Section 1 is to be completed by local carriers only, while section 2 is to be completed by the National Supplier Clearinghouse (NSC) on behalf of the durable medical equipment regional carriers (DMERCs).

13421.2 <u>Due Date</u>.--Transmit data about the Participating Physician/Supplier Program to CO via PC or terminal. Use instructions in the Contractor Reporting of Operational and Workload Data (CROWD) System User's Guide.

The report is due 45 days after the end of the enrollment period. Include updated data as of the end of the most recent enrollment period.

Do not submit hard copies of the report.

13422. COMPLETION OF ITEMS ON PARTICIPATING PHYSICIAN/SUPPLIER REPORT

13422.1 <u>Heading</u>.--This report is referenced as Form F in the CROWD system. Complete the ADD/UPDATE/DELETE DATA criteria screen with the appropriate information to bring the reporting format to your screen.

13422.2 Definitions of Columns One Through Eight.--

<u>Column 1.--Participating Physicians/LLPs/Suppliers - Prior</u>.--This column contains a count of the number of physicians, limited license practitioners (LLPs), and suppliers who were participating prior to the beginning of the latest enrollment period.

NOTE: Adjust this data if there are changes from the information submitted in column 2 on the previous enrollment period. Inform CMS by memorandum if the numbers are different. Include in your description the specialty number, column, and the reason for the change. Send the memorandum to:

Examples of possible reasons for changes to the data include:

- o Addition of new physicians to the Medicare file;
- o Reclassification of physicians, LLPs, and suppliers between specialty designations;
- o Deletion of deceased or retired physicians from the Medicare file; or
- o Technical corrections to previously submitted data.

<u>Column 2.--Participating Physicians/LLPs/Suppliers - Current.</u>--Data in this column include the number of physicians, LLPs, and suppliers who are continuing as participants from the prior participation period into the new participation period and the number who have <u>newly</u> signed participation agreements in the latest enrollment period.

NOTE: Effective January 1, 1995, a change in Medicare law required certain practitioners to accept assignment for all covered services they furnish to Medicare beneficiaries. The specialty codes involved in this change are: 42, 43, 50, 68, 80, 89, and 97. From now on, categorize all practitioners with these specialty codes as <u>participating</u> practitioners for purposes of this report.

<u>Column 3.--Participating Physicians/LLPs/Suppliers - Continuing.</u>--Show in this column only the number of physicians, LLPs, and suppliers who are <u>continuing</u> as participants from the prior participation period into the new participation period. Do not include those who have newly signed participation agreements in the latest enrollment period or those who have dropped out.

<u>Column 4.--Non-Participating Physicians/LLPs/Suppliers - Prior.</u>--This column contains a count of physicians, LLPs, and suppliers who were not participating at the beginning of the latest enrollment period.

NOTE: Adjust this data if the information is different from that submitted in column 5 on the previous enrollment period. (See column 1 for further information.)

<u>Column 5.--Non-Participating Physicians/LLPs/Suppliers - Current.</u>--This column contains a count of physicians, LLPs, and suppliers who were not participating after the latest enrollment period. This count includes those who were not participating at the beginning of the latest enrollment period and chose not to enroll and those who disenrolled during the latest period.

<u>Column 6.--Participating Drop-Out - Current</u>.--Data in this column represent physicians, LLPs, and suppliers who, prior to this enrollment period, were participating in the program and have now decided to drop out.

<u>Column 7.--Non-Participating Sign-Up - Current.</u>--Data in this column represent physicians, LLPs, and suppliers who were non-participating prior to the latest enrollment period and who enrolled in the program during the latest enrollment period.

Column 8.--Participating Disenrolls.--Show in this column only the number of participants who disenrolled from the Medicare program during an authorized disenrollment period held during the past 12 months. Leave this field blank, unless CMS declares an authorized disenrollment period such as the one held in 1984.

13422.3 <u>Definitions of Lines One Through One Hundred Fifteen</u>.--Count individual participants by the specialties listed below. Do not count an individual more than once, even if they practice in more than one setting. Local carriers are to complete section 1 (lines 1-93) only, while the NSC is to complete section 2 (lines 94-115) only.

Line 92--Total Physicians/LLPs.--Enter in the appropriate column the sum of lines 90 and 91.

<u>Line 93--Total Local Carrier Suppliers</u>.--Enter in the appropriate column the total of all specialty codes applicable to suppliers from lines 1-89.

<u>Line 114--Total DMERC Suppliers</u>.--Enter in the appropriate column the total of all suppliers on lines 94-113.

<u>Line 115--Unduplicated NSC Supplier Count.</u>--Enter in the appropriated column an unduplicated count of individual suppliers included on lines 94-113; i.e., count each supplier only once regardless of how many specialty codes it might have.
