SUBJECT: Change of Medicare Part A Plan under contract with the Blue Cross/Blue Shield Association (BCBSA) and change of Part B carrier in the State of Rhode Island from BC/BS of Rhode Island to Arkansas BC/BS.

I. GENERAL INFORMATION

A. Background:

BC/BS of Rhode Island is not renewing its Medicare contracts and will no longer serve as the Part A Plan under contract with BCBSA or as a Part B carrier. Arkansas BC/BS will become the Part A Plan and Part B contractor for the State of Rhode Island effective February 1, 2004. There will be a separate Part A intermediary number and a separate Part B carrier number for reporting the Rhode Island workload. CWF software changes and changes to the CROWD, PULSE, and PECOS systems are needed to reflect the new contractor numbers.

The numbers are as follows: Arkansas BC/BS-Rhode Island **Part A: 00021**; Arkansas BC/BS-Rhode Island **Part B: 00524**

Both BC/BS Rhode Island and Arkansas BC/BS will inform Rhode Island providers about the change in Medicare contractor by posting transition information on their Web sites, contacting professional societies, mailing notification, and conducting provider training workshops throughout the state.
