
Things to Think About

As you drive to Meadow Creek trailhead you will travel along one of our country's premier designated *Wild and Scenic Rivers*-the Selway. So drive safely, take your time, and enjoy the view.

Meadow Creek Trail #726 is open to motorcycles for the first three miles. Stock animals have the right-of-way. At Little Creek it changes to foot and stock traffic only. The trail leaves the creek bottom here, and contours the hillside for six miles before it drops back down to the creek.

There is an indoor untested water system provided. All water should be filtered or boiled for 5 minutes.

The propane tank is located on the back porch and should be turned off before leaving.



A corral is provided for stock use and any grazing should take place beyond the grassy area in front of the cabins.

Items Provided

- Propane refrigerator, stove and lights
- Dishes, pots, pans, utensils for six
- Six beds with mattresses
- Wood heat and cook stove
- Coleman lantern (for backup)
- Fire extinguisher
- Broom, mop and bucket

Items to Bring

- Matches
- Garbage bags for packing out
- Flashlight, extra batteries
- Sleeping bags or desired bedding
- First-Aid equipment
- Fishing pole, license
- Coleman fuel, extra mantels (optional)
- Supplemental feed for stock
- Special use permit, cabin key


The Nez Perce Tribe called Meadow Creek "Wol-lwe-its", which means Meandering Stream.

Welcome...

Escape into a world of peaceful solitude, while you experience the pristine beauty of this unique area. Meadow Creek Cabin lies nestled among the pines deep in the heart of Nez Perce National Forest on the banks of Meadow Creek. Plan on a leisurely hike or horseback ride to this remote backcountry cabin.

There are several trails in the area to explore, and after July 1 you can step off the porch and enjoy great native trout fishing.

Be sure to bring your fly rod.



Since 1932, Meadow Creek has served as a workstation, with fieldwork crews occasionally utilizing the bunkhouse. It is our pleasure to rent this historic site to visitors, and we appreciate your respect of the Meadow Creek Ranger Station as a piece of National Forest history.

How To Get There

The cabin sits in a steep-sided canyon along Meadow Creek, a major tributary of the Selway River. Travel to Lowell, Idaho located approximately midway between Lewiston, Idaho and Missoula, Montana on Highway 12, milepost 97 at the confluence of the Lochsa and Selway Rivers.

Cross the bridge and drive 20 miles up the Selway River. Cross the Selway Falls Bridge on your right. Travel about a mile to the trailhead at Slim's Camp. It's a 15-mile hike or horseback ride on National Recreation Trail #726 to Meadow Creek Cabin.

You can also access the cabin from Elk City by way of Kirk's Fork Trail #830 to Anderson Butte, then Butte Creek Trail #809, a total of 14 miles.

Call for Reservations

You can request a special use permit to reserve Meadow Creek Cabin by contacting Moose Creek Ranger District at 208-926-4258. Rental fee for the cabin is \$25 per night with a maximum use period of seven nights. It is available May 1 through September 15.
