## Scope of April 18, 2001 Examination.

The registration examination scheduled for April 18, 2001, is directed at patent laws, rules, policies, practices and procedures to be followed when prosecuting patent applications in the United States Patent and Trademark Office. The U.S. patent statutes, the USPTO rules of practice, the Manual of Patent Examining Procedure, and the Patent Cooperation Treaty, as modified by any later court decisions or Official Gazette notices, determine the correct answers. The examination will include questions that address statutory changes enacted by the American Inventors Protection Act of 1999 (the Act), Public Law 106-113, 113 Stat. 1501 (1999), as well as changes to the rules and procedures that were published in the Federal Register and Official Gazette on or before January 5, 2001. The examination will also include questions addressing laws, rules procedures and policies not affected by the Act or related rule changes. No determination has been made regarding how many questions will cover the respective areas.

The rule and procedural changes addressed in the examination are found in the following final rules, comments accompanying the rule changes, and guidelines published on or before January 5, 2001. These rule changes were published after the last revision of the MPEP dated February 2000. The final rules, comments, and guidelines are identified below by cites to the *Federal Register* and the *Official Gazette*, where applicable. Links to the identified rules are provided below. The final rules, commentary to the final rules, and the guidelines will determine the correct answer to the extent that there is any conflict or difference with the MPEP dated February 2000.

The current Seventh Edition of Manual of Patent Examining Procedure (MPEP), revision 1, dated February 2000 does not reflect the Act-related changes. A new revision is due sometime in the Spring of 2001. However, a revised edition may not be available before the examination. Furthermore, the revision of the MPEP dated February 2000, which is available at <a href="http://www.uspto.gov/web/offices/pac/mpep/mpep.htm">http://www.uspto.gov/web/offices/pac/mpep/mpep.htm</a>, contains statutes and rules in Appendices L and R. However, the statutes and rules in Appendices L and R also do not reflect the Act-related changes. Accordingly, it is not recommended that candidates rely on the statute and rules in Appendices L and R.
