# **PRODUCT TRANSFER REPORT (PTR)**

# RESPONSIBILITY

Except for exemptions noted below, the operator of a catcher/processor or mothership or the manager of a shoreside processor or stationary floating processor must complete and submit a separate PTR for each transfer (shipment or receipt) of groundfish and donated prohibited species caught in groundfish fisheries.

In addition, a Registered Buyer must submit a separate PTR for each transfer (shipment only) of halibut or sablefish for which the Registered Buyer submitted an IFQ landing report or was required to submit an IFQ landing report.

# A PTR is not required to accompany a shipment or offload.

Exemption: Bait sales (non-IFQ groundfish only).

The operator or manager may aggregate individual sales or transfers of non-IFQ groundfish to vessels for bait purposes during a day onto one PTR when recording the amount of such bait product **transferred from a vessel or facility** that day.

Exemption: Retail sales (non-IFQ groundfish only).

For retail sales destined for human consumption and weighing less than 10 lb or 4.5 kilograms, the operator, manager, or Registered Buyer may aggregate and record on one PTR, the amount of such retail product transferred during one calendar day.

# Exemption: Wholesale sales (non-IFQ groundfish only).

The operator or manager may aggregate and record on one PTR, wholesale sales of non-IFQ groundfish by species when recording the amount of such wholesale species leaving a vessel or facility in one calendar day, if invoices detailing destinations for all of the product are available for inspection by an authorized officer.

# Exemption: Registered Buyers.

Registered Buyers are not required to submit a PTR for "receipt" of IFQ halibut, CDQ halibut, or IFQ sablefish.

#### Exemption: Dockside sales.

A person holding a valid IFQ permit, IFQ card, and Registered Buyer permit may conduct a dockside sale of IFQ halibut or IFQ sablefish with a person who has not been issued a Registered Buyer permit after all IFQ fish have been landed and reported in accordance with § 679.5(1).

A person holding a valid CDQ permit, halibut CDQ card, and Registered Buyer permit may conduct a dockside sale of CDQ halibut with a person who has not been issued a Registered Buyer permit after all CDQ fish have been landed and reported in accordance with § 679.5(1).

A Registered Buyer conducting dockside sales must issue a receipt to each individual receiving IFQ halibut, **CDQ halibut**, or IFQ sablefish in lieu of a PTR. This receipt must include:

Date of sale or transfer Registered Buyer permit number Weight by product of the IFQ halibut, CDQ halibut, or IFQ sablefish transferred. The Registered Buyer must maintain a copy of each dockside sales receipt as described in § 679.5(1).

Exemption: transfer directly from the landing site to a processing facility (CDQ halibut, IFQ halibut, or IFQ sablefish only).

A PTR is not required for transportation of unprocessed **IFQ halibut**, **IFQ sablefish**, and **CDQ halibut** directly from the landing site to a facility for processing, provided the following conditions are met:

A copy of the IFQ Landing Report receipt (Internet or transaction terminal receipt) documenting the IFQ landing accompanies the offloaded IFQ halibut, IFQ sablefish, and CDQ halibut while in transit.

A copy of the IFQ Landing Report receipt is available for inspection by an authorized officer.

The Registered Buyer submitting the IFQ Landing Report completes a PTR for each transfer from the processing facility of **IFQ** 

# halibut, IFQ sablefish, and CDQ halibut transported in this manner.

### TIME LIMITS AND SUBMITTAL.

The operator of a mothership or catcher/ processor, a Registered Buyer, or manager of a shoreside processor or stationary floating processor must:

<u>Record on PTR</u>. Record all product transfer information on a PTR within 2 hours of the completion of the transfer.

<u>Submit original PTR</u>. Submit by FAX or electronic file a copy of each PTR to:

<u>Submit revised PTR</u>. Ensure that, if any information on the original PTR changes prior to the first destination of the shipment, a revised PTR is submitted by FAX or electronic file to:

by 1200 hours, A.l.t., on the Tuesday following the end of the applicable weekly reporting period in which the change occurred.

#### **GENERAL INFORMATION.**

The operator, manager, or Registered Buyer must record on a PTR whether:

Whether original or revised PTR;

Whether you are the shipper or receiver;

# **RECEIVER INFORMATION.**

If documenting receipt of non-IFQ groundfish, the operator or manager must check "Receiver" and enter:

Your representative's name, telephone number, and FAX number;

Start and finish date and time of product transfer, Position of product transfer (if applicable),

Port or location of transfer (location where transferred product is received) and:

### SHIPPER INFORMATION.

If documenting transfer of product away from your facility or transfer of product off of your vessel, the operator, manager, or Registered Buyer must:

Using descriptions from the following table, enter receiver information, date and time of product transfer, port or location of product transfer (location from which transferred product is shipped), mode of transportation, and intended route.

### NOTE

If a transfer involves a single destination but requires loading on multiple vans, trucks, or airline flights, record the transfer on a single PTR page.

# PRODUCTS SHIPPED OR RECEIVED

The operator, manager, or Registered Buyer must record the following information for each product transferred:

Species code and product code.

The species code and product code (see Tables 1 and 2).

**Do not record on PTR** products identified by the product codes 41, 42, 98, or 99.

# Species weight.

DO NOT USE THIS COLUMN if you are aggregating daily wholesale shipments onto one PTR.

DO NOT USE THIS COLUMN if you are shipping the same kind of product made from the same kind of species to one customer.

USE THIS COLUMN if you are shipping two or more species with one or more product types in one box to the same customer.

This column to be used only for recording the actual scale weight of each product of each species to the nearest kilogram or pound (indicate which).

If not applicable, enter "n/a" in the species weight column.

If using more than one line to record species in one carton, use a bracket "}" to tie the carton information together.

Number of units.

Total number of production units (blocks, trays, pans, individual fish, boxes, or cartons; if iced, enter number of totes or containers).

#### Unit weight.

Unit weight (average weight of single production unit as listed in "No. of Units" less packing materials) for each species and product code in kilograms or pounds (indicate which).

Total weight.

PTR

Total weight for each species and product code of shipment less packing materials in kilograms or pounds (indicate which).

#### Total or partial offload.

*Use only if a mothership or catcher/processor.* If a mothership or catcher/processor, the operator must indicate whether the transfer is a total or partial offload.

If a partial offload, for the products remaining on board after the transfer, the operator must enter: Species code Product code Total product weight to the nearest kilogram or pound (indicate which) for each product.

To calculate metric tons from pounds:

No. cartons x average carton weight (lb) 2,204.6

To calculate metric tons from kilograms:

(No. cartons x average carton weight (kg) 1,000
