We invite biologists, managers, researchers, students and the interested public to participate in the second Great Lakes Lake Sturgeon Coordination Meeting. This meeting will be held at the Quality Inn in Sault St. Marie, MI, November 9-10, 2004, beginning at 9:00 AM Wednesday and concluding by 4:00 PM Thursday.

PURPOSE: Provide a bi-annual forum to foster communication and exchange of

information relating to the study, management, and restoration of lake sturgeon in the Great Lakes basin, to address priority research and

assessment needs, and to address selected emerging issues.

The focus of the 2004 meeting will be to address three priority emerging issues identified by participants at the 2002 meeting. They are: habitat classification (spawning, nursery, and juvenile), habitat restoration and enhancement, and fish passage. We will also have follow-up presentations on the two emerging issues covered at the 2002 meeting (use of stocking and genetic considerations to rehabilitate populations, and development of standardized assessment techniques). The meeting will focus on presentations related to habitat classification, habitat rehabilitation and restoration, and fish passage. A panel discussion (open question and answer) related to sturgeon passage will follow the presentations. An evening potluck social gathering will feature poster presentations that describe a wide range of sturgeon work. There will also be facilitated discussion on several topics. Individuals may choose which topic group to attend. Following the discussions will be summary presentations from each group.

Included with this announcement are instructions for preparation of oral and poster presentations (September 17 submission deadline), registration materials that includes instructions for a biographical sketch for distribution to participants (registration due October 15), information about lodging and travel (block of rooms reserved until October 22 for "sturgeon meeting" at \$55 a night), and a tentative meeting agenda.
