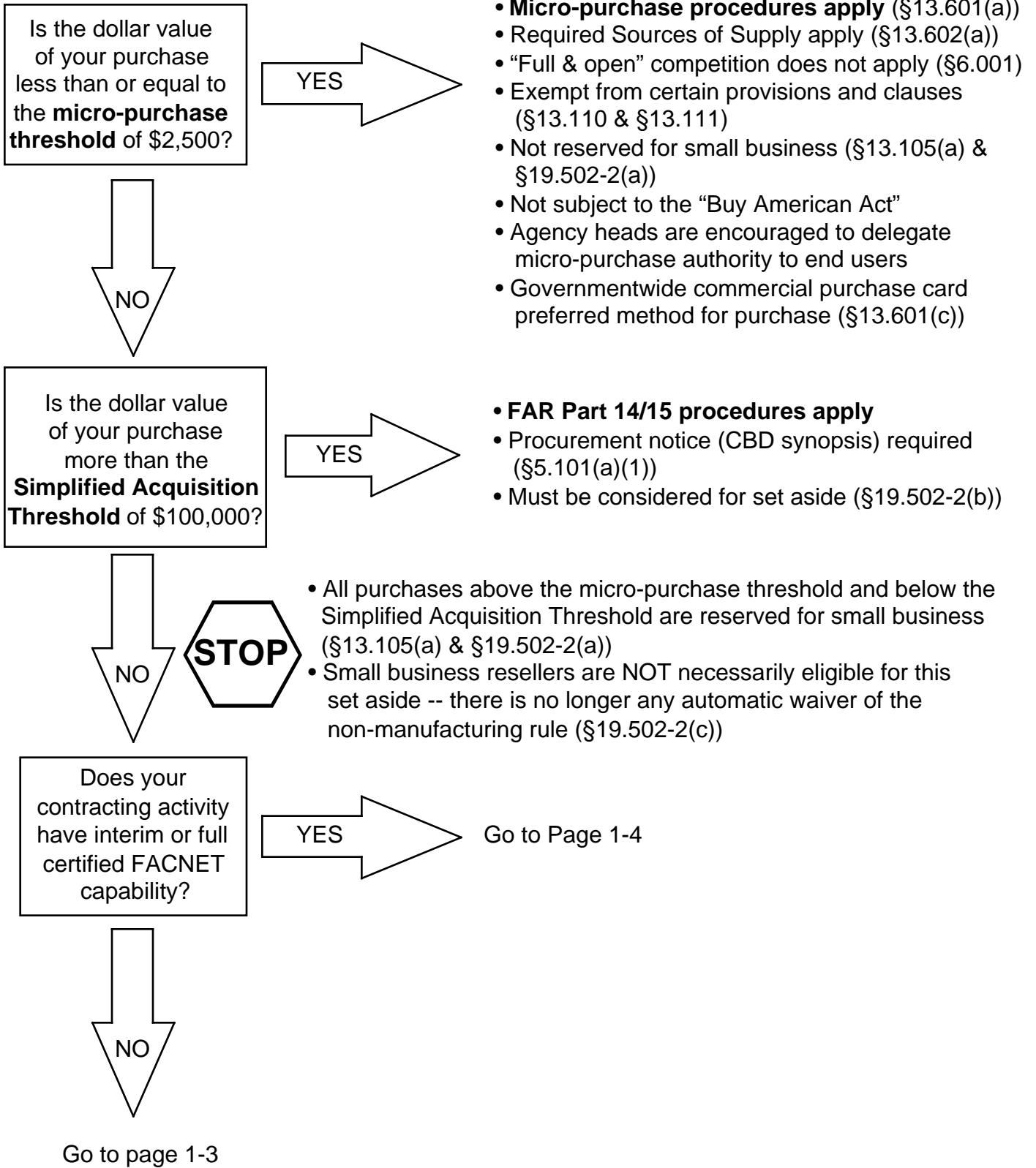


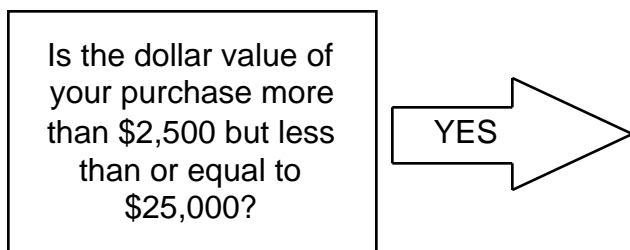
PROCUREMENT PROCEDURES DECISION TREE

(prior to 31 December 1999)

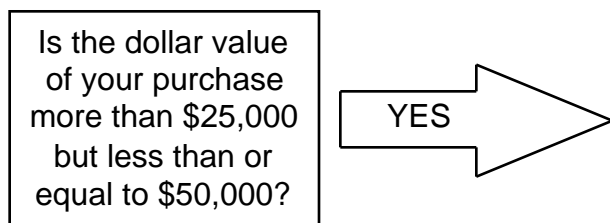
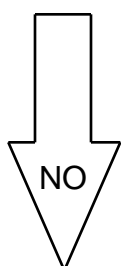


PROCUREMENT PROCEDURES DECISION TREE

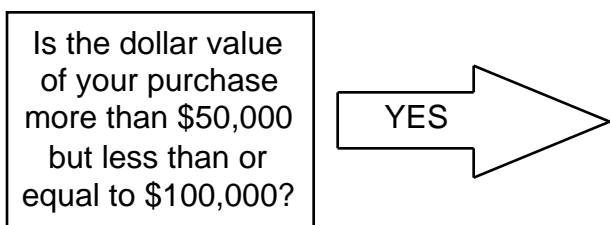
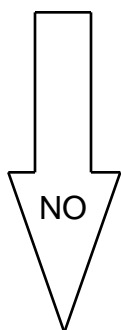
CONTRACT ACTIVITIES NOT FACNET CERTIFIED
PURCHASE VALUE OVER \$2,500 BUT NOT EXCEEDING \$100,000



- **Simplified Acquisition Procedures apply** (§13.103(a))
- Required Sources of Supply apply (§13.103(a))
- “Full & open” competition does not apply (§6.001)
- Exempt from certain provisions and clauses (§13.110 & §13.111)
- **Procurement notice (public posting) required** (§5.101(a)(2))
- Must consider ALL timely quotes from responsible vendors received in response to posting
- Oral solicitations permitted (§13.106-1(a)(2))
- Governmentwide commercial purchase card may be used for payment
- Reserved for small business (§13.105(a) & §19.502-2(a))



- **Simplified Acquisition Procedures apply** (§13.103(a))
- Required Sources of Supply apply (§13.103(a))
- “Full & open” competition does not apply (§6.001)
- Exempt from certain provisions and clauses (§13.110 & §13.111)
- **Procurement notice (CBD synopsis) required** (§5.101(a)(1))
- Must consider all quotes timely received including those received via FACNET
- **Oral solicitations may not be practicable** (§13.106-1(a)(2))
- Governmentwide commercial purchase card may be used for payment
- Reserved for small business (§13.105(a) & §19.502-2(a))

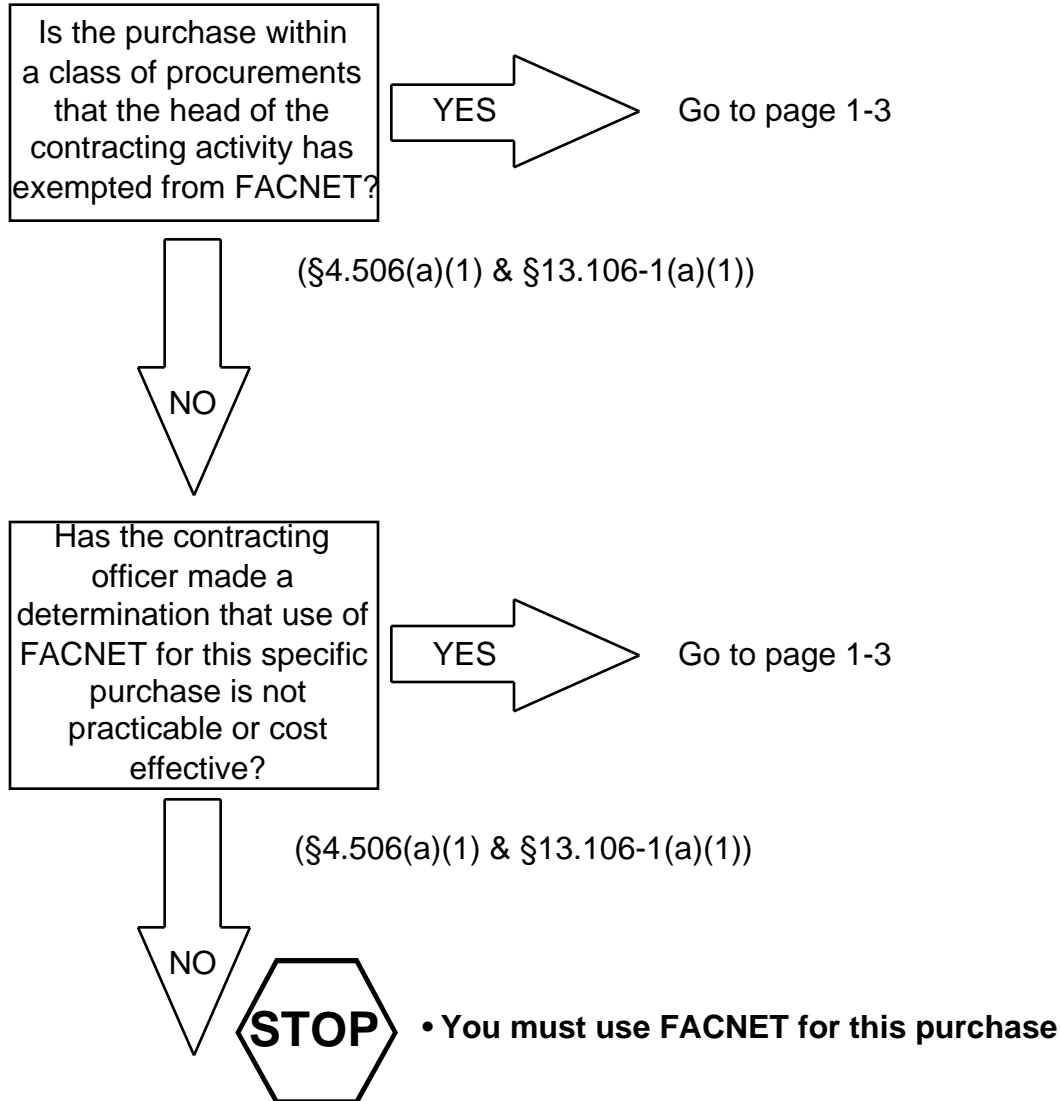


- **FAR Part 14/15 procedures apply** (§13.103(b))
- Exempt from certain provisions and clauses (§13.110 & §13.111)
- Procurement notice (CBD synopsis) required (§5.101(a)(1))
- Reserved for small business (§13.105(a) & §19.502-2(a))

CONTRACT ACTIVITIES WITH INTERIM CERTIFIED FACNET
PURCHASE VALUE OVER \$2,500 BUT NOT EXCEEDING \$100,000



- **Simplified Acquisition Procedures apply** (§13.103(a))
- Required Sources of Supply apply (§13.103(a))
- “Full & open” competition does not apply (§6.001)
- Exempt from certain provisions and clauses (§13.110 & §13.111)
- Procurement notice not required (§5.202(a)(13))
- Must consider ALL timely quotes received from eligible vendors (§5.101(a)(2)(ii))
- Oral solicitations may not be used (§13.106-1(a)(2))
- Governmentwide commercial purchase card may be used for payment
- Reserved for small business (§13.105(a) & §19.502-2(a))
